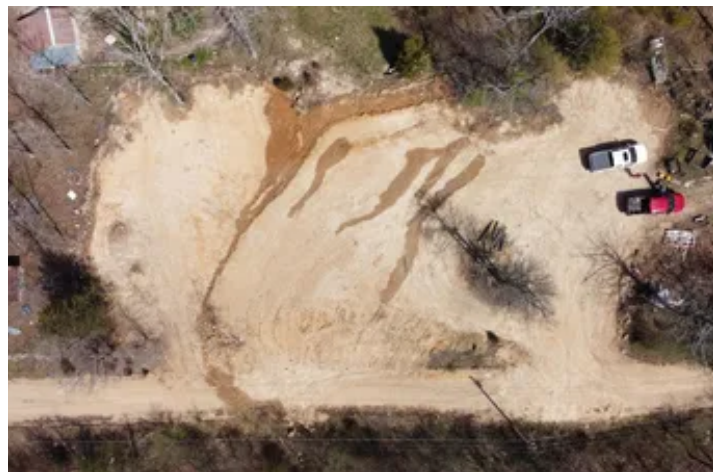

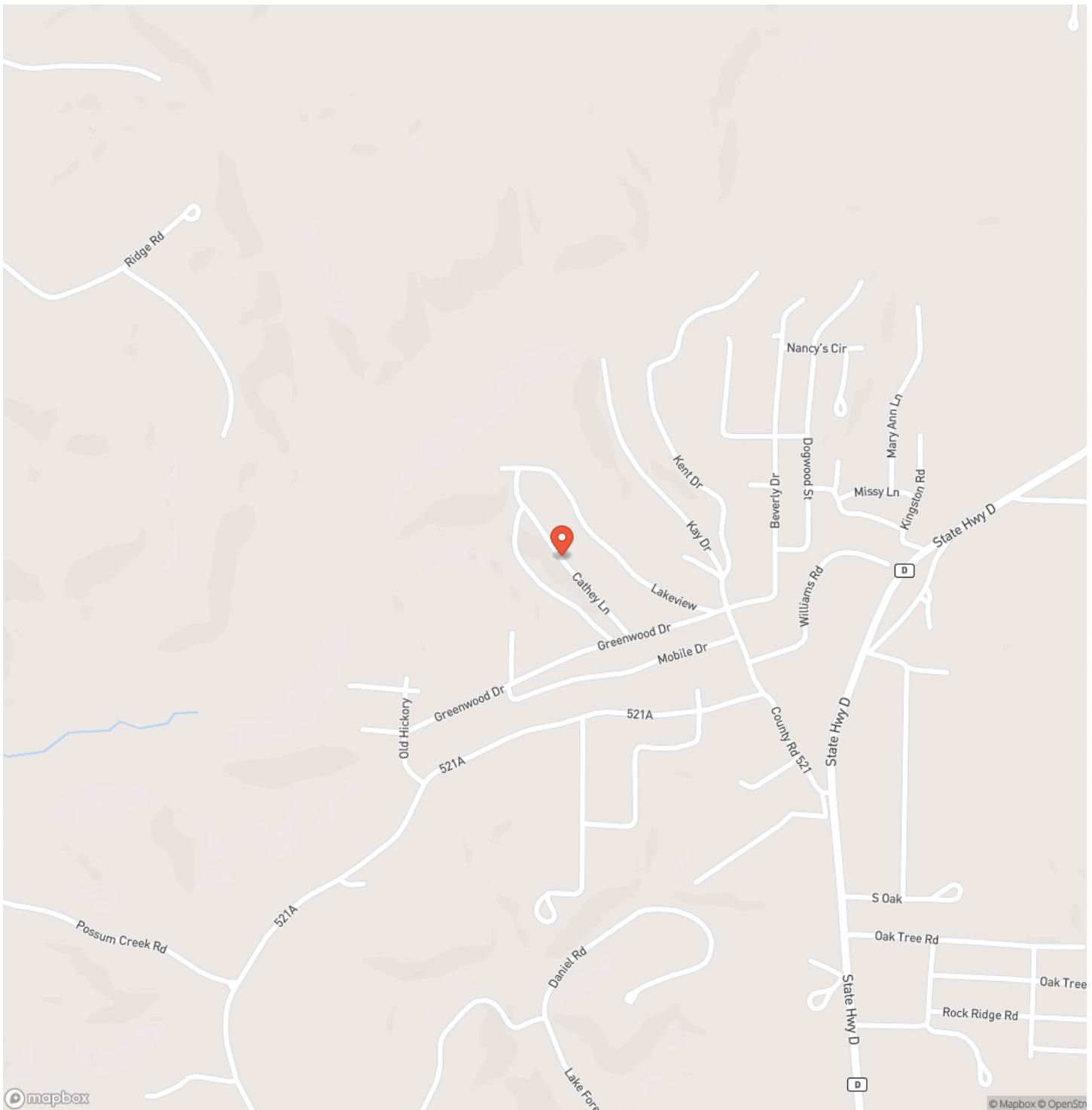

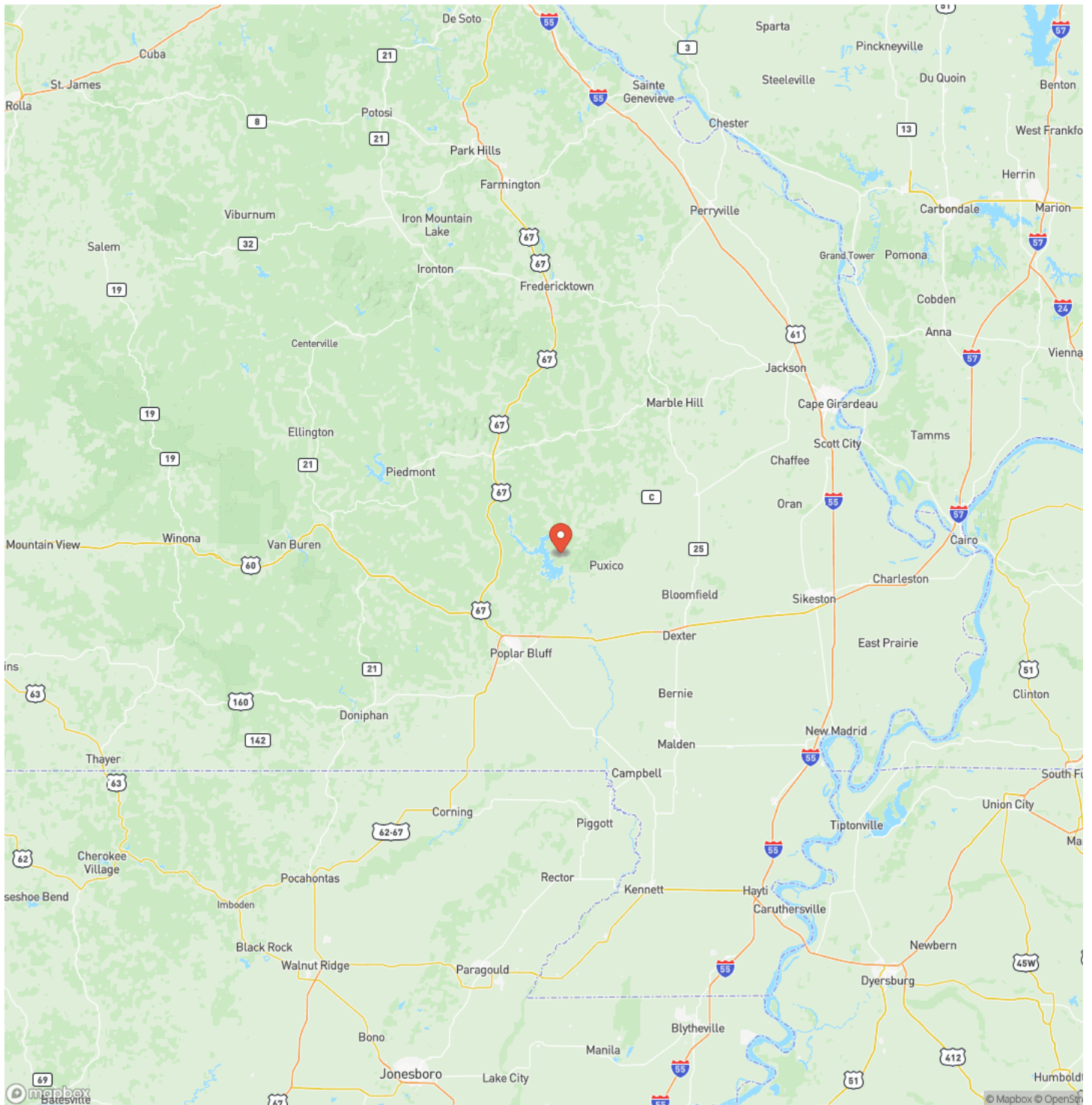

Locator Map

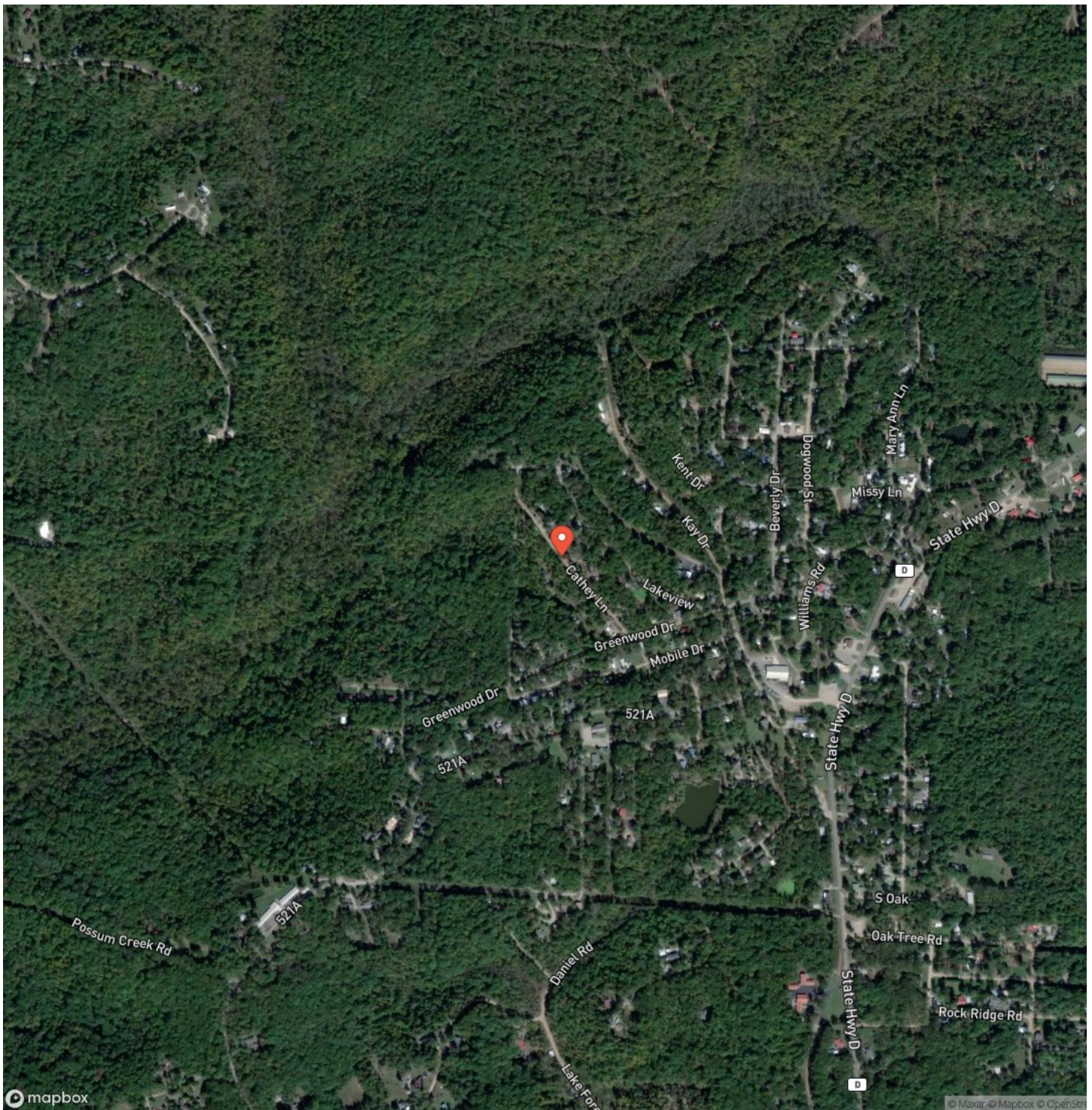
