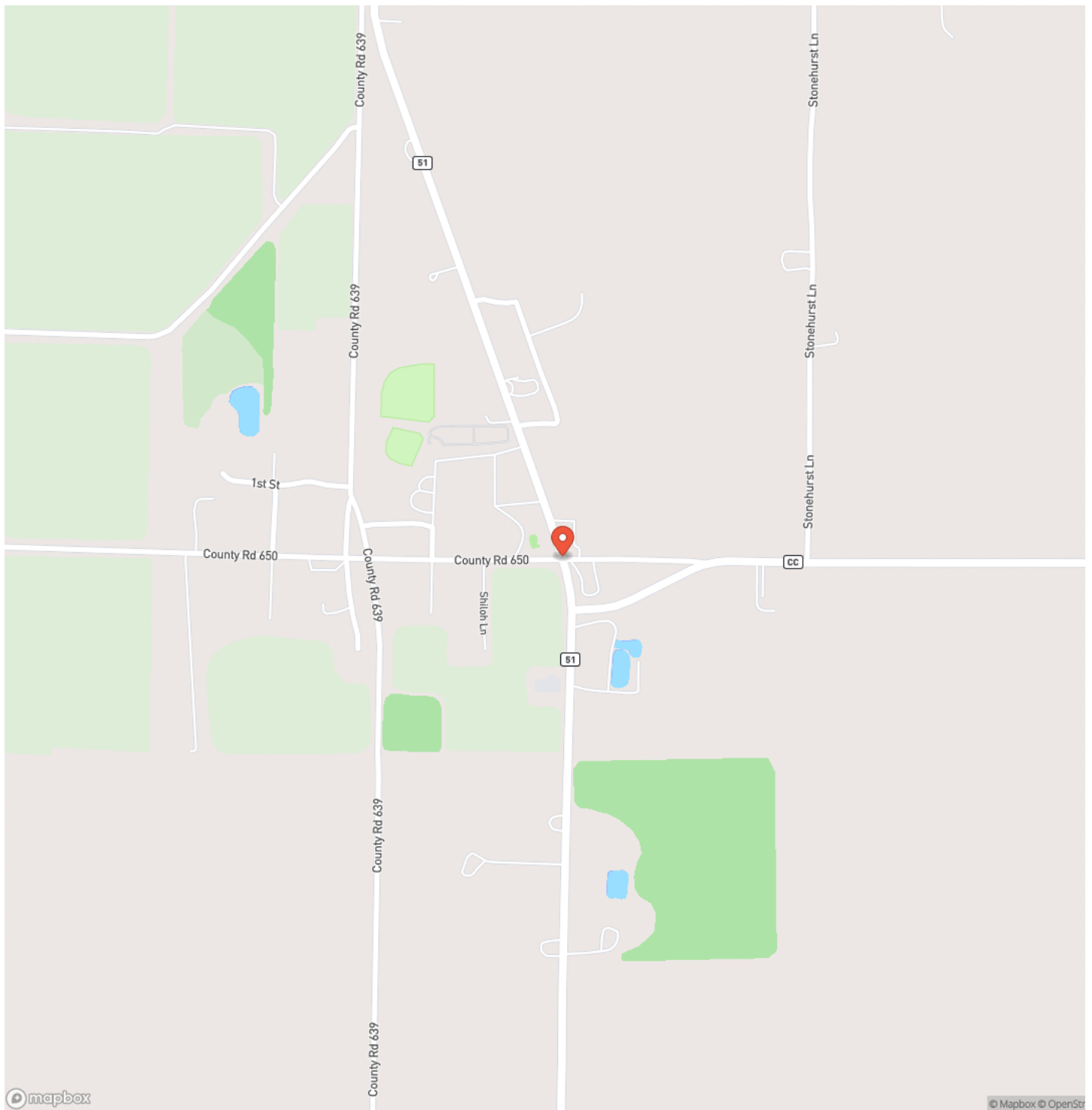

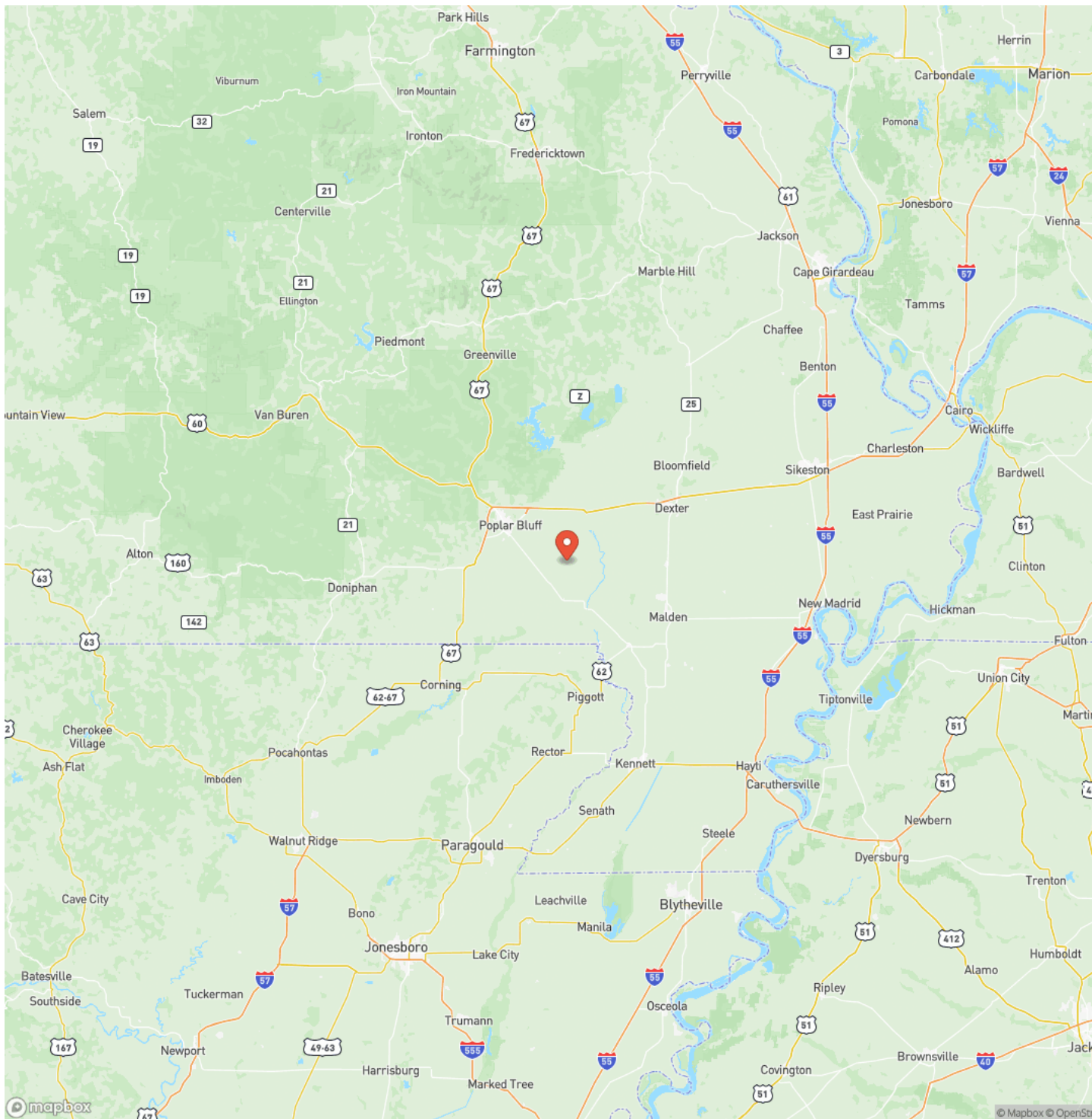


Locator Map

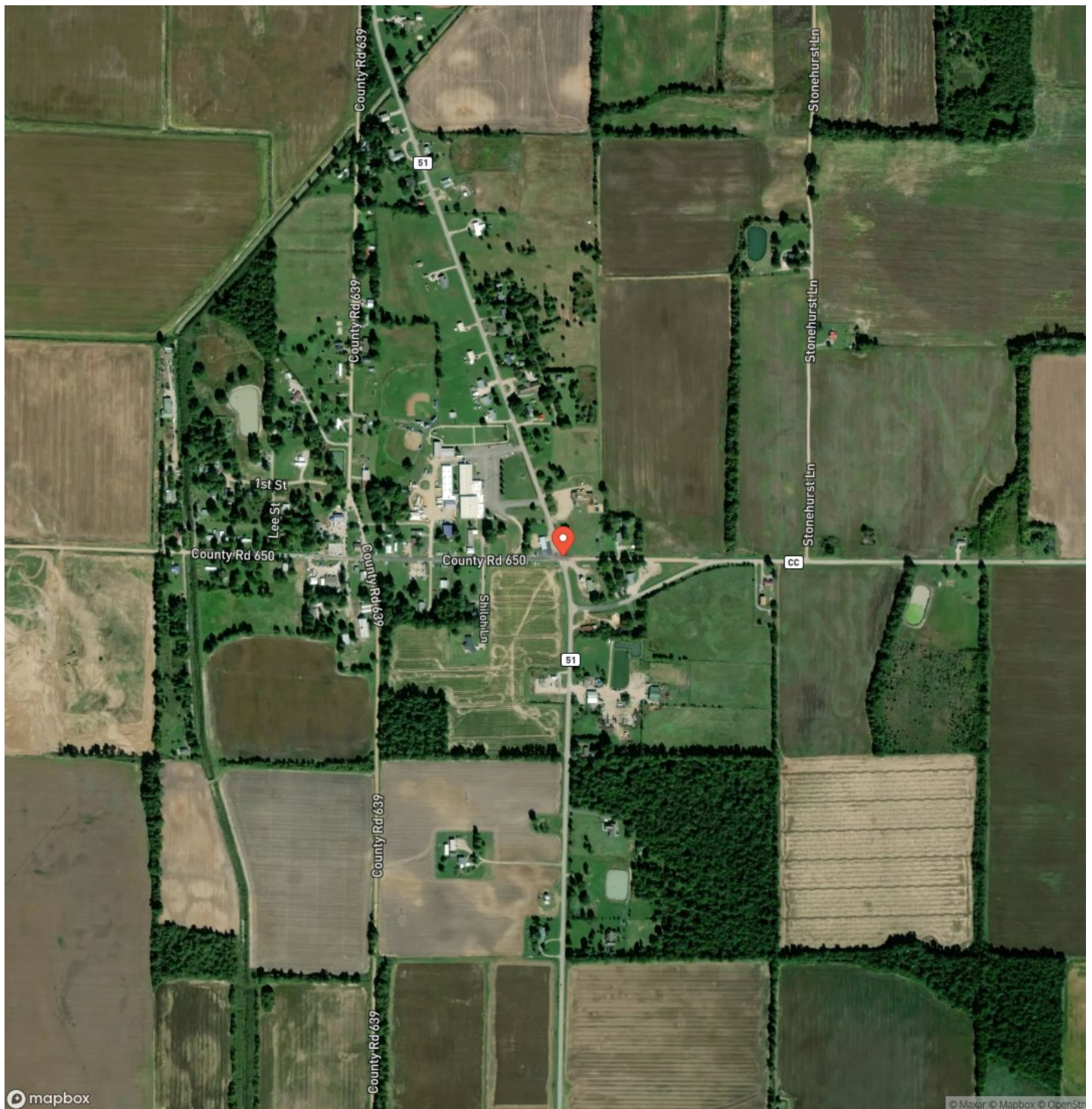
