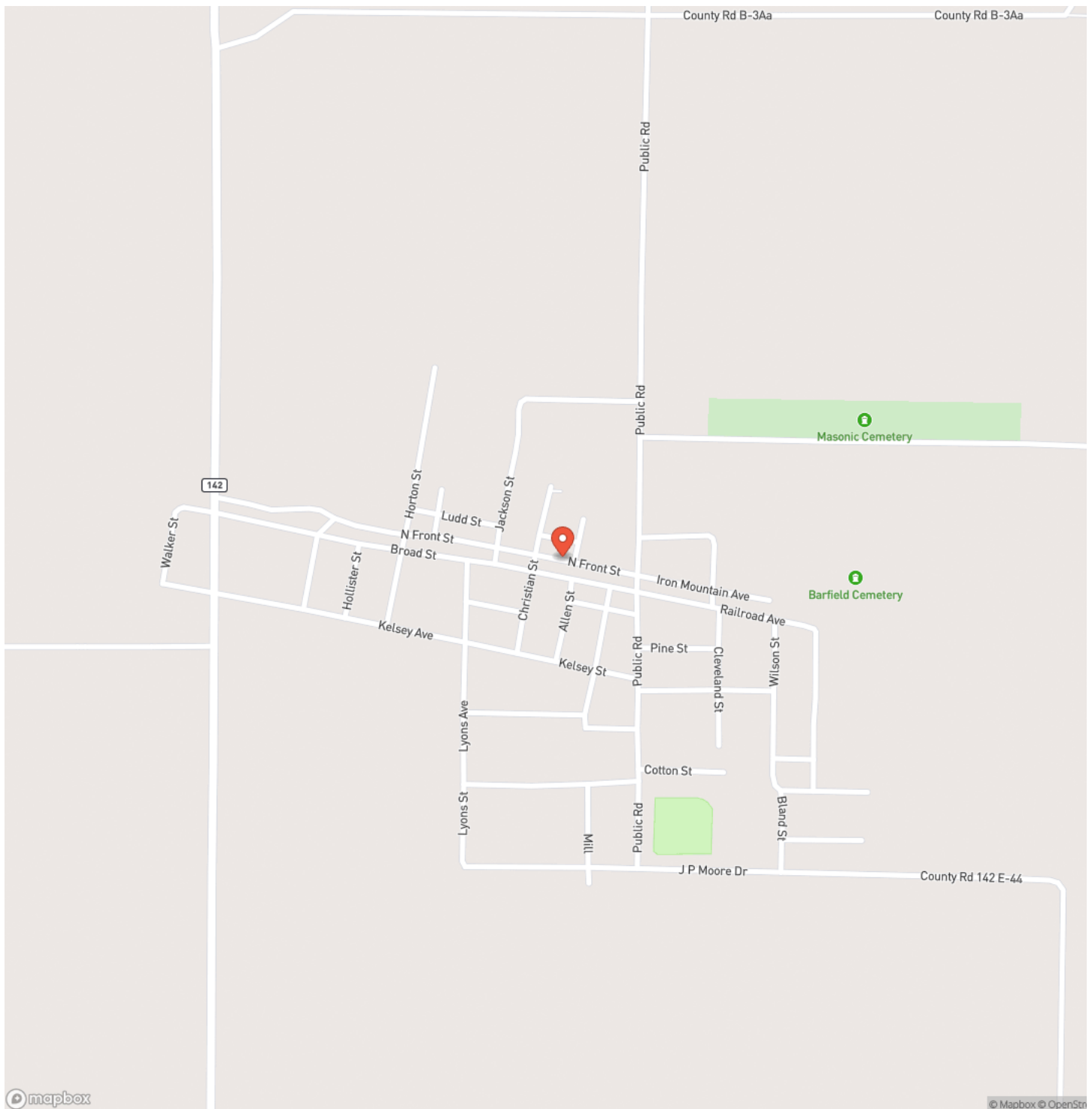

Locator Map

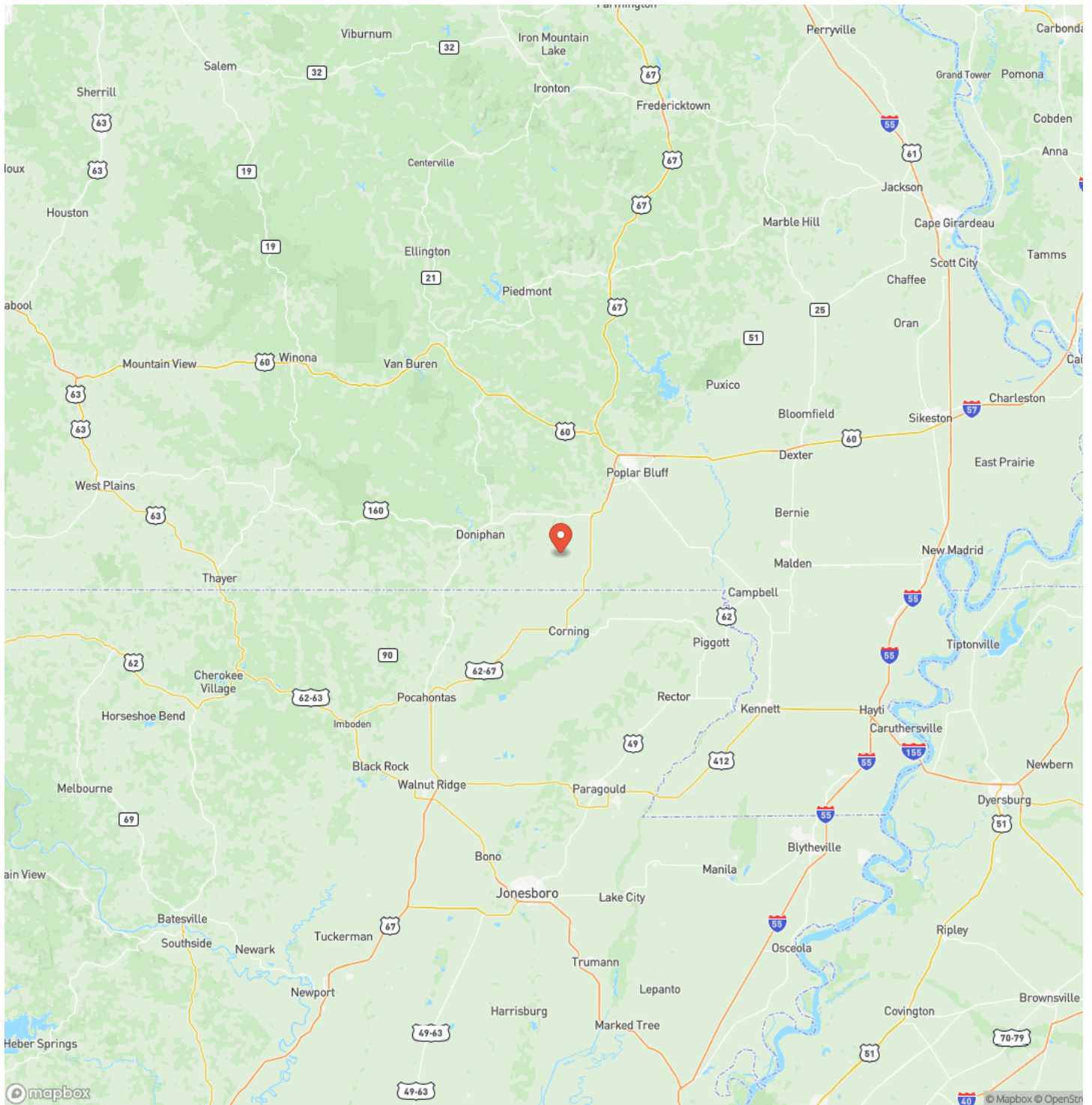

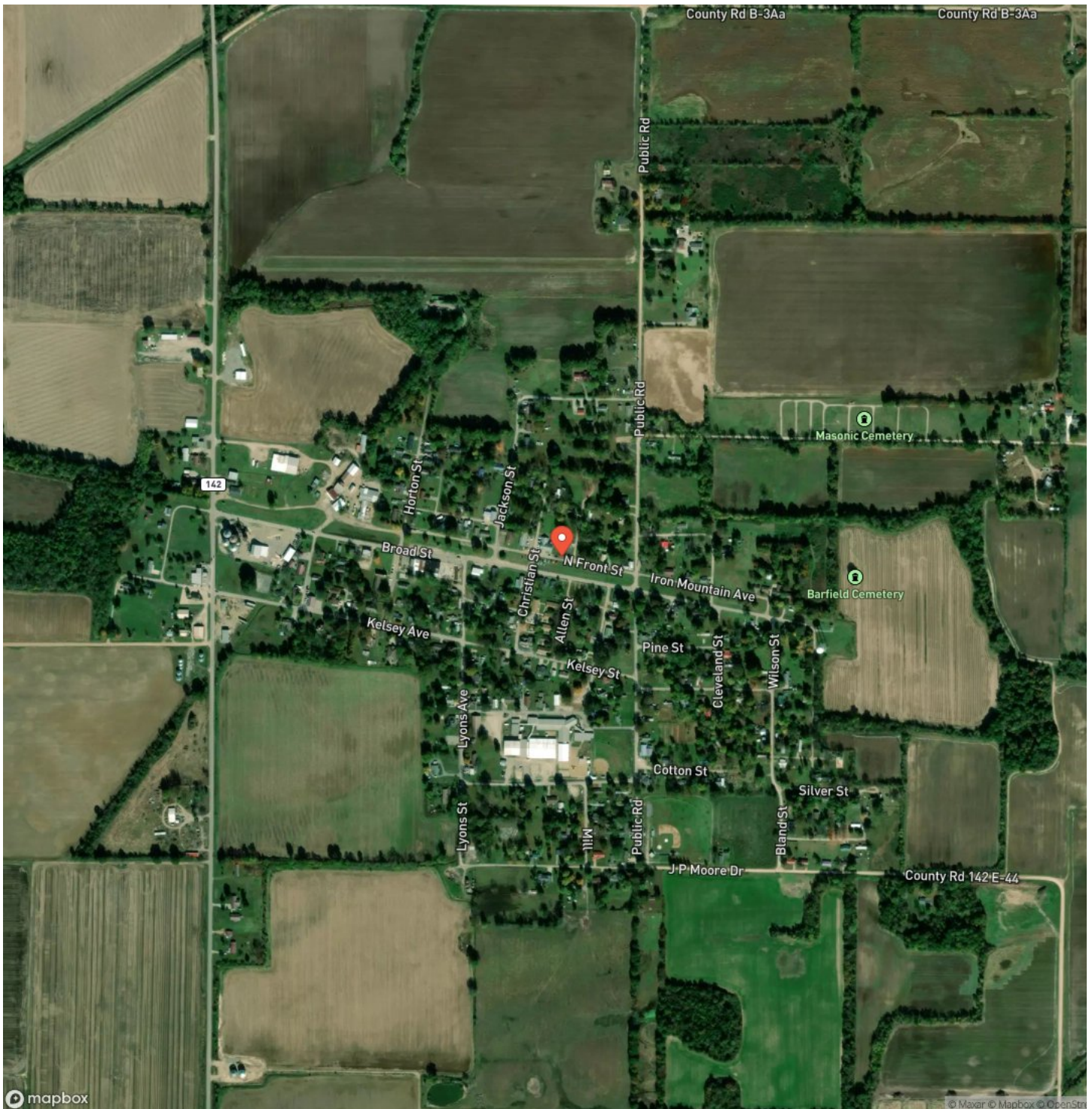
