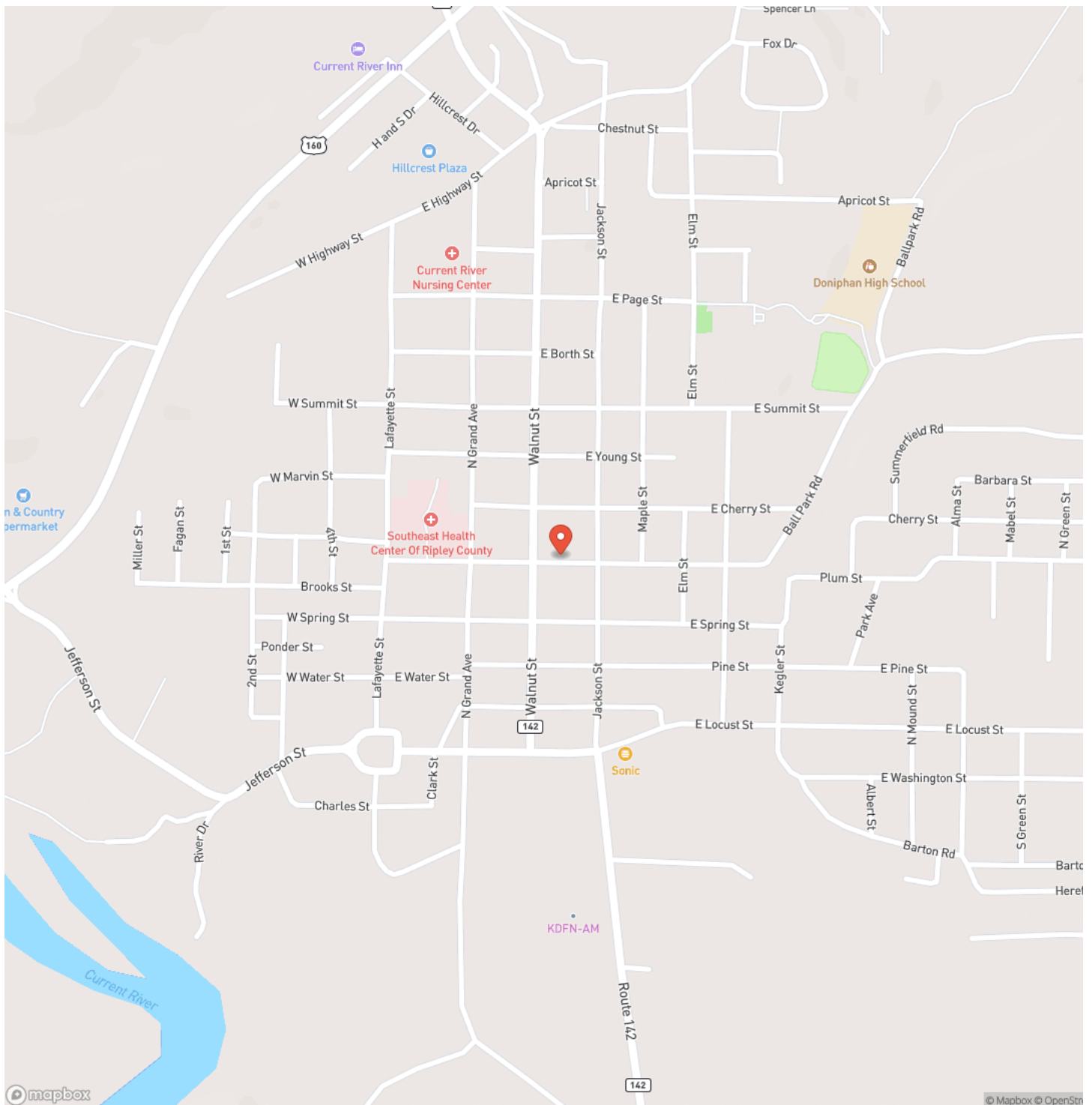

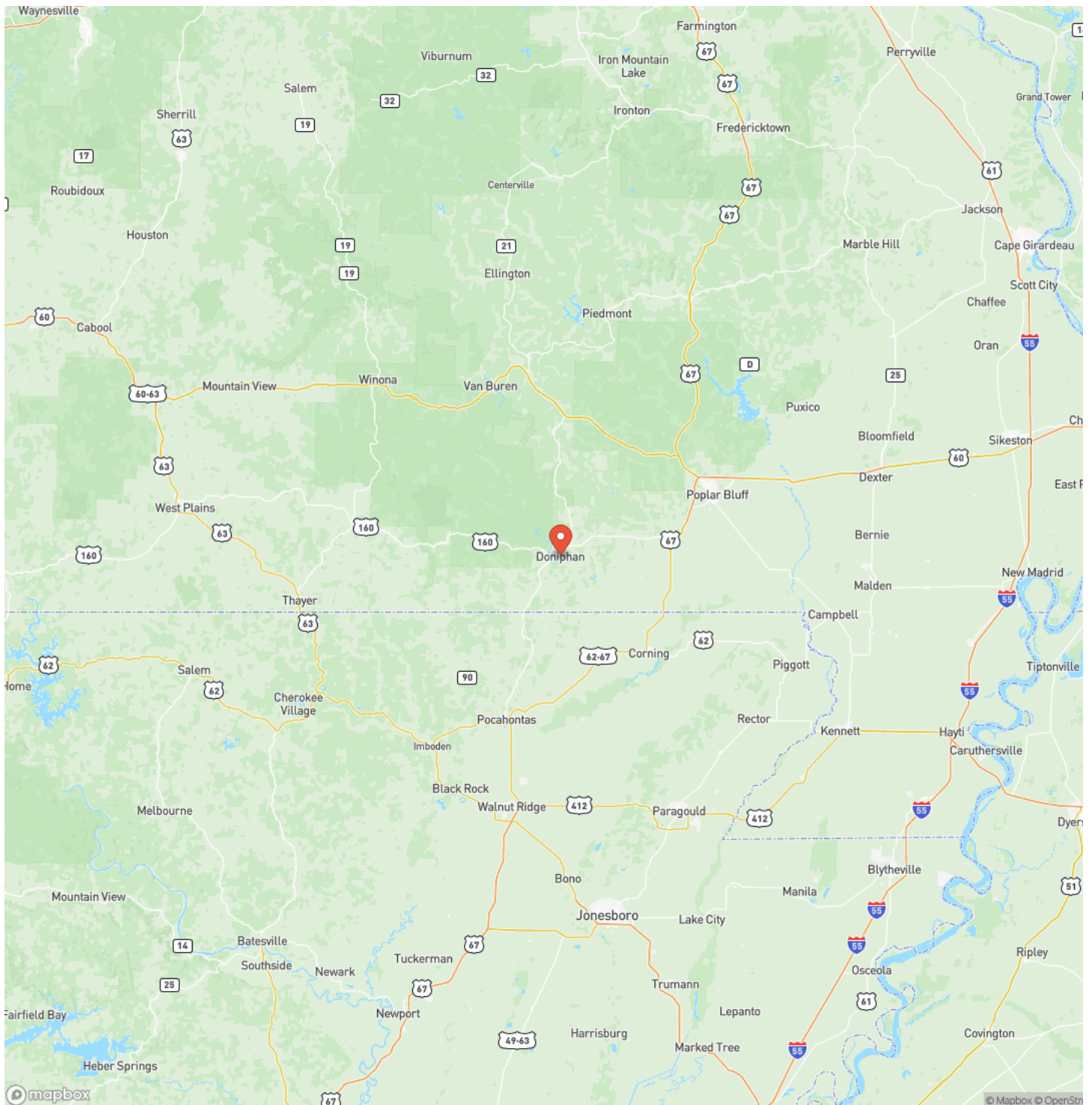
Locator Map

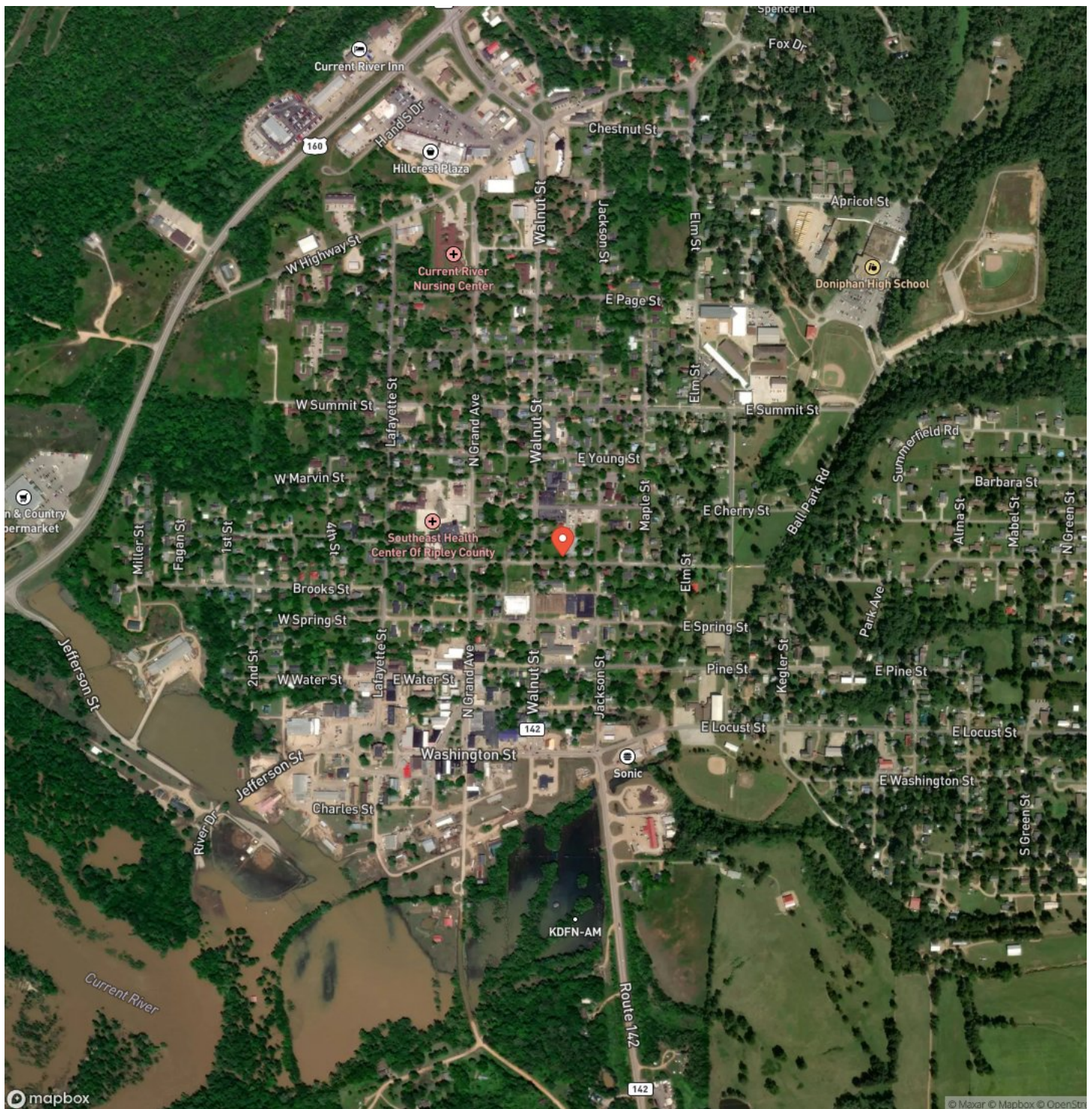
Locator Map
