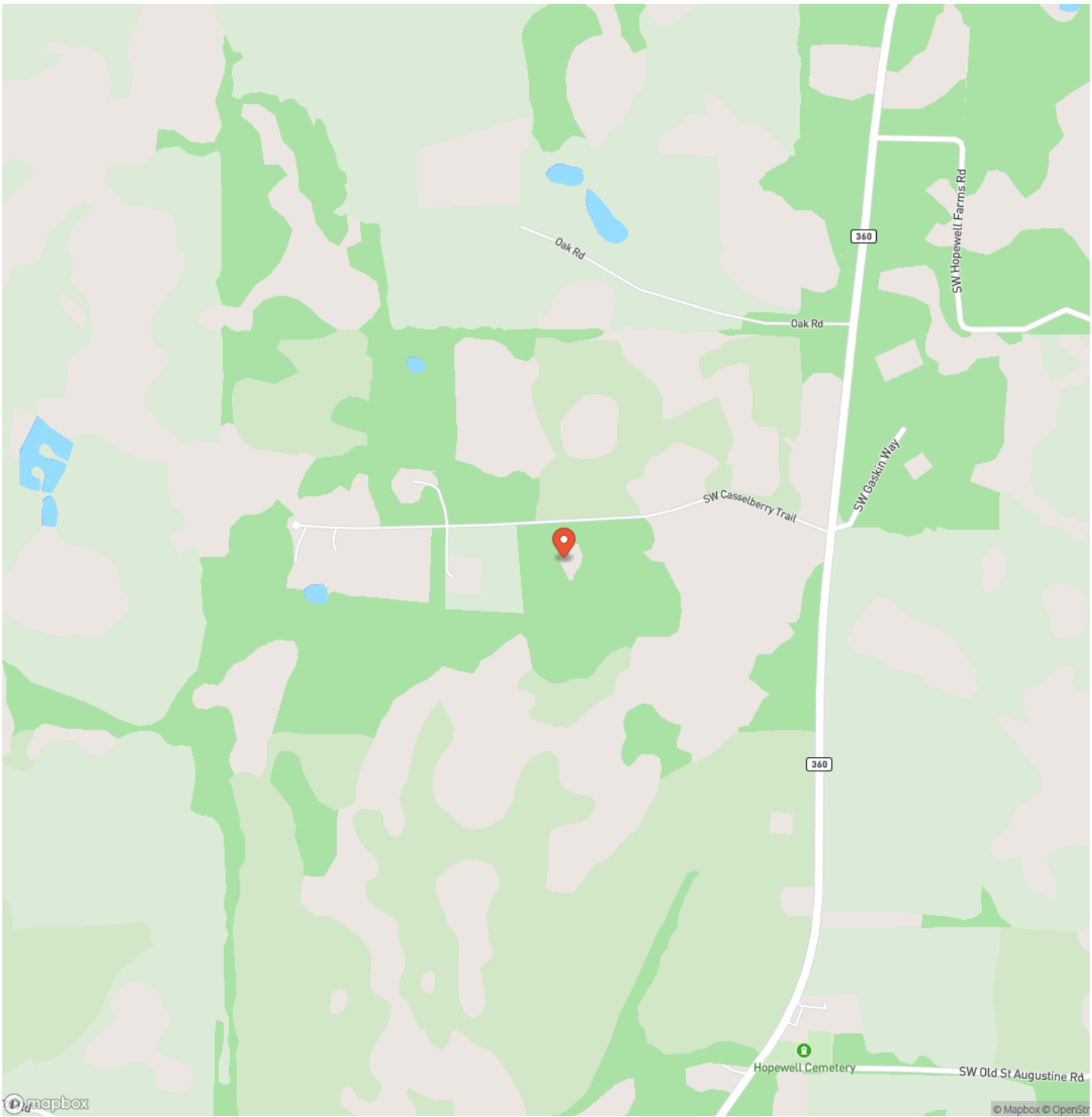

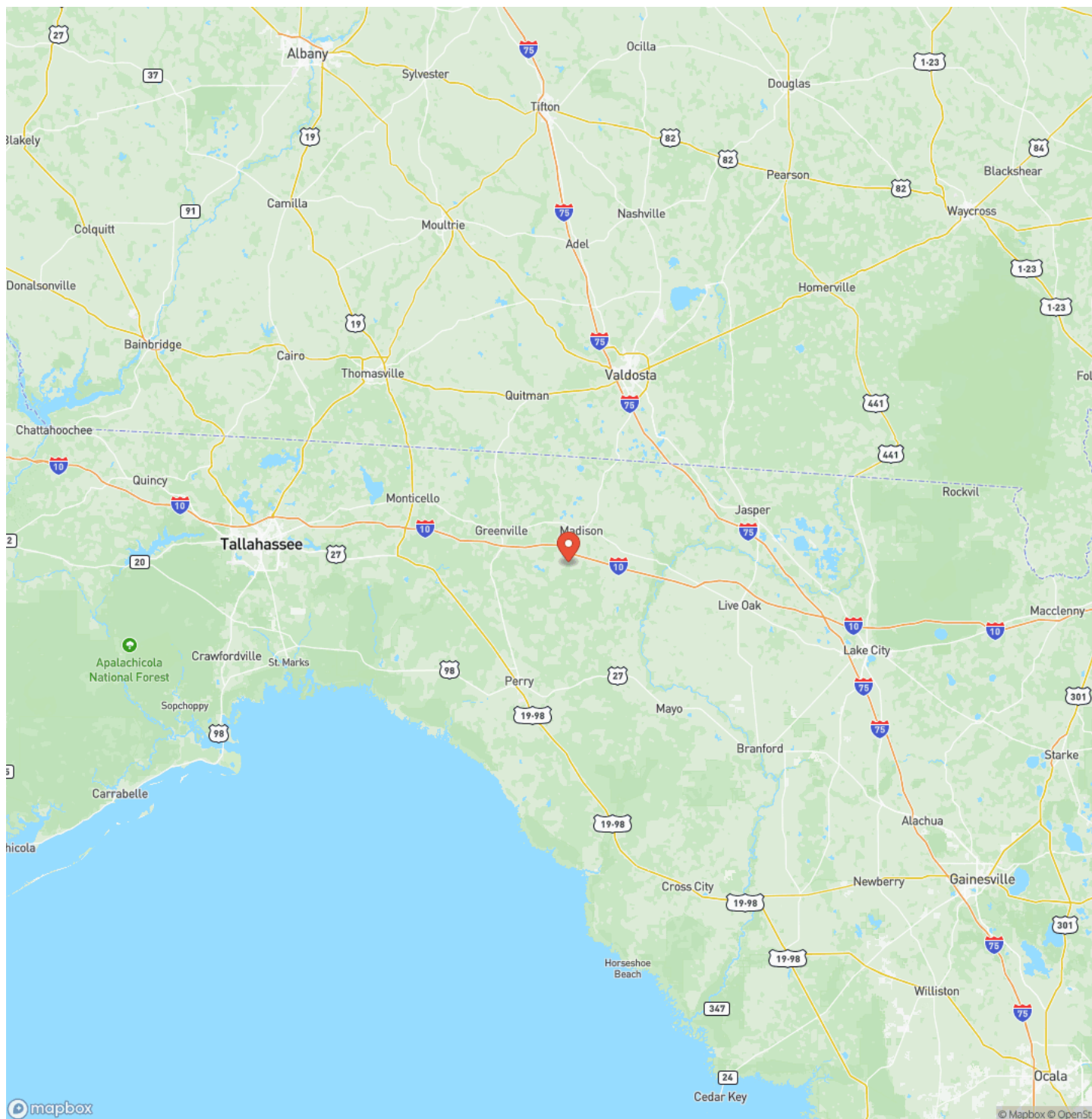


Locator Map
