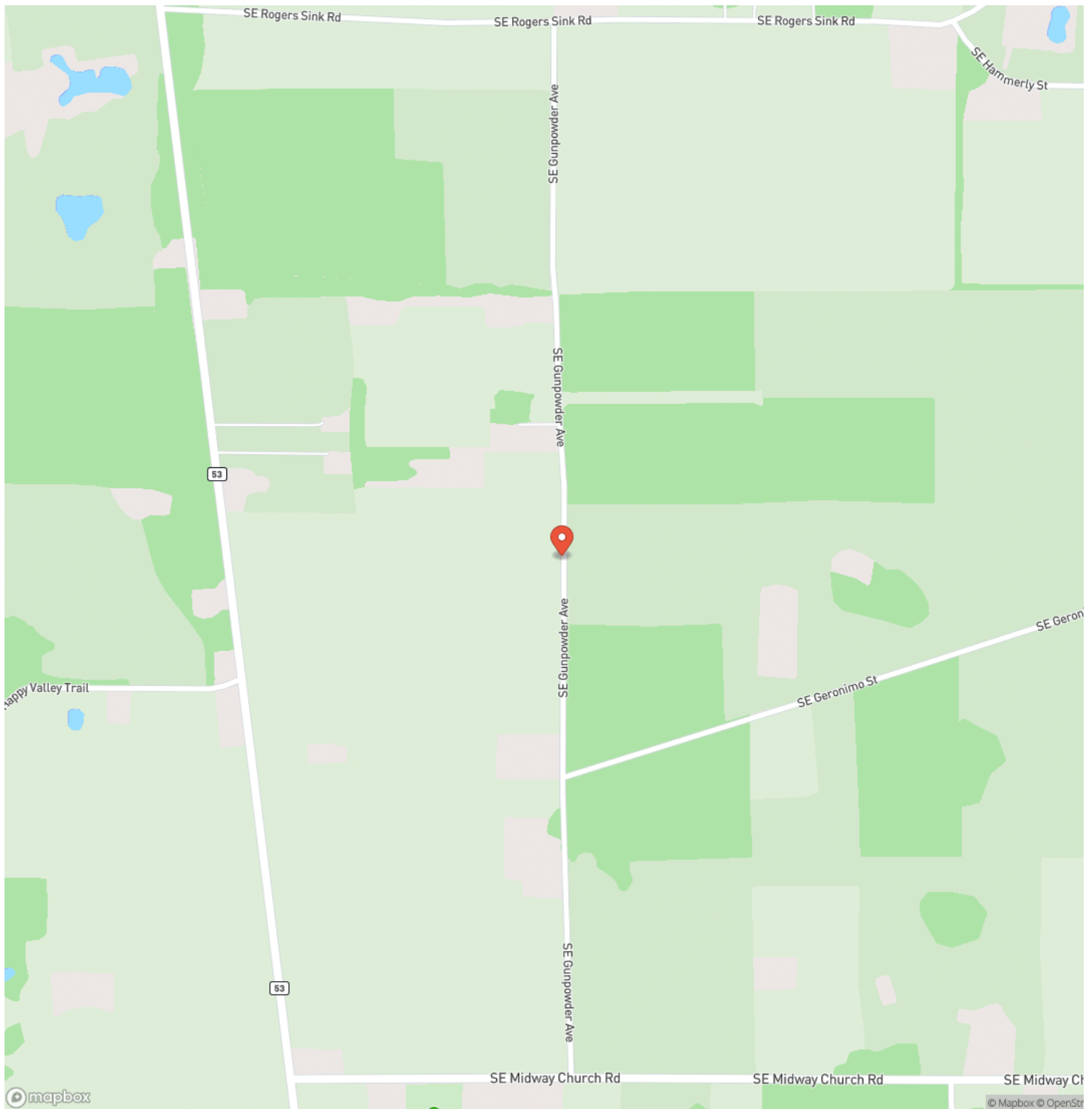

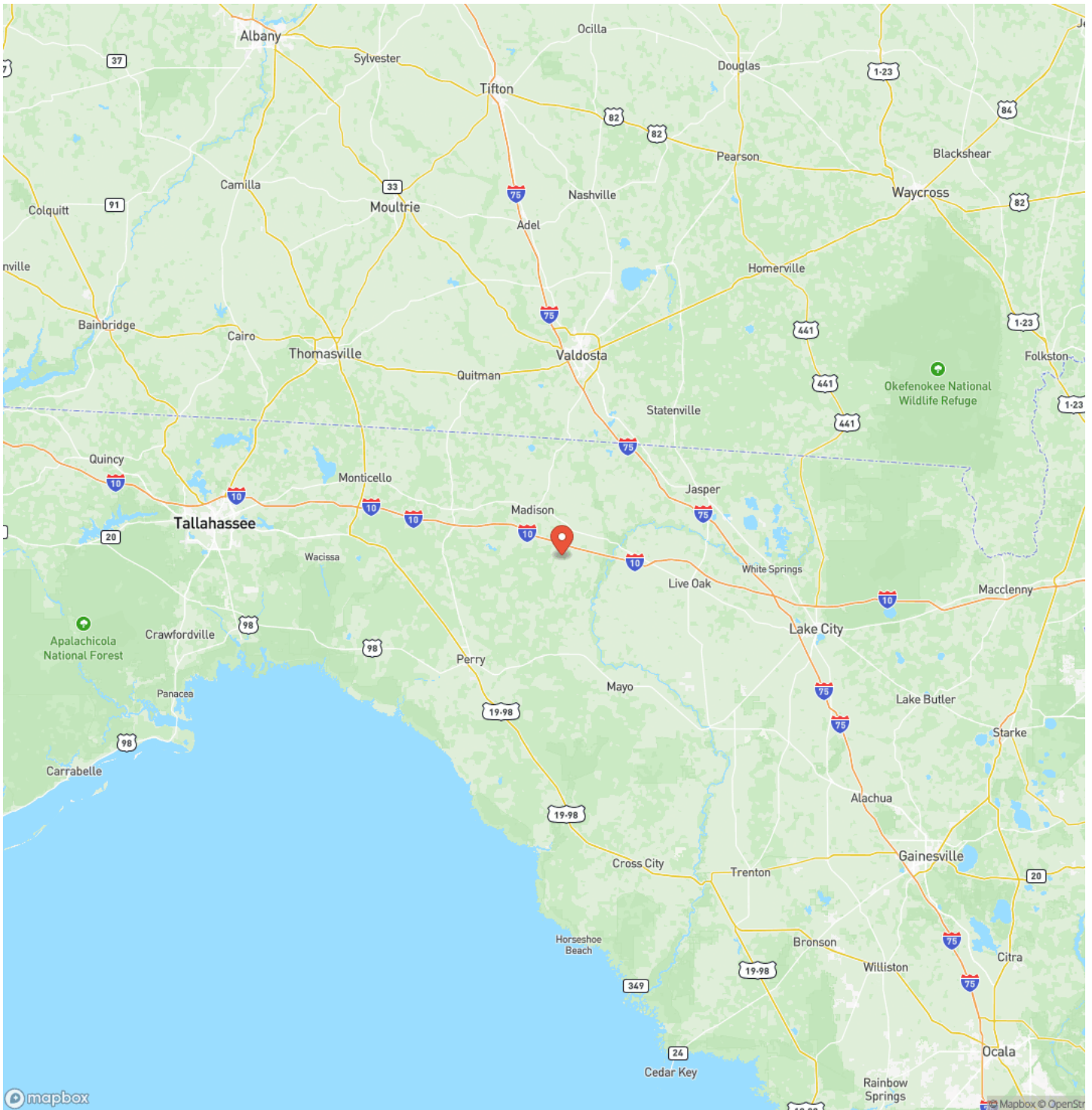

Locator Map

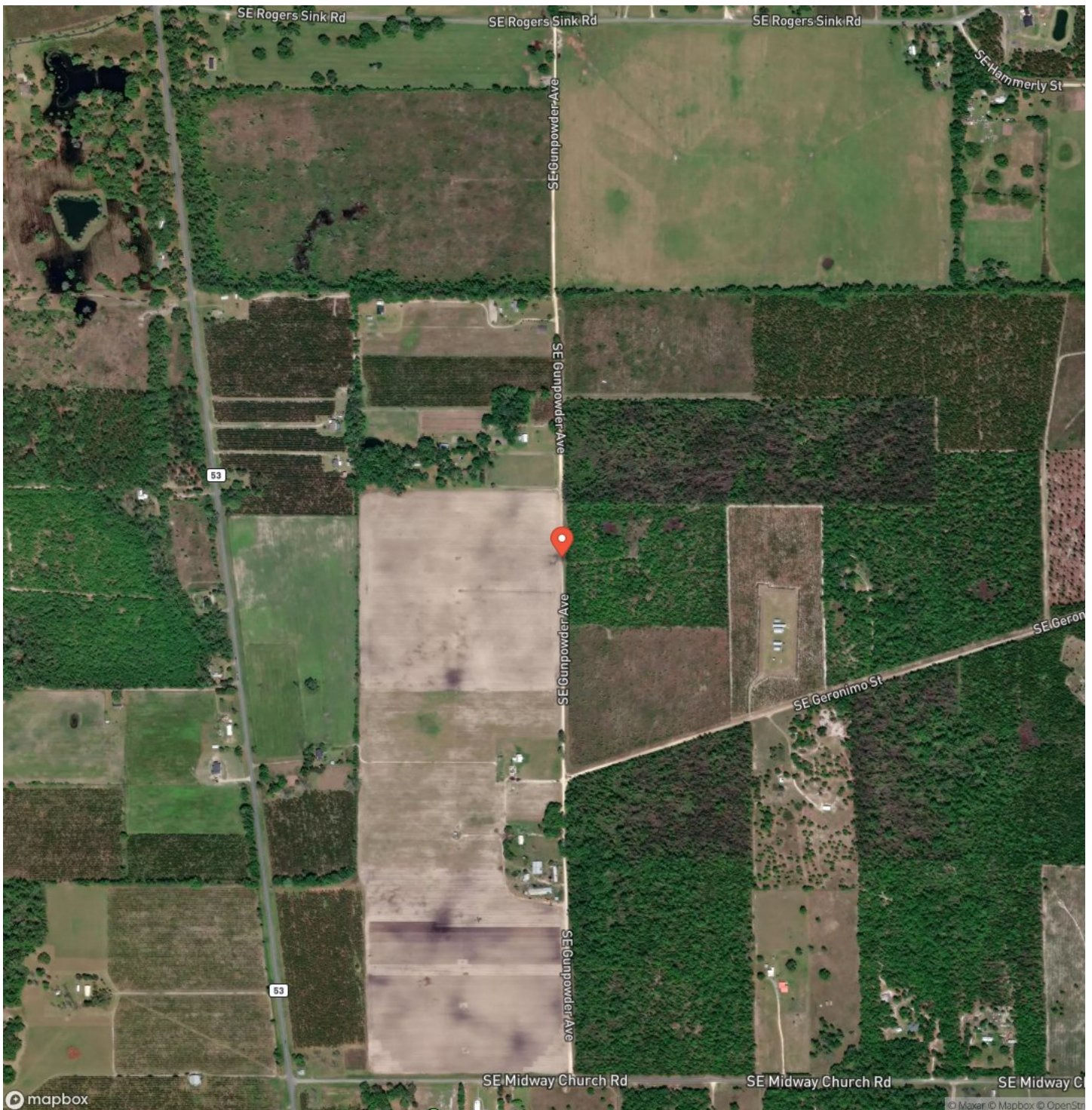


Locator Map
