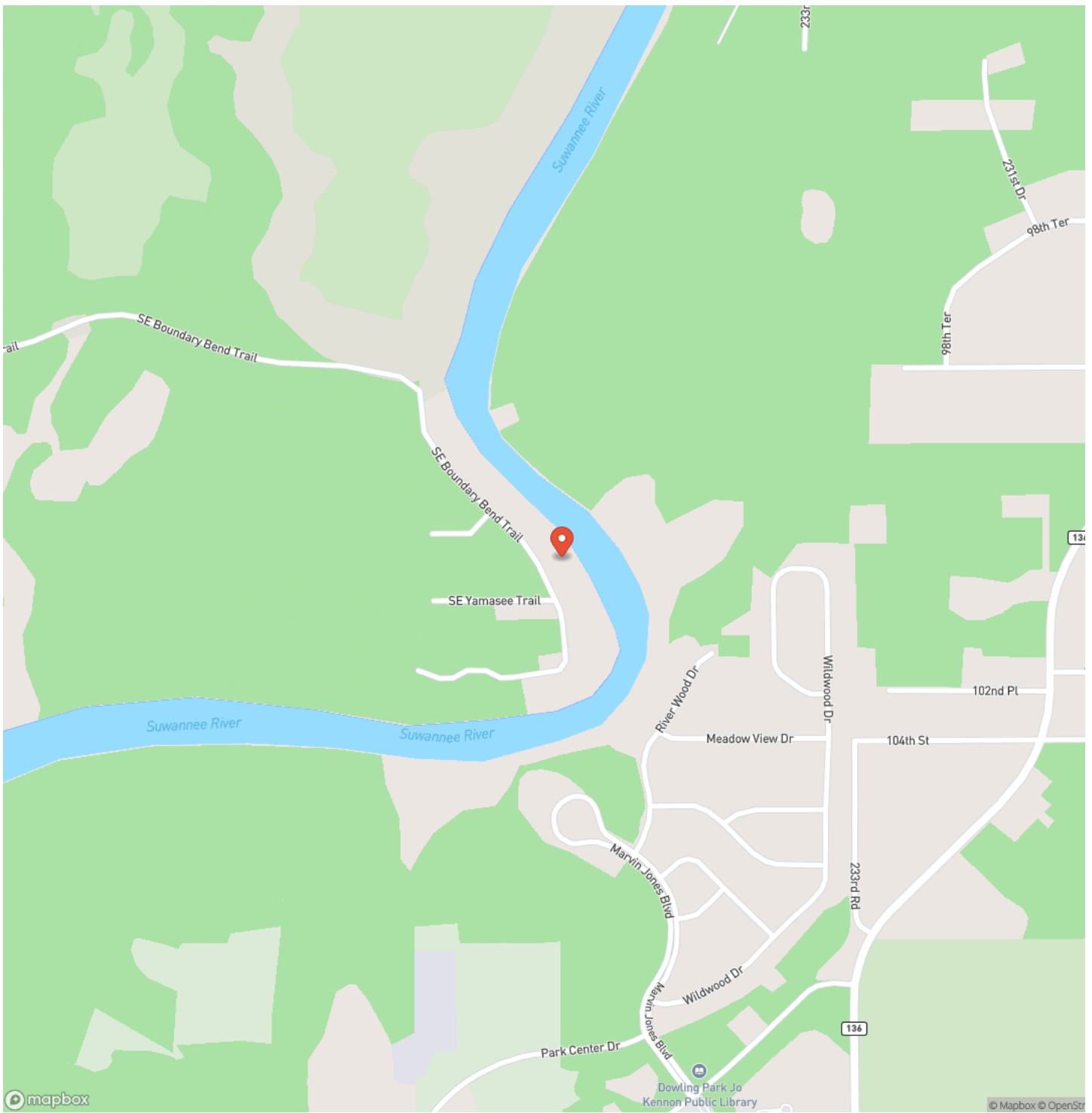

Whether you're looking for a weekend escape or a low-maintenance river retreat, this property offers an exceptional opportunity to own a slice of Suwannee River paradise.

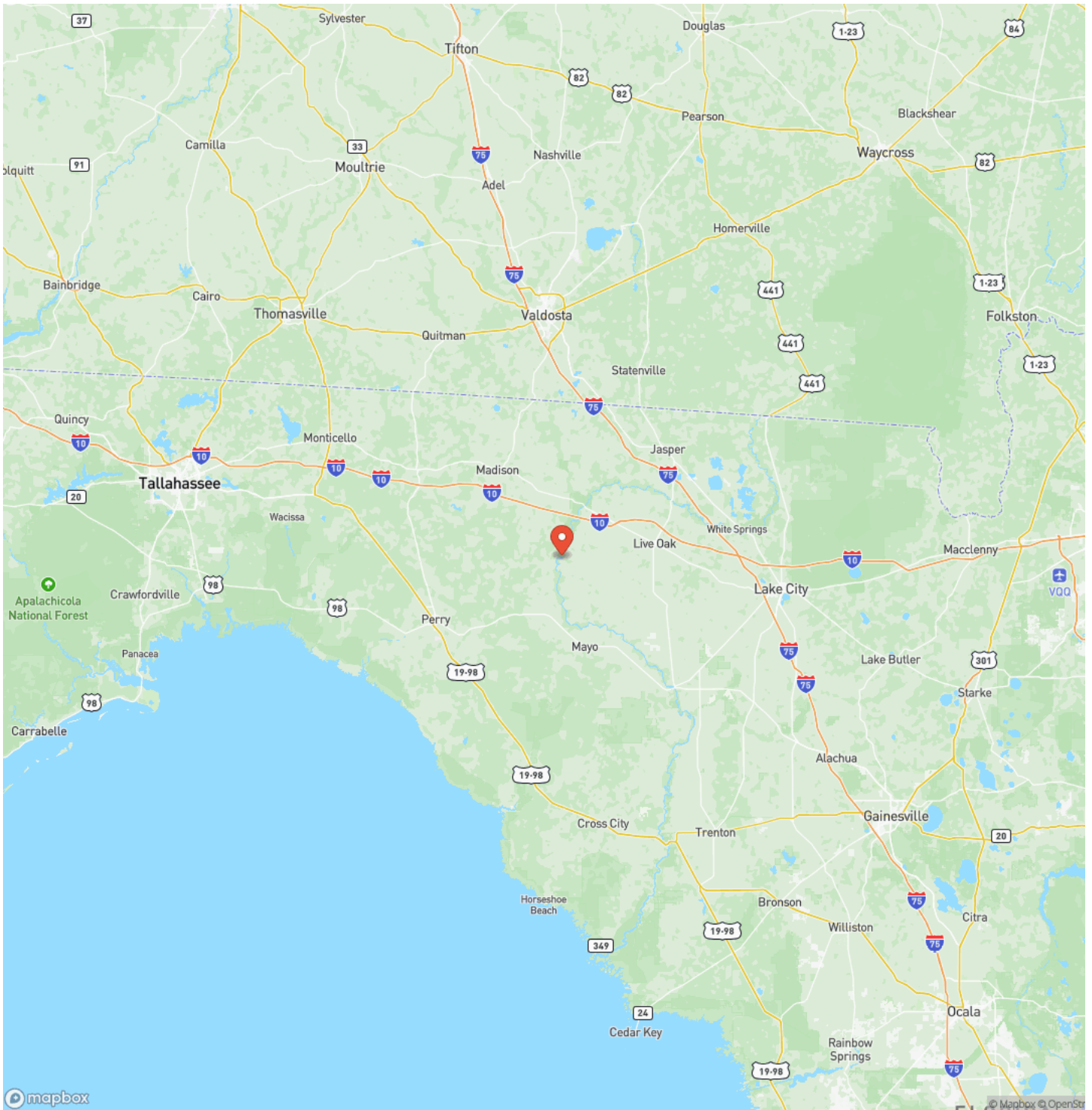
