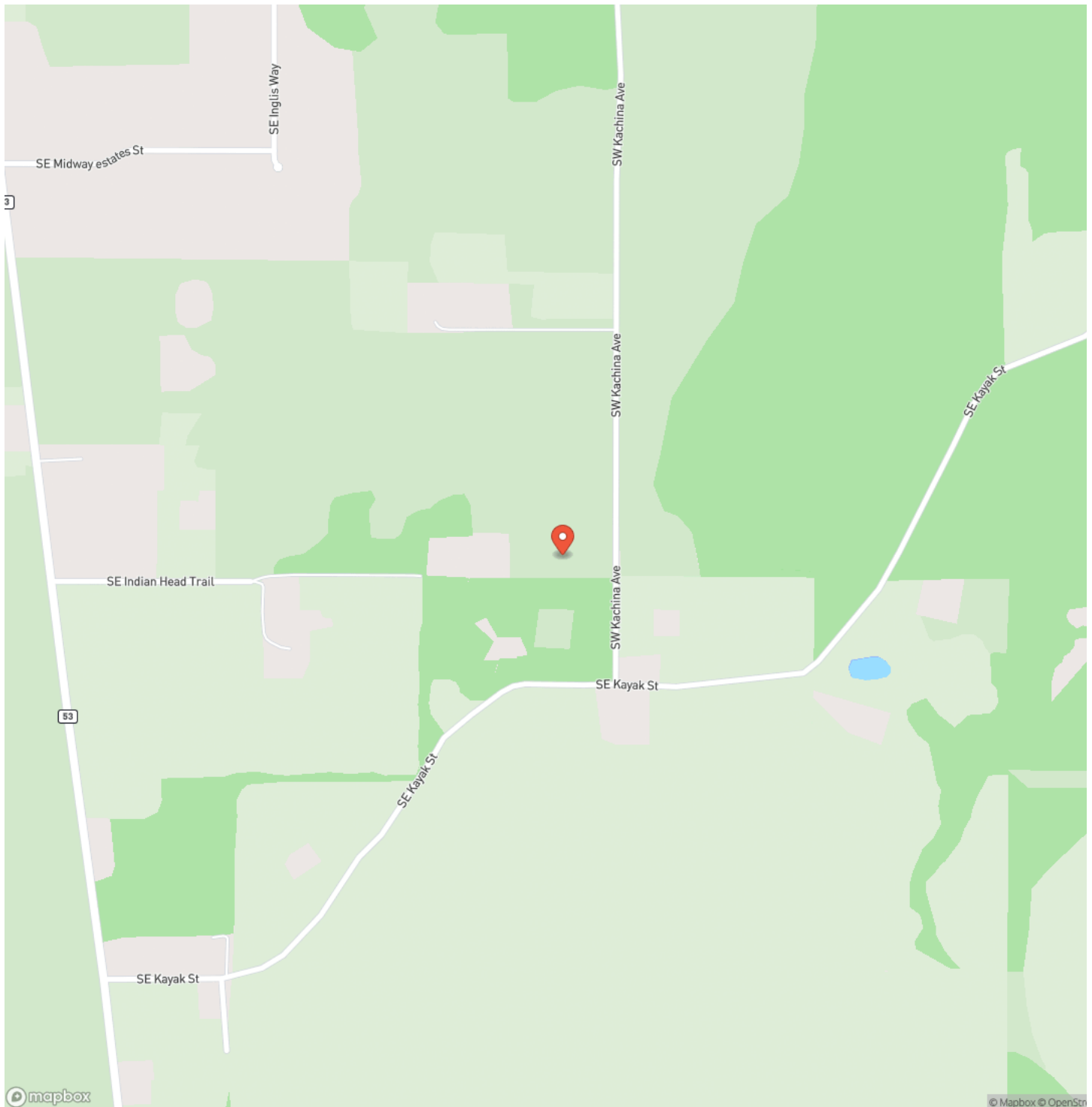

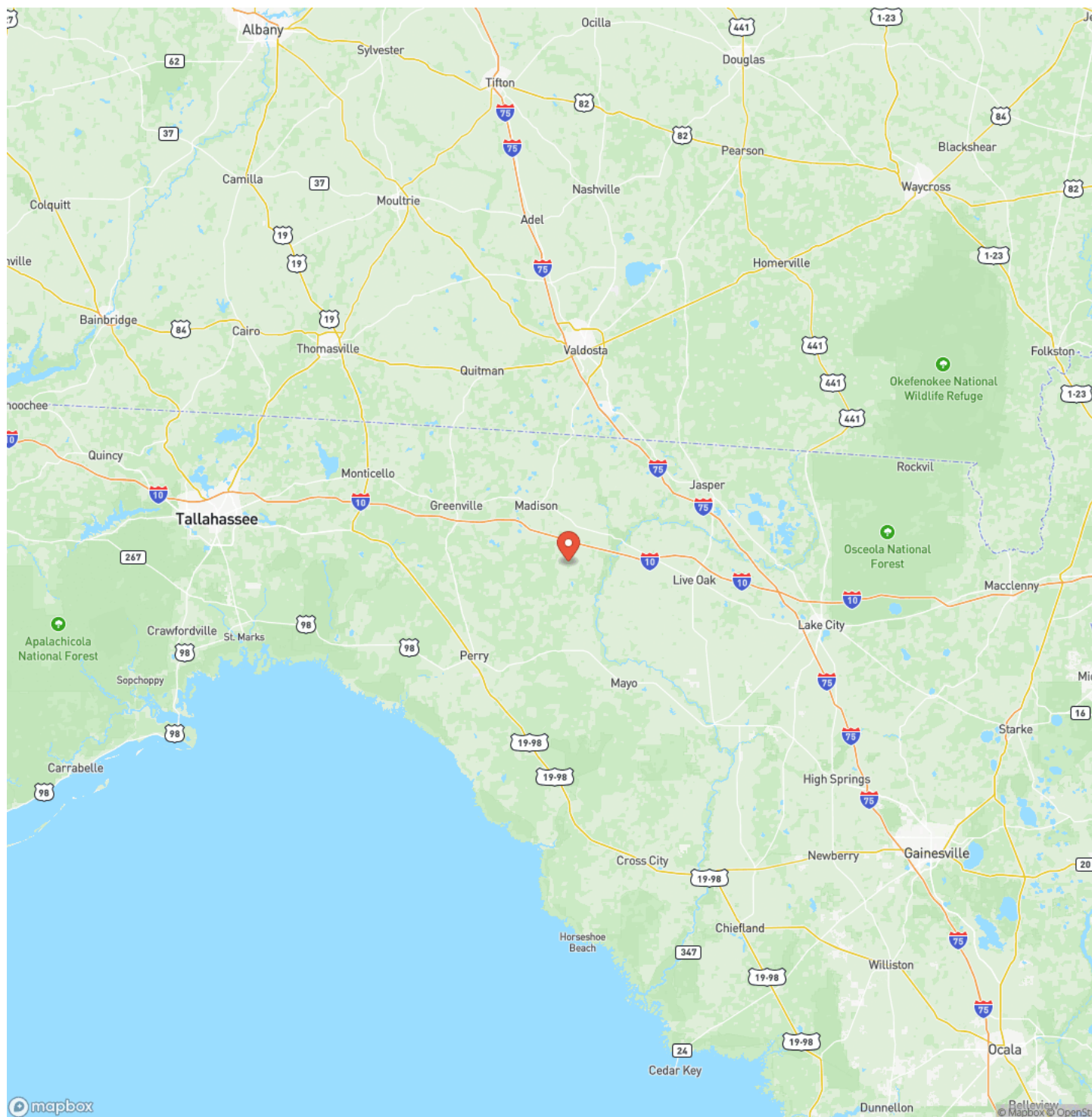

Locator Map

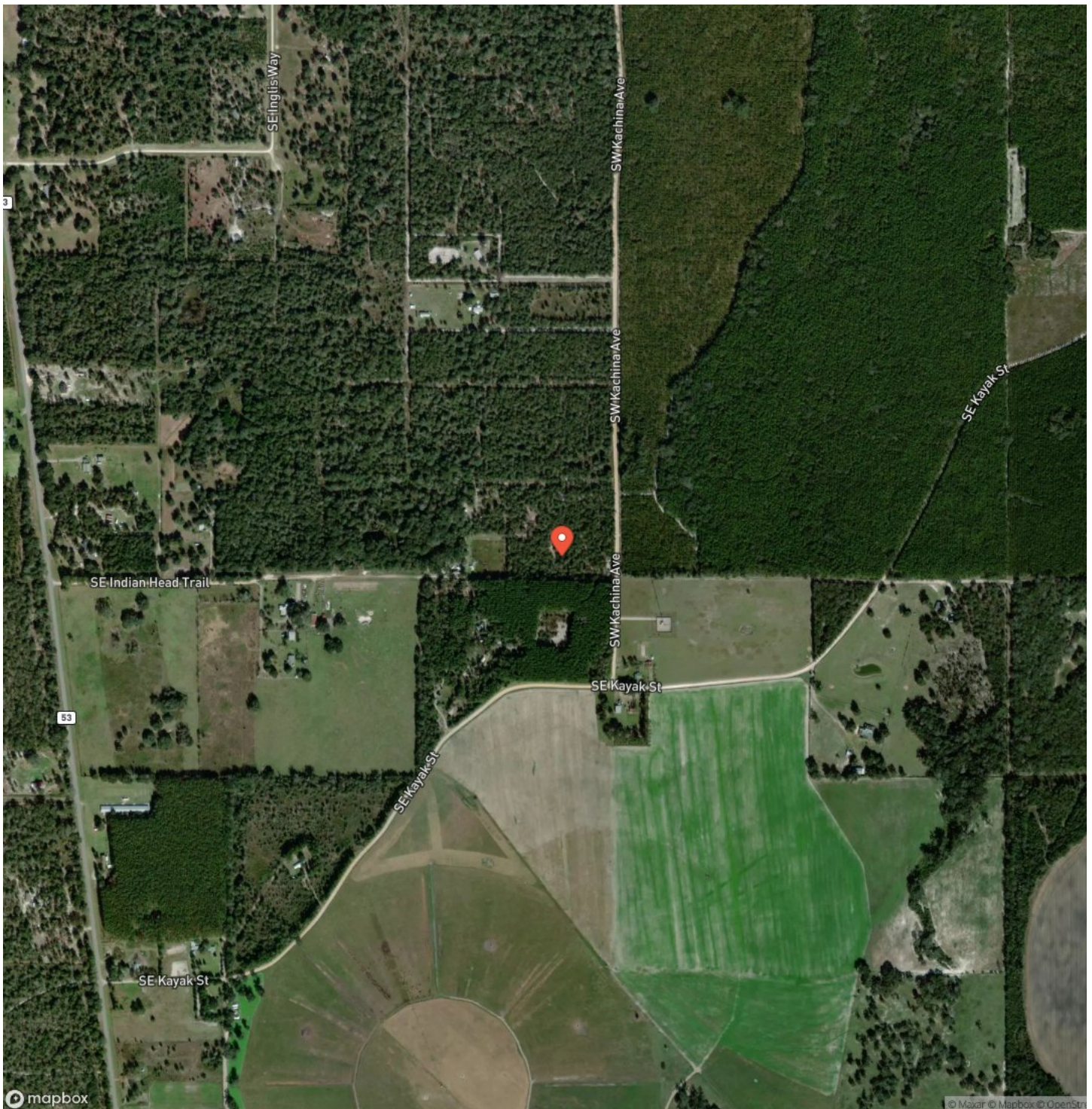
