

Brent Tract No. 3-A:

That part of the Fractional Northeast Quarter(Frl. NE 1/4) of Section Four(4), Township One North(T1N), Range Five East(R5E) lying West and North of the Mississippi River Levee, containing 92.0 acres, more or less.

Brent Tract No. 4:
