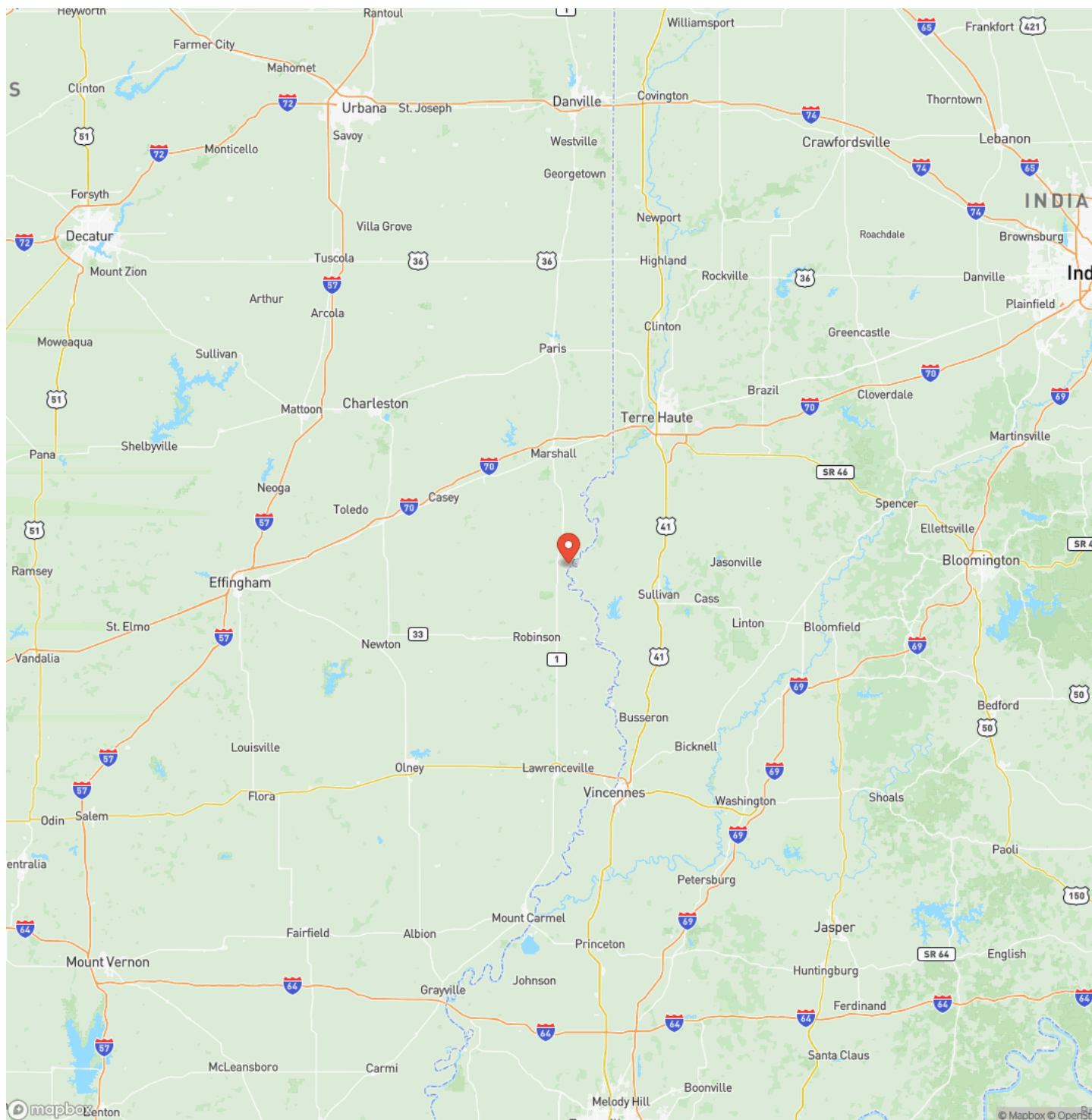


Locator Map
