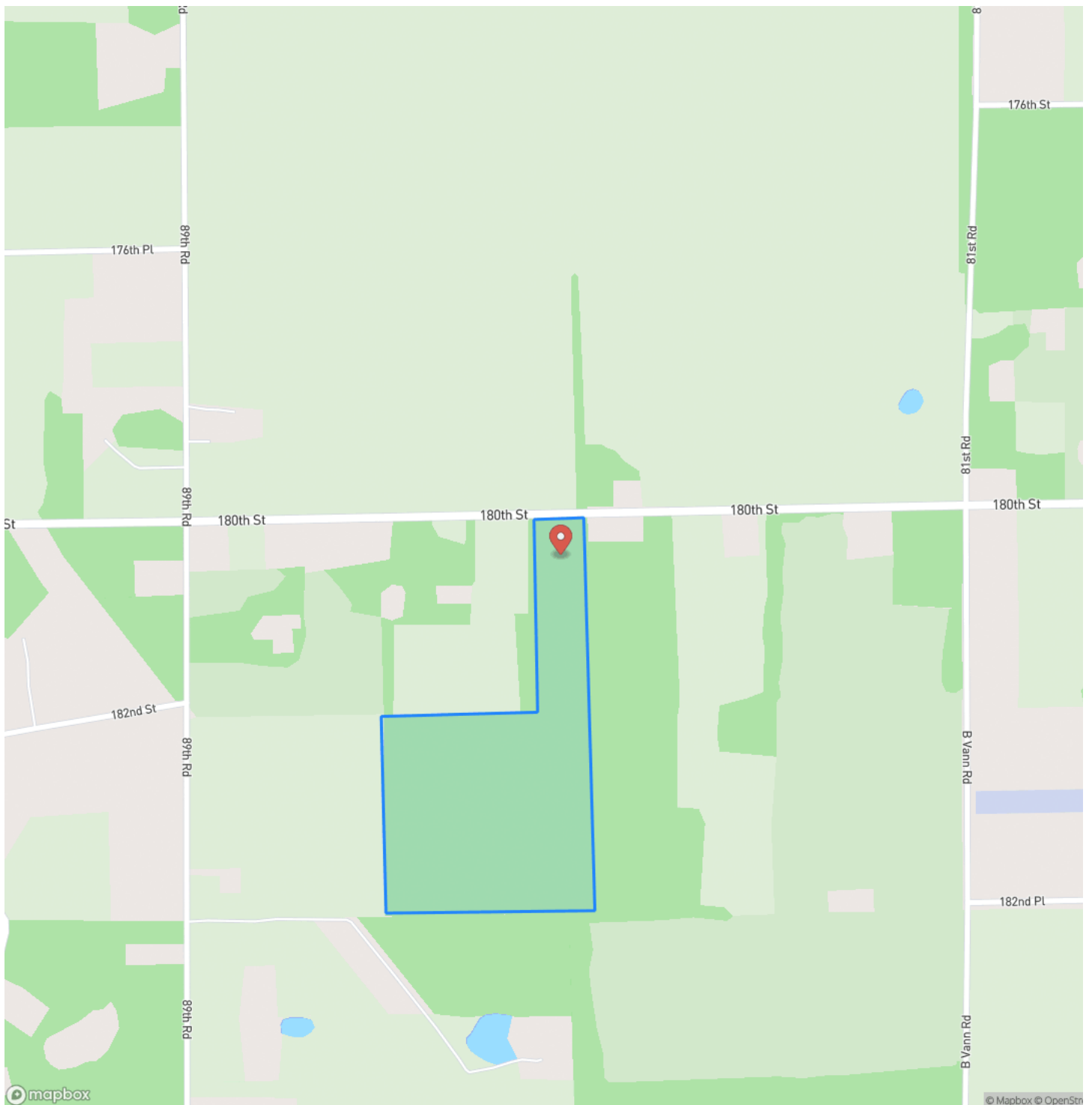

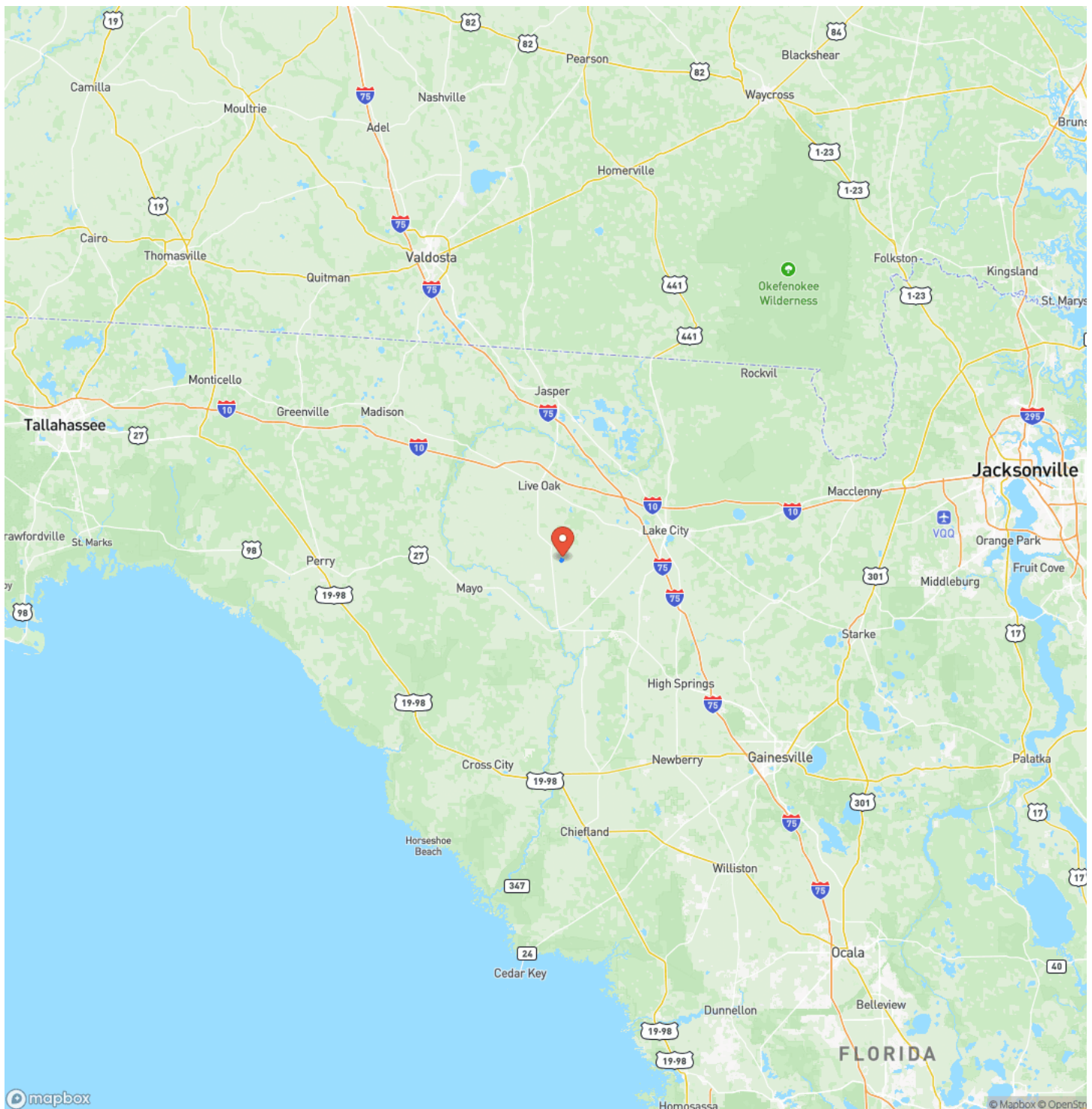




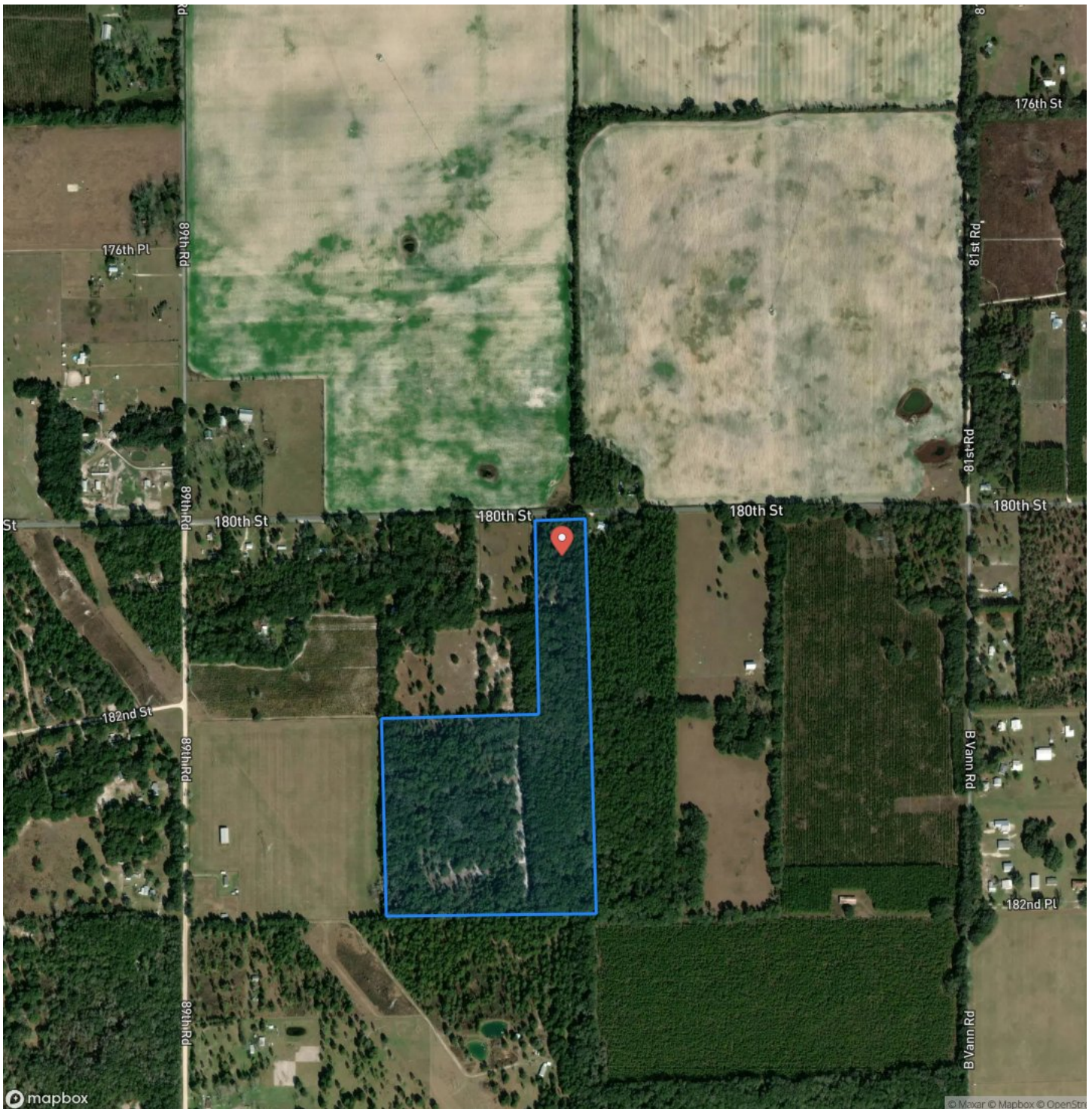
Locator Map
