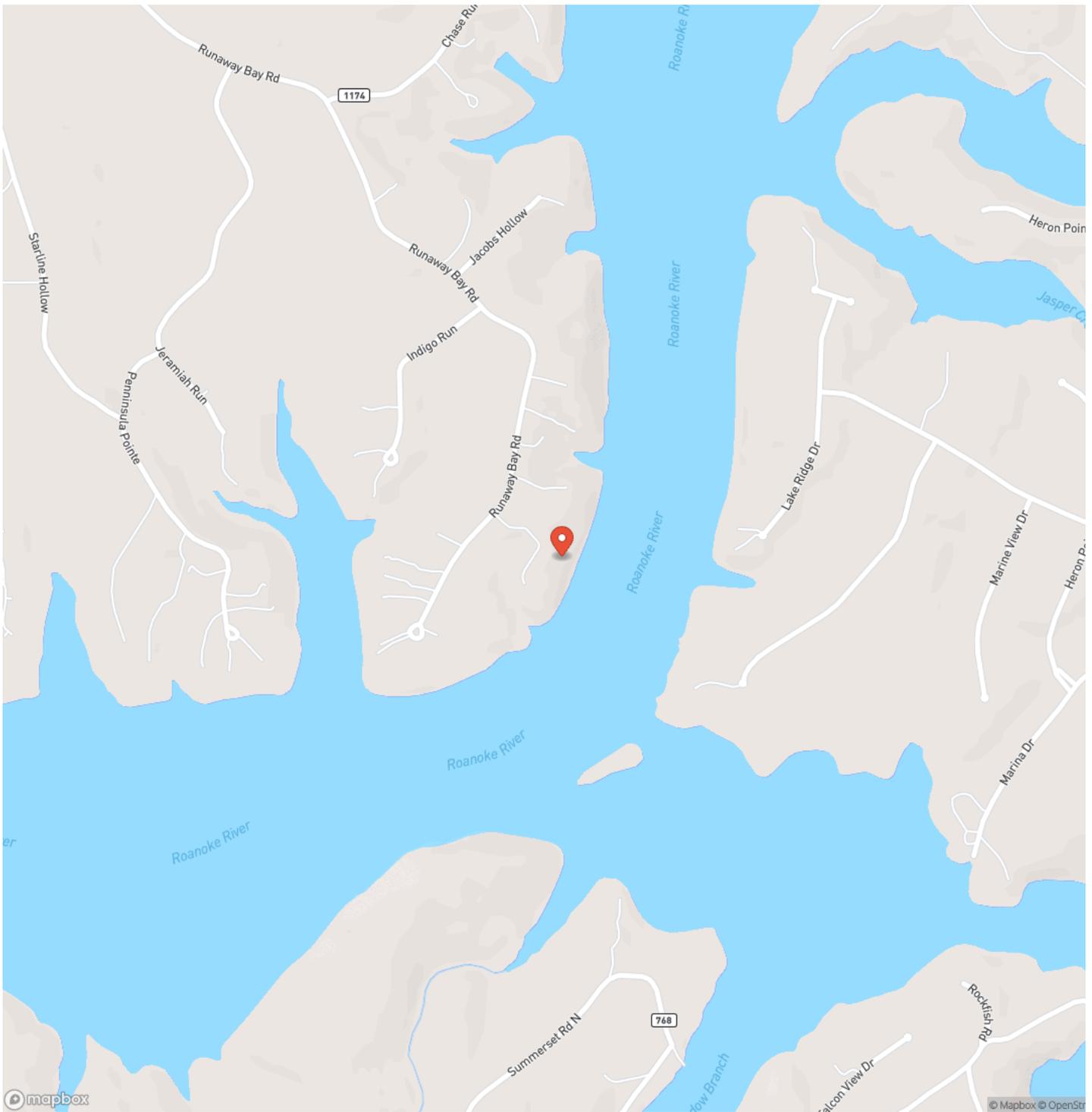

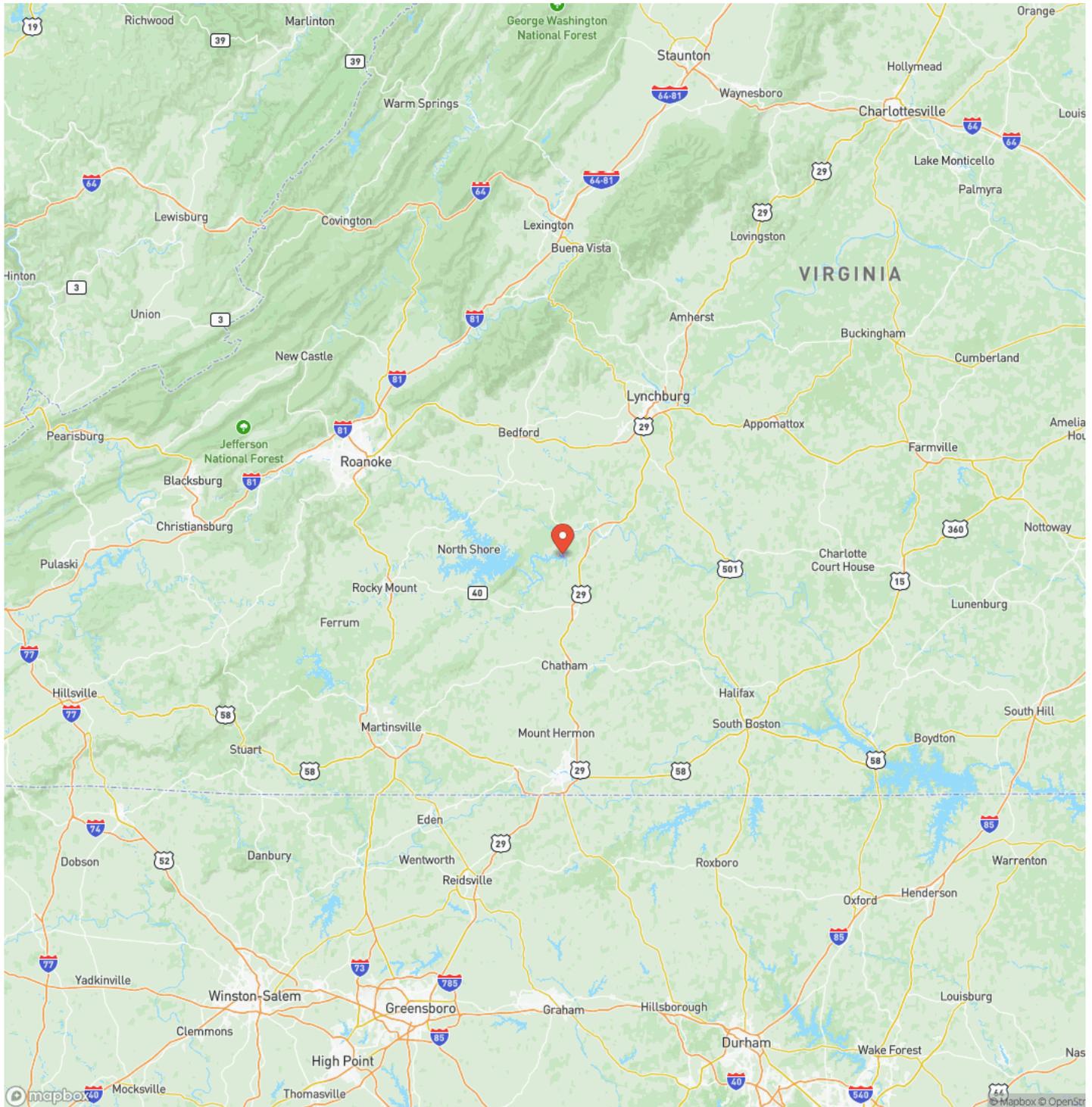

Locator Map



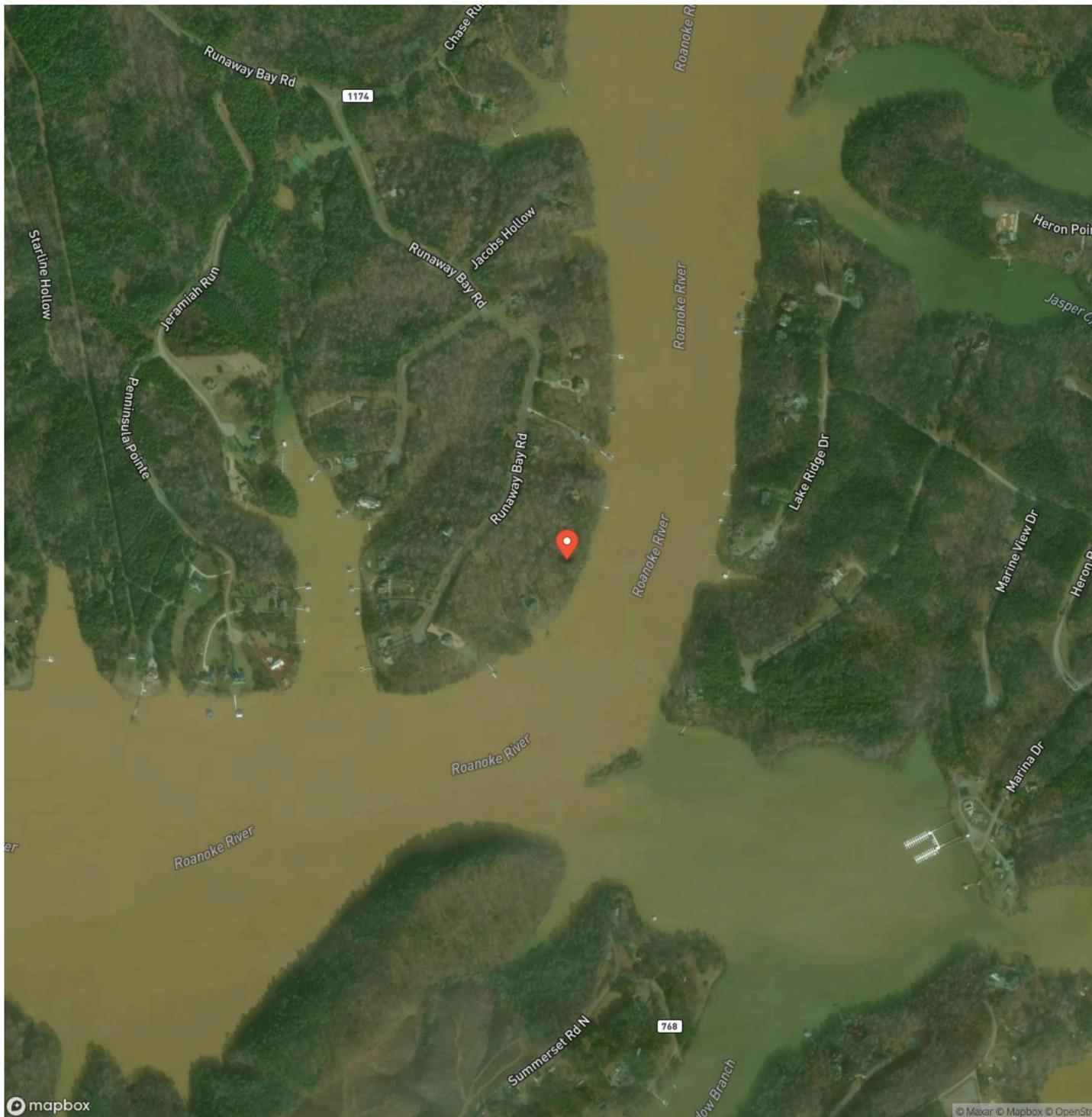
