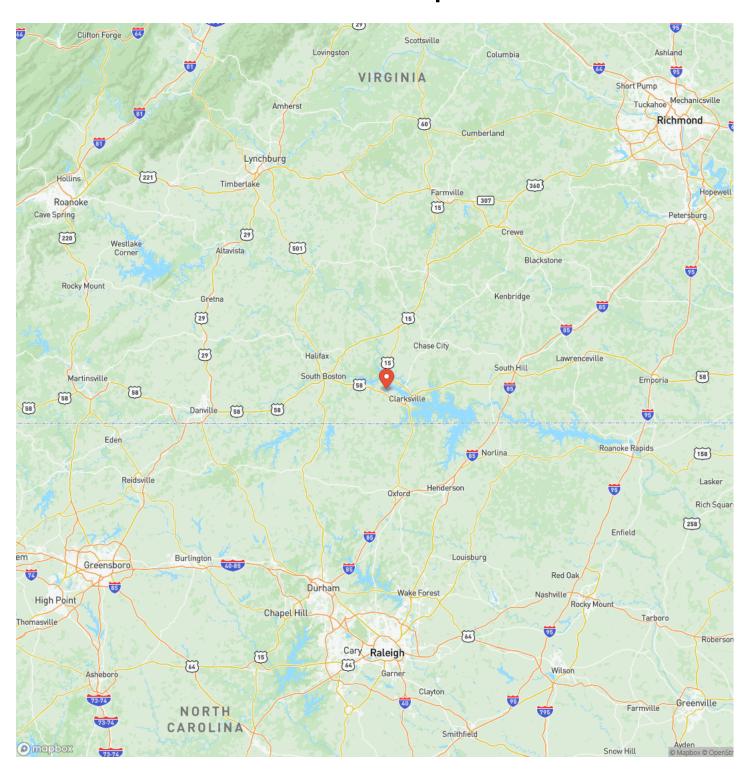


Locator Map
