Multiple flat potential homesites lay in wait for the new owners to choose from, utilities are available along the paved county road.

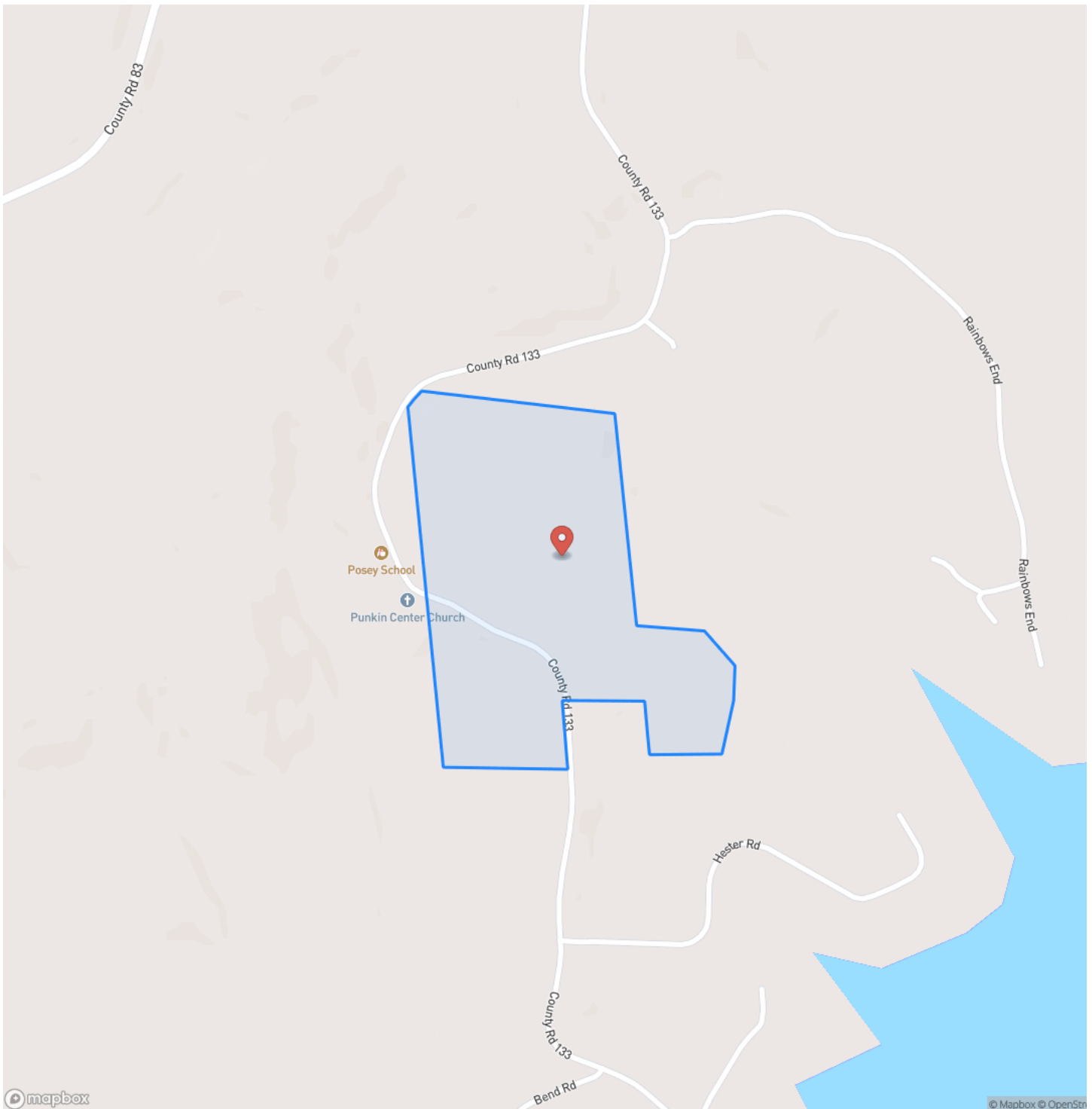

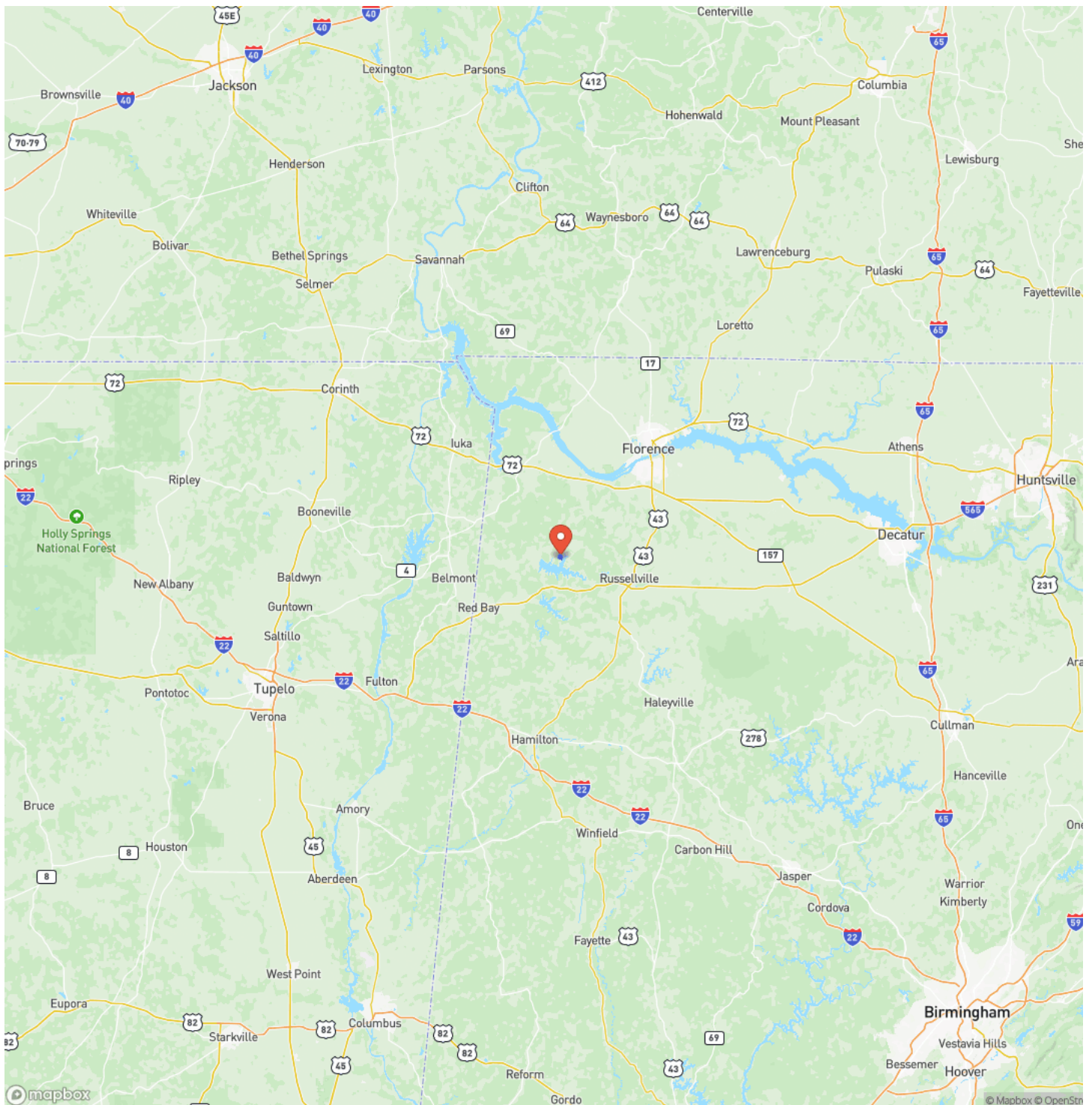

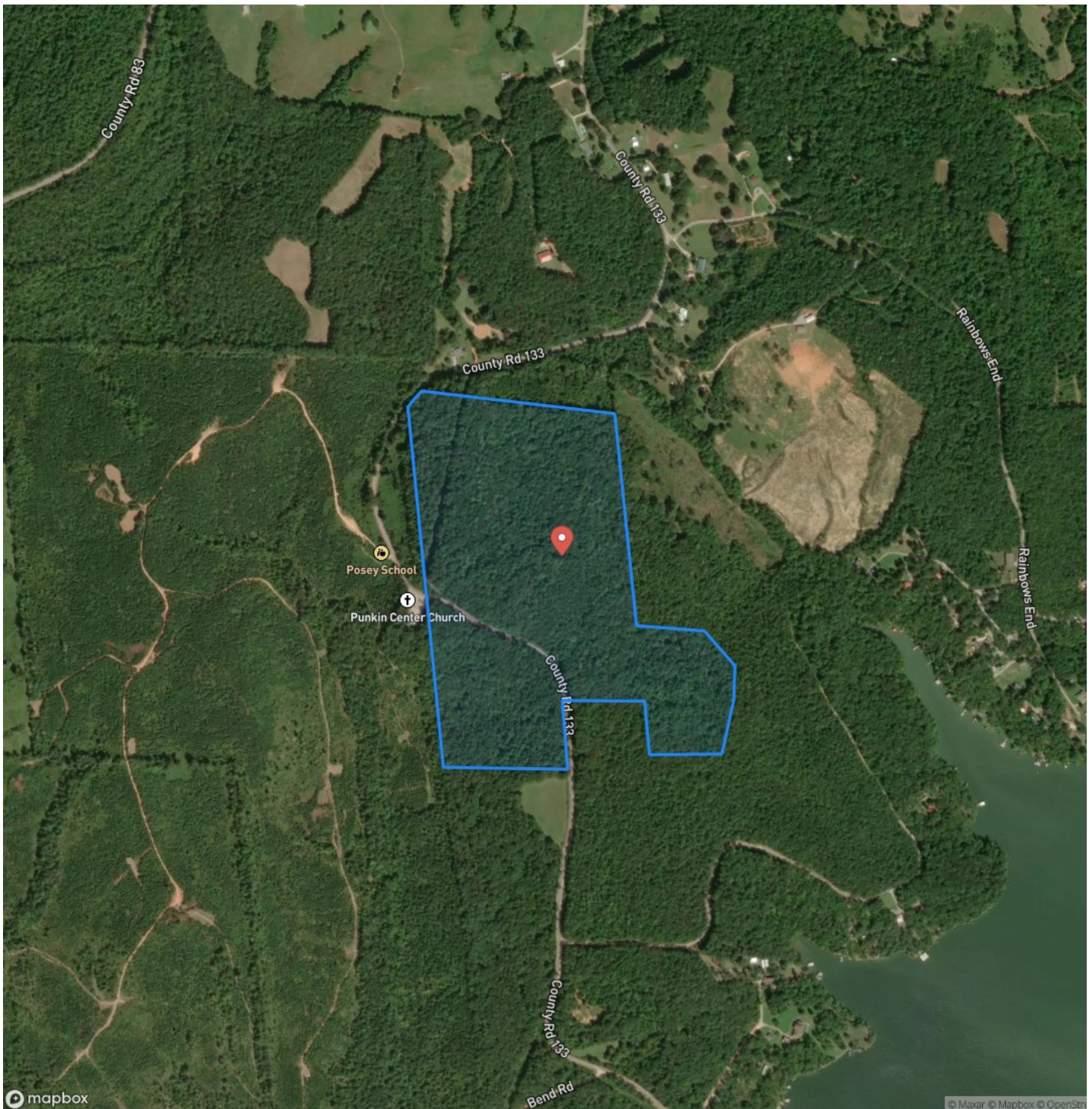
Locator Map
