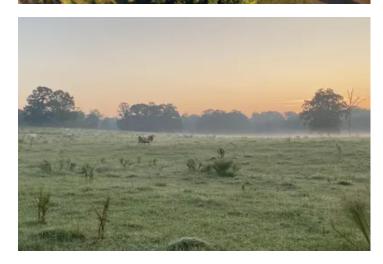

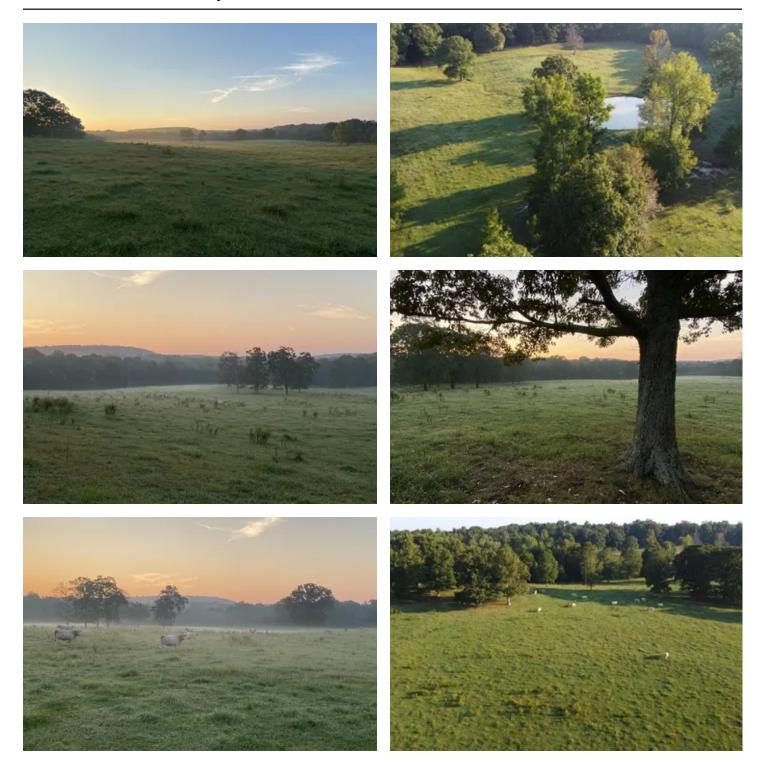

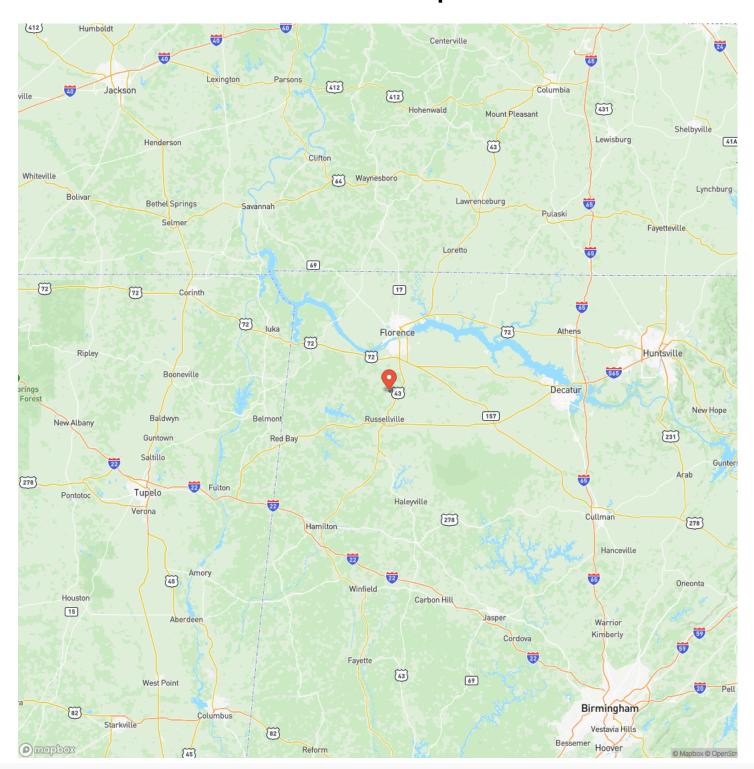


Locator Map
