PROPERTY DESCRIPTION


One-of-a-kind hunting mecca only one hour west of Colorado Springs! Just shy of 300 acres and with excellent access off a county-maintained road; large tract hunting properties like this are getting harder and harder to come by. With its high rocky outcroppings, thick forest, open meadows, and an underground spring/natural drainage-fed small pond on the northern boundary, this property contains everything you could want in a hunting/recreation property. It is bordered by large properties to its east and west and thousands of acres of Pike National Forest to the north. The seemingly remote location and water source are like a magnet for local wildlife to include elk, mule deer, turkeys, bears, bobcats, and other small game. A portion of this parcel was burned in the Hayman Fire (2002), but the area was reseeded in native grasses and has made a great comeback. The open aspect of this area now really opens up fields of view and makes this portion much more huntable. The layout and size of this property would allow for either a hunting cabin or a full-time residence while still retaining enough undeveloped habitat for your recreational pursuits. Gold medal fly fishing in the Dream Stream, limited stakes gambling in Cripple Creek, and fuel/groceries/dining in Florissant/Divide/Woodland Park all within minutes of this property. Close enough to be convenient, but remote enough to get away from the grind...this is the one!


