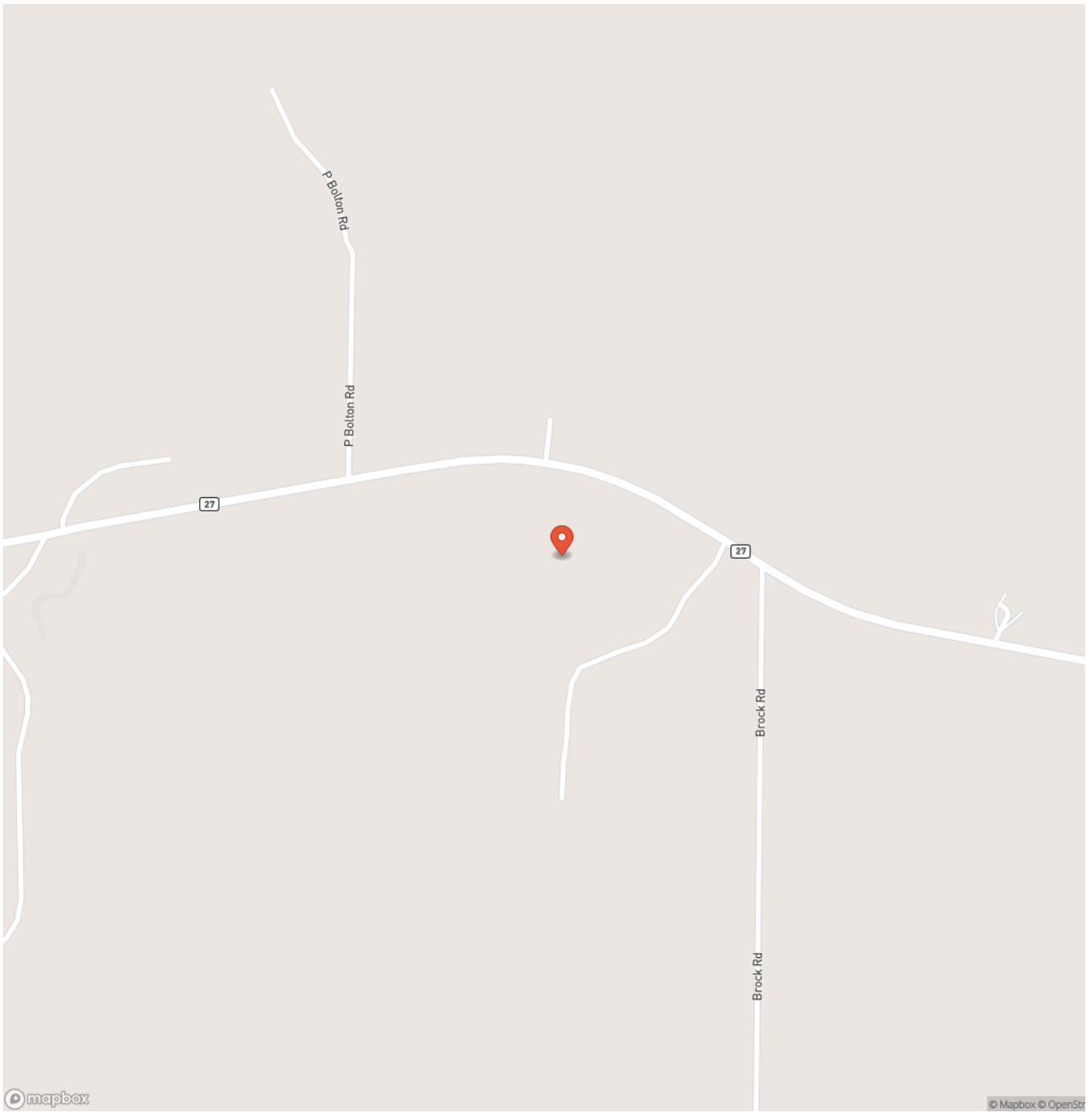

In fact, the county is widely recognized as one of the top regions in Mississippi for harvesting mature bucks. For turkey hunters, the mix of hardwood bottoms, creek frontage, and open areas provides excellent nesting habitat and strong gobbler populations--making this a true year-round recreational property. 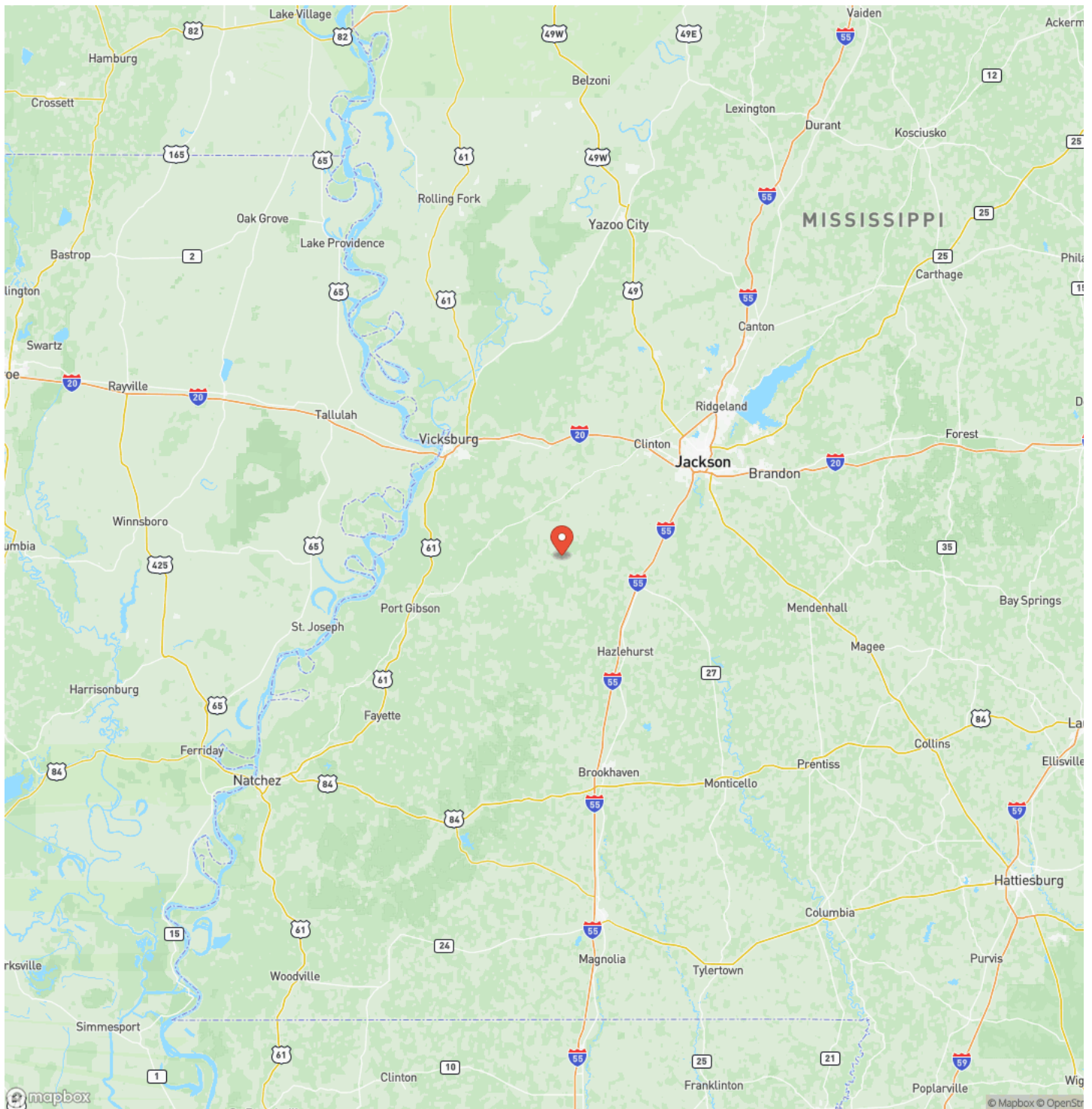

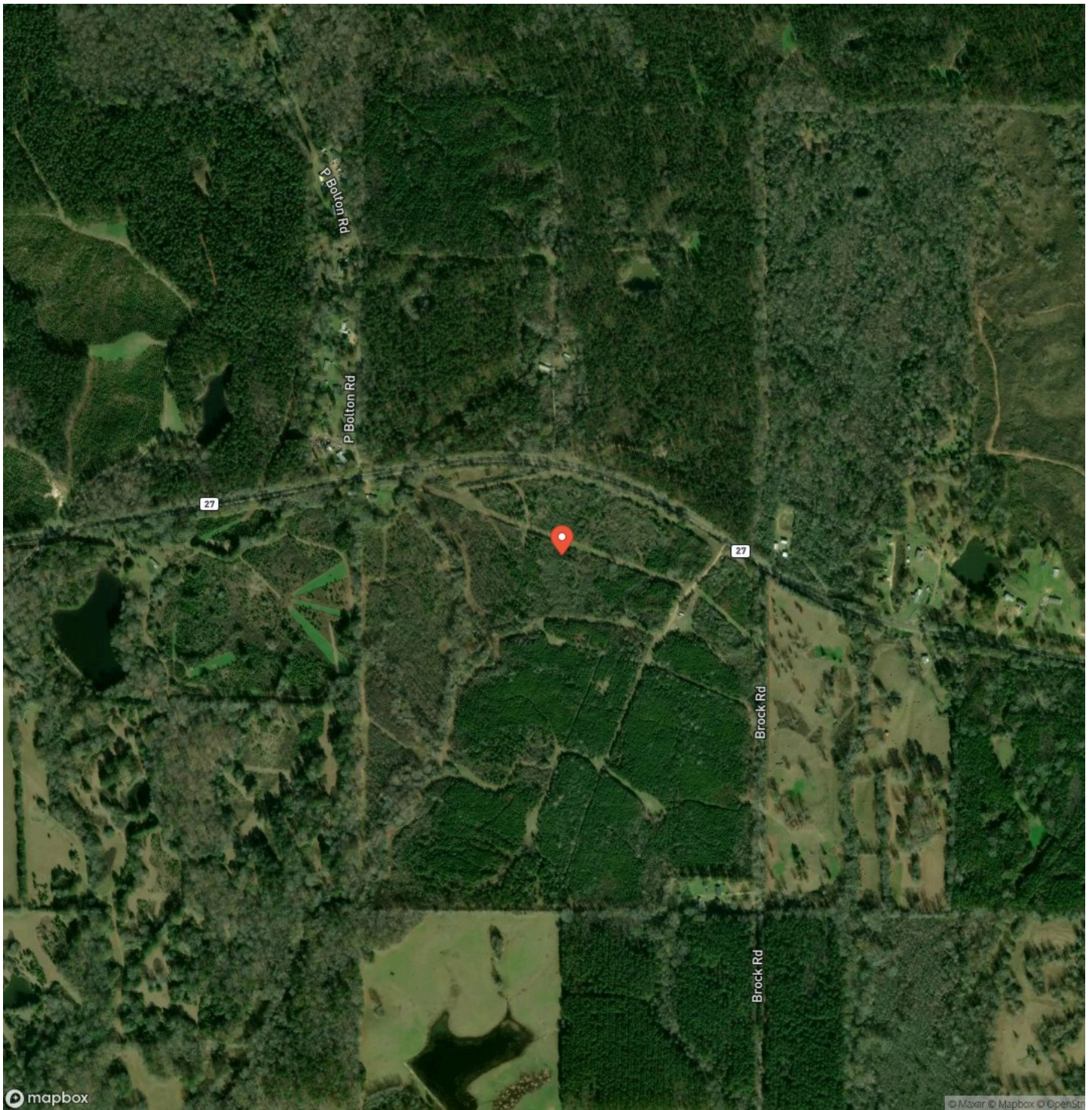
Locator Map
