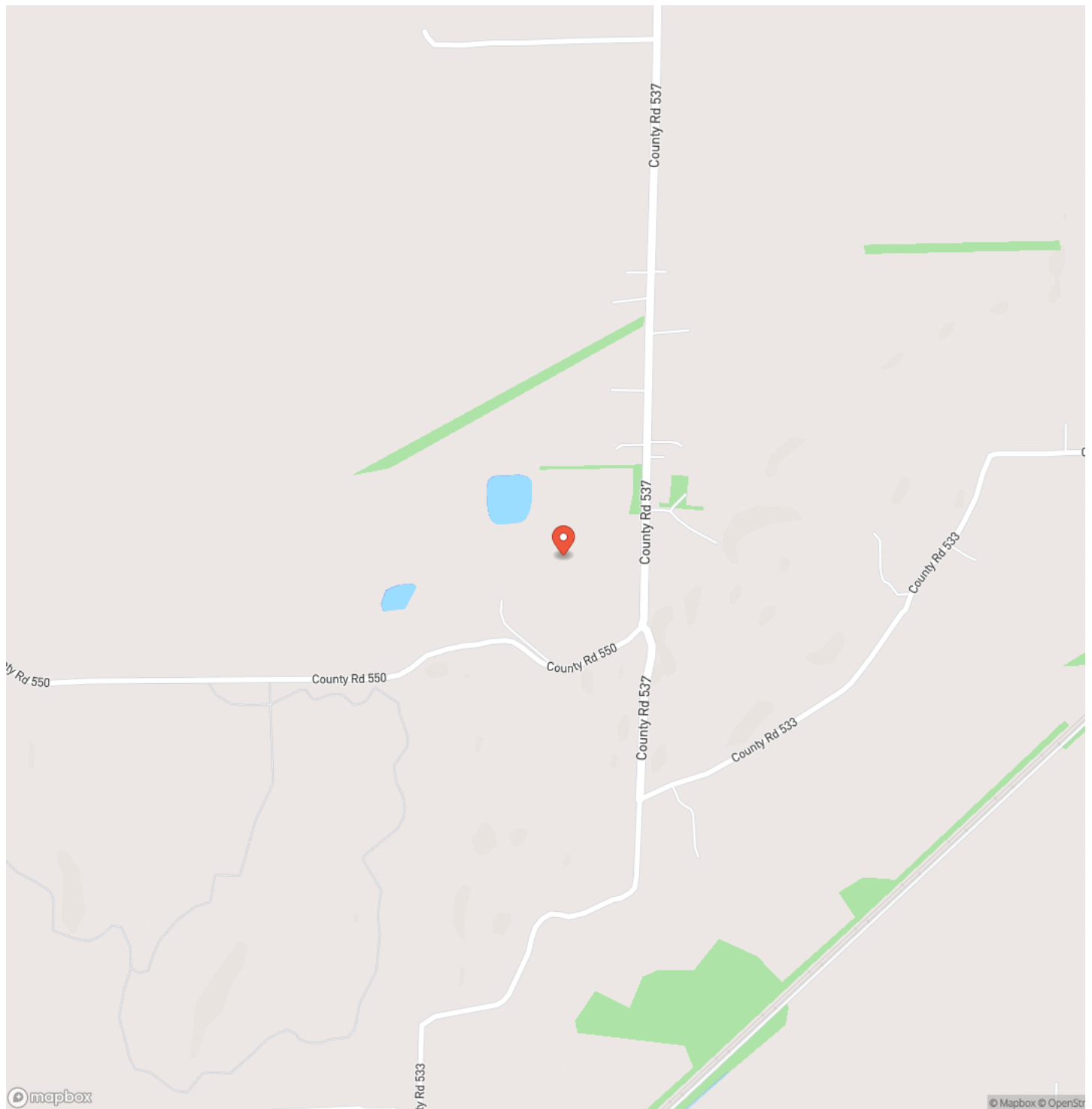

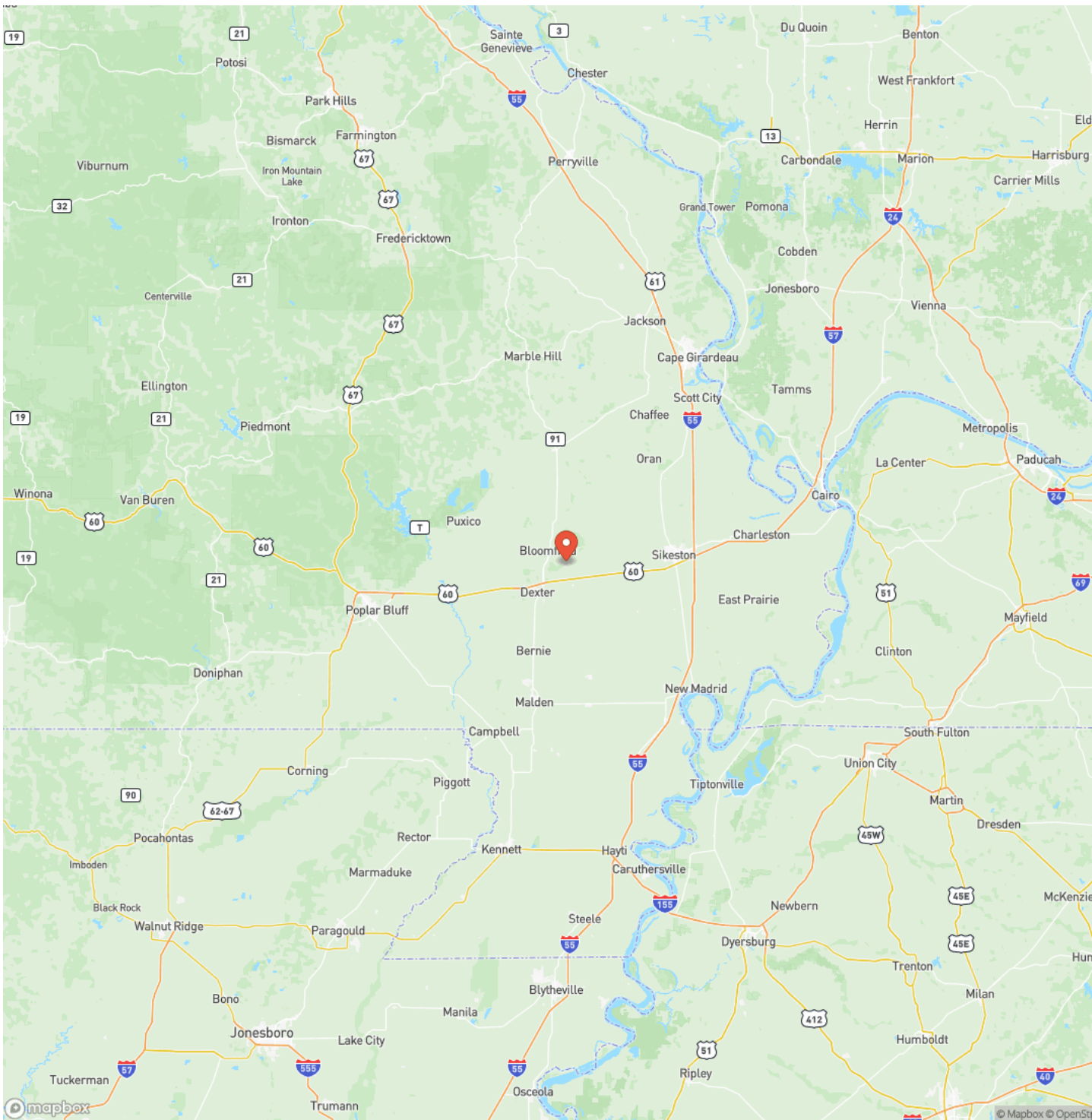


## Locator Map

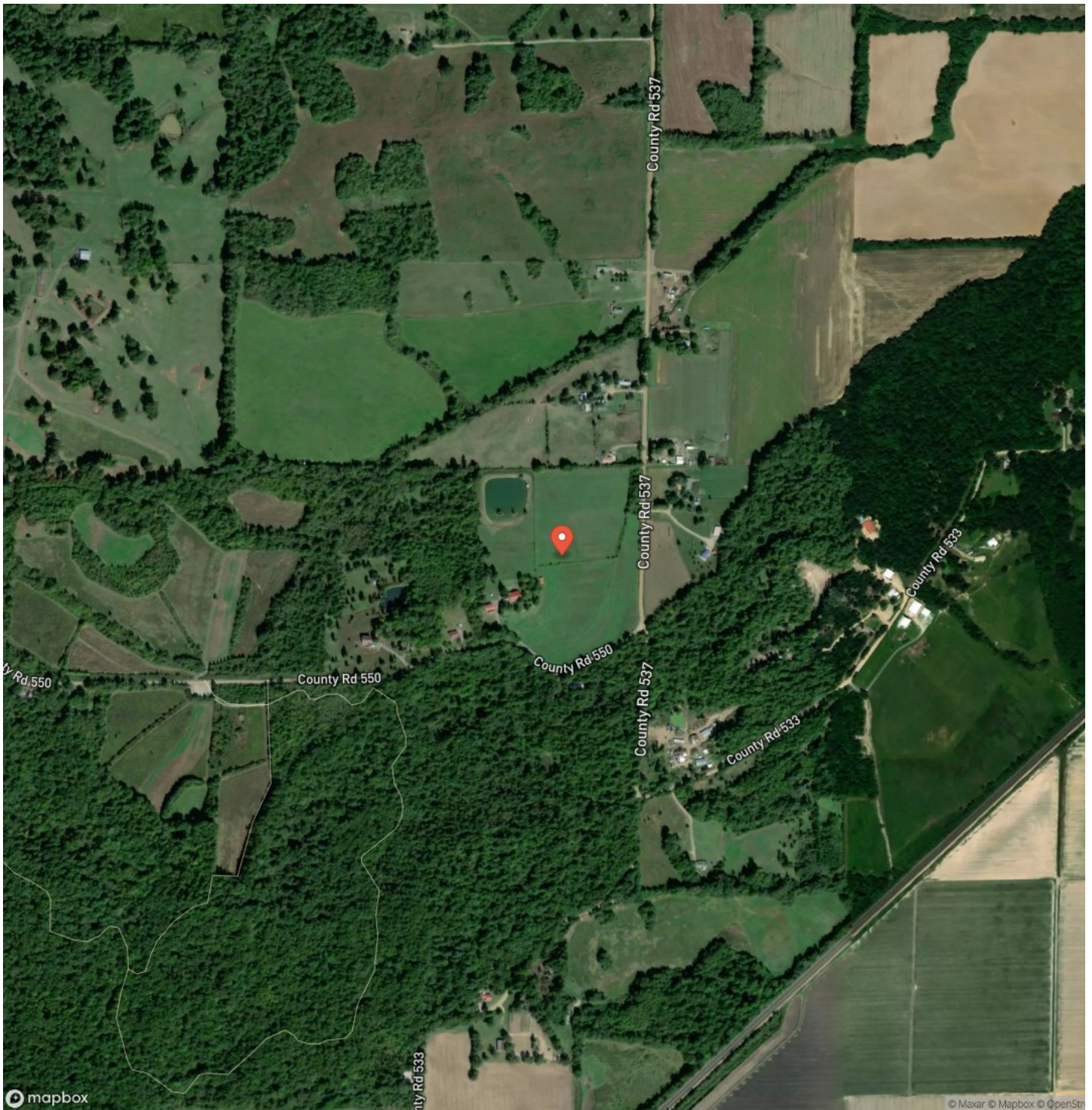
