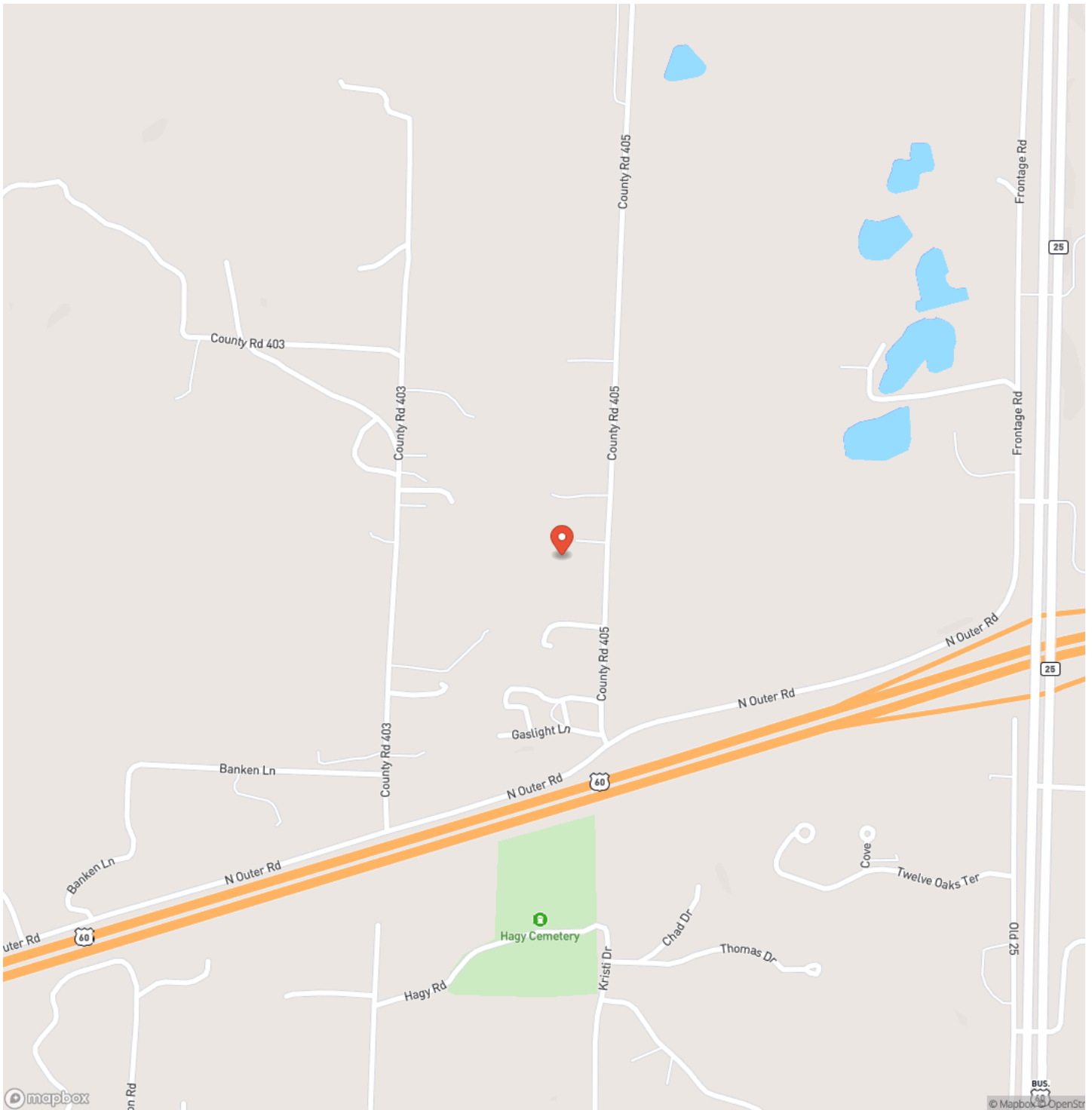

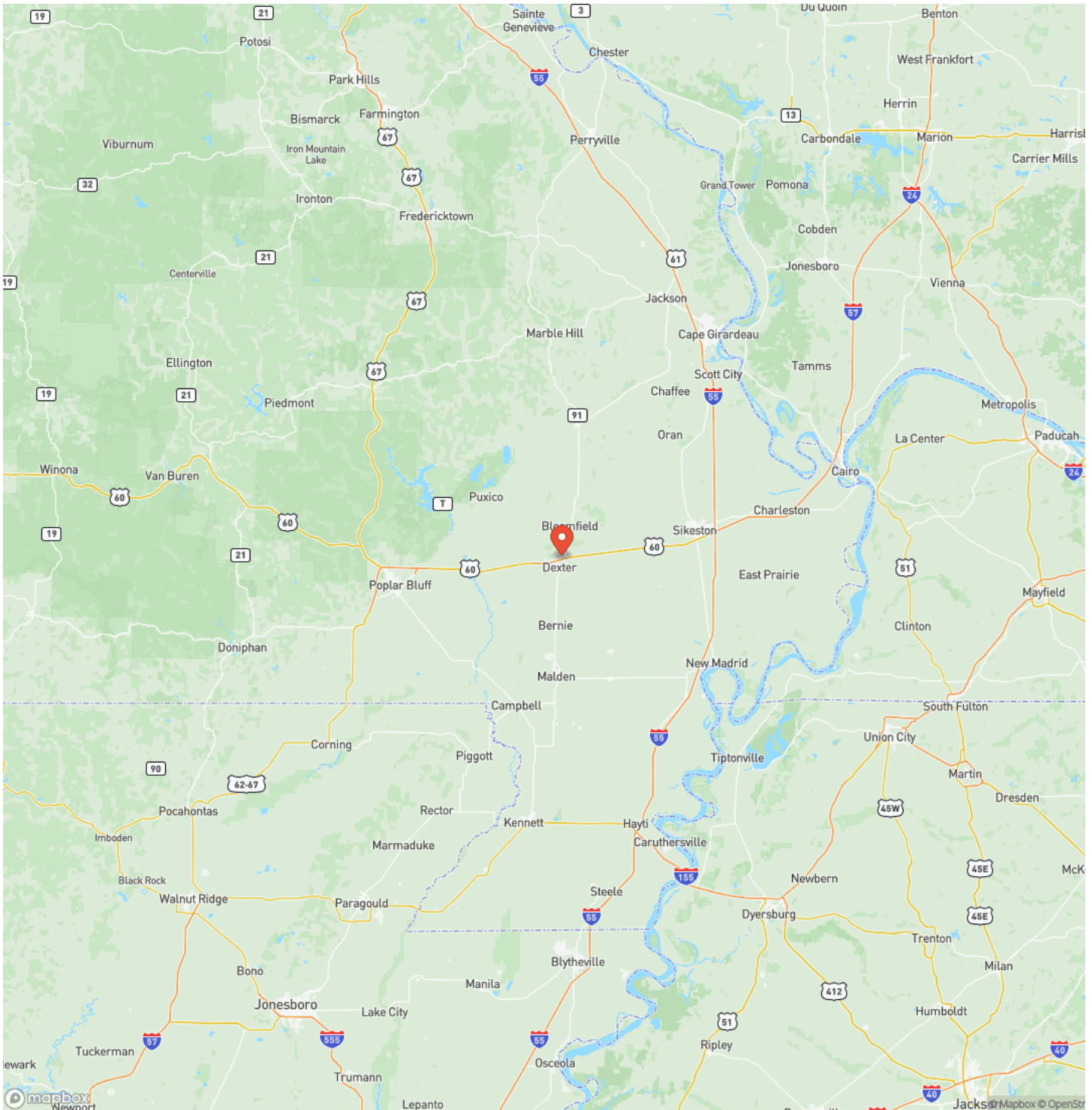


## Locator Map



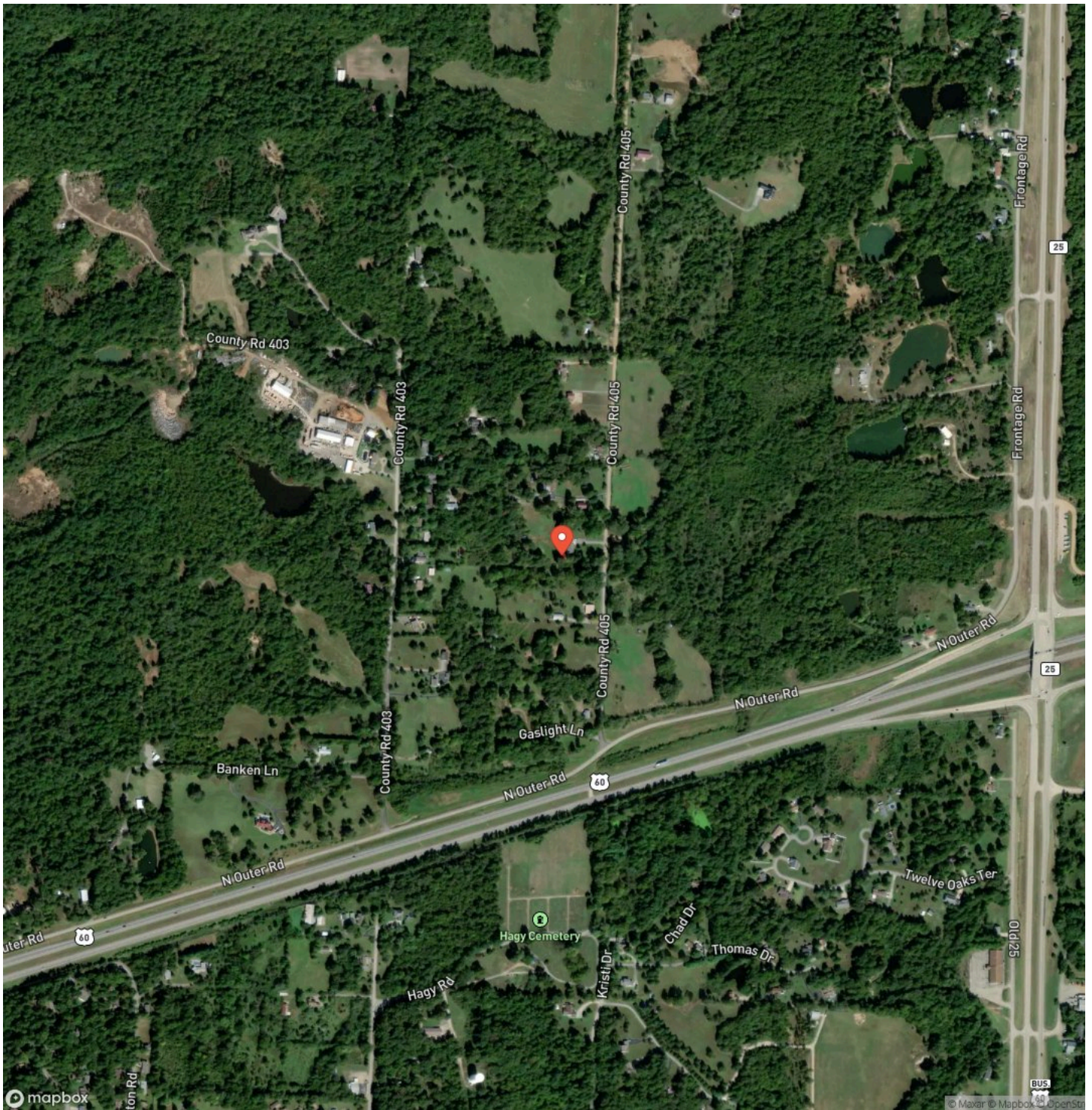
