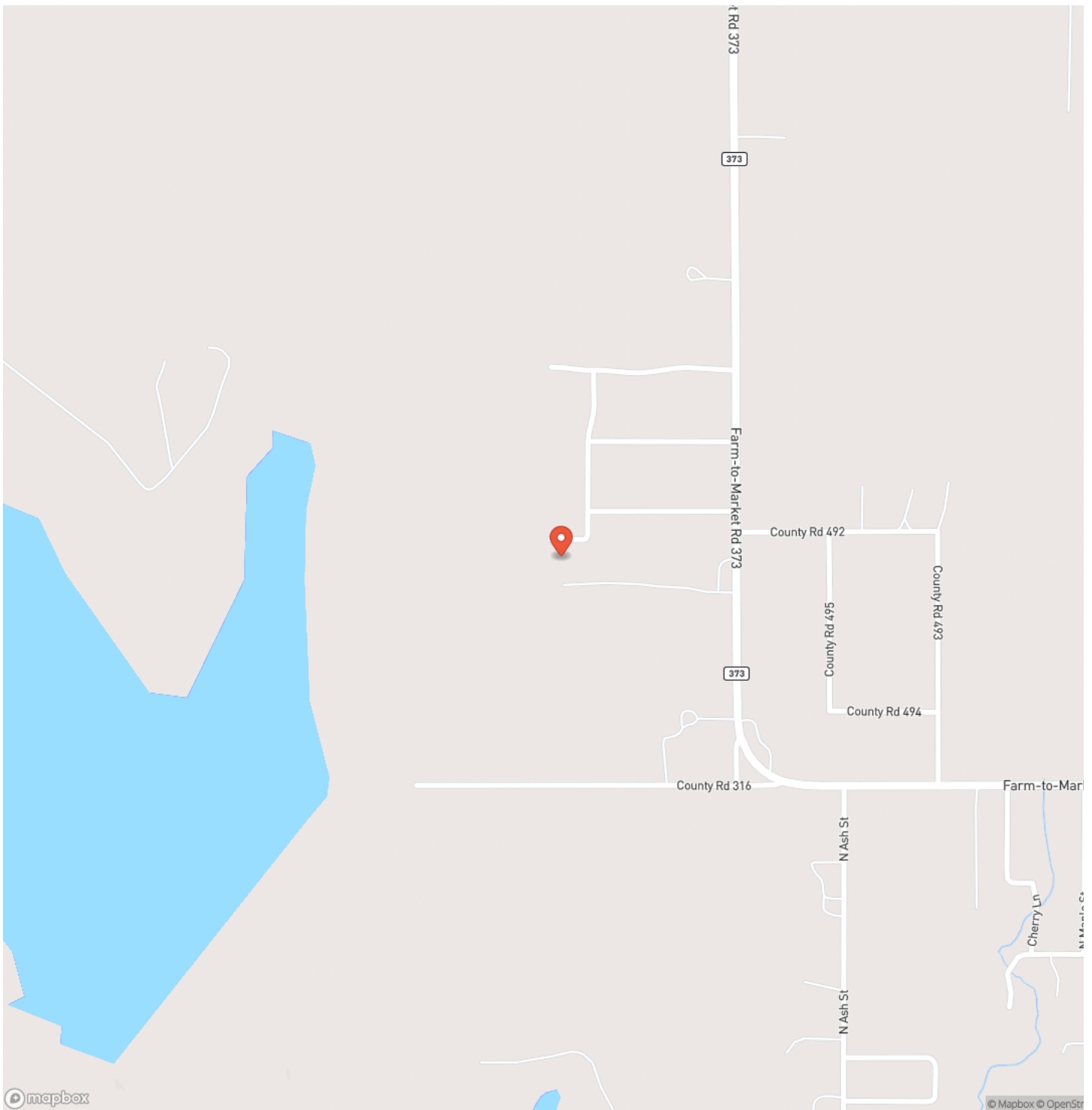

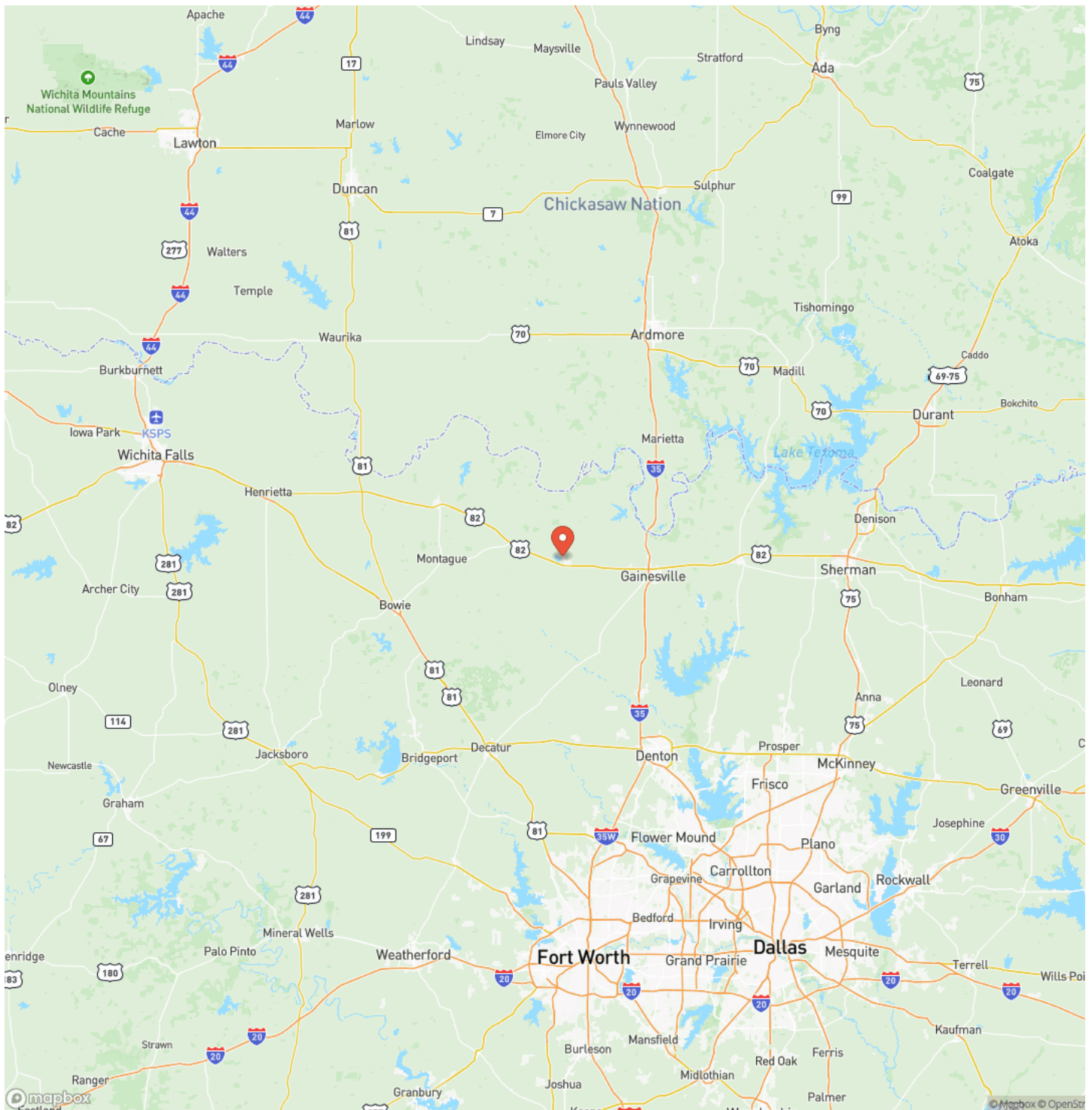


Locator Map



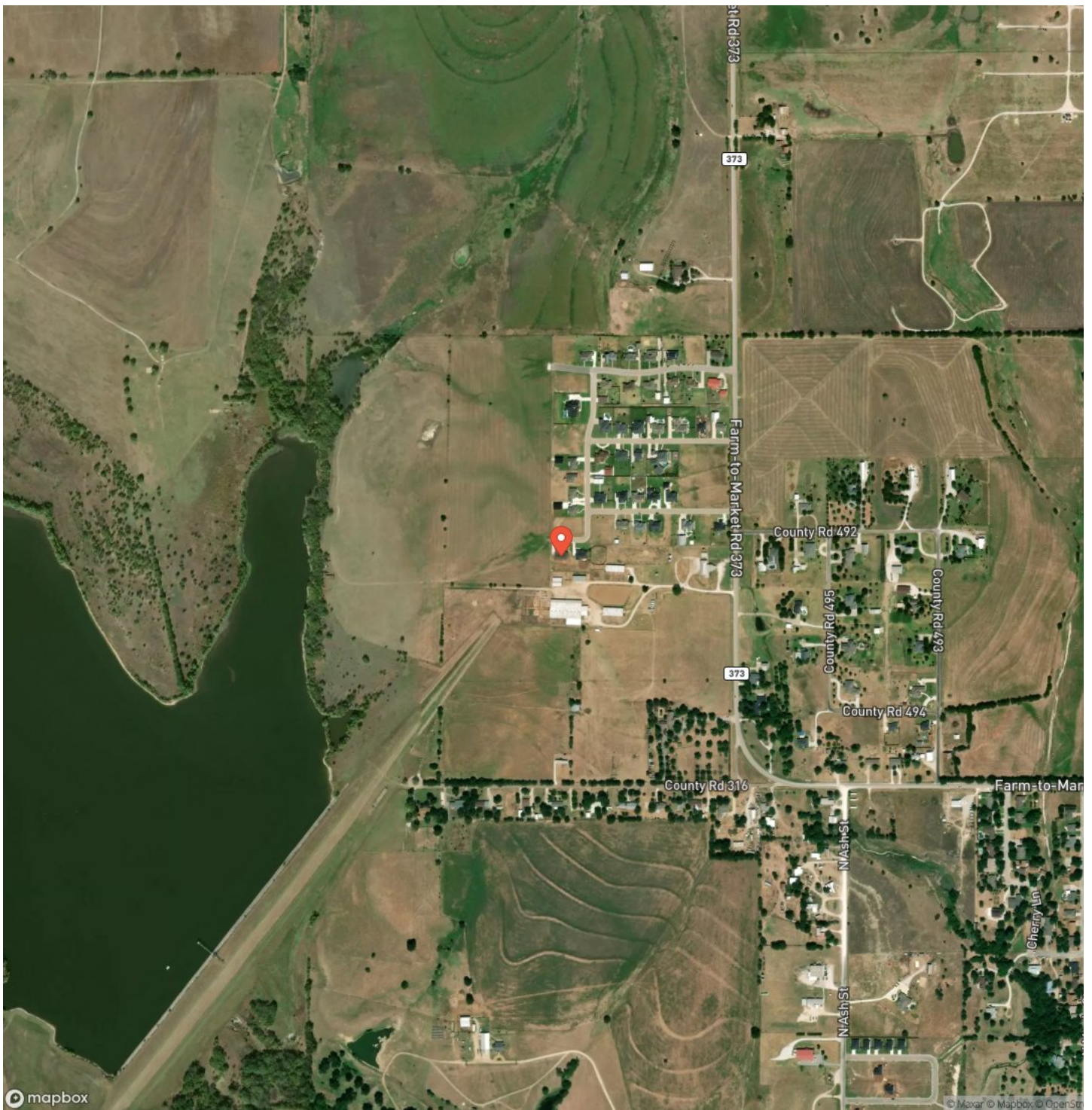
