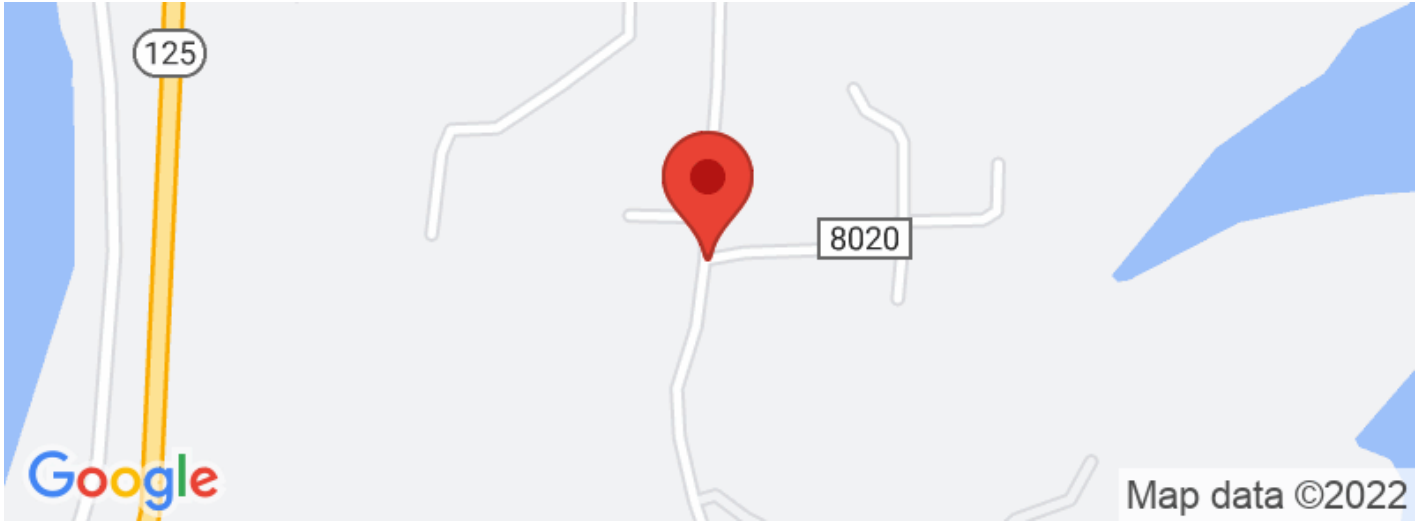

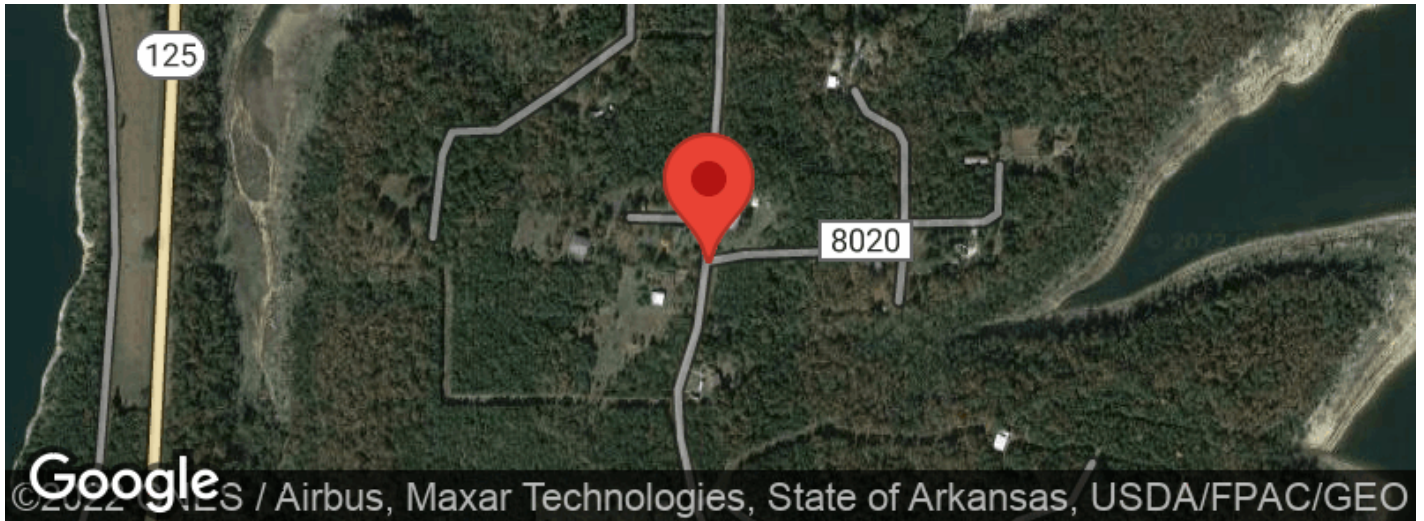




Locator Maps
