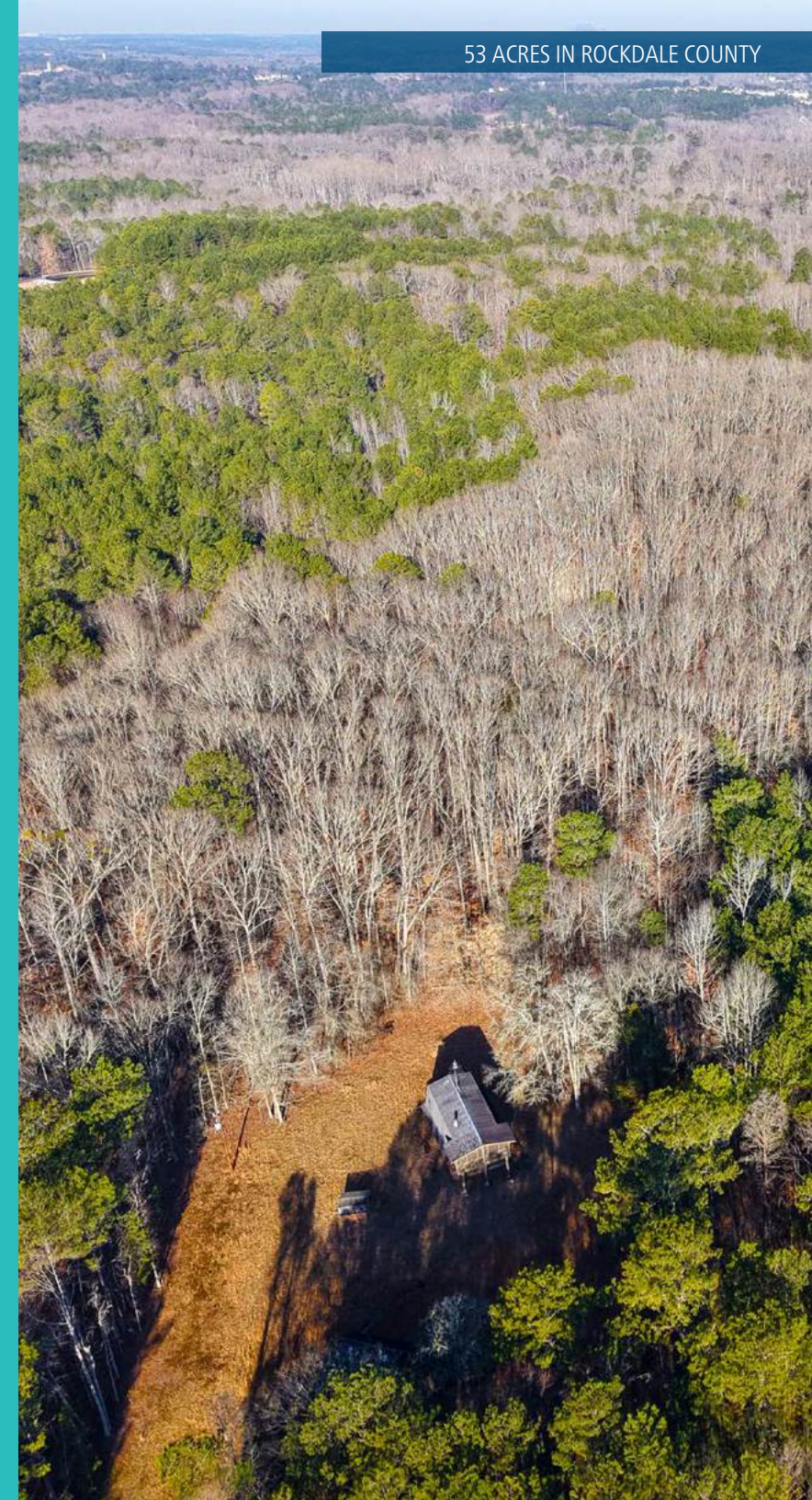

Gees Mill Rd offers the following attributes:

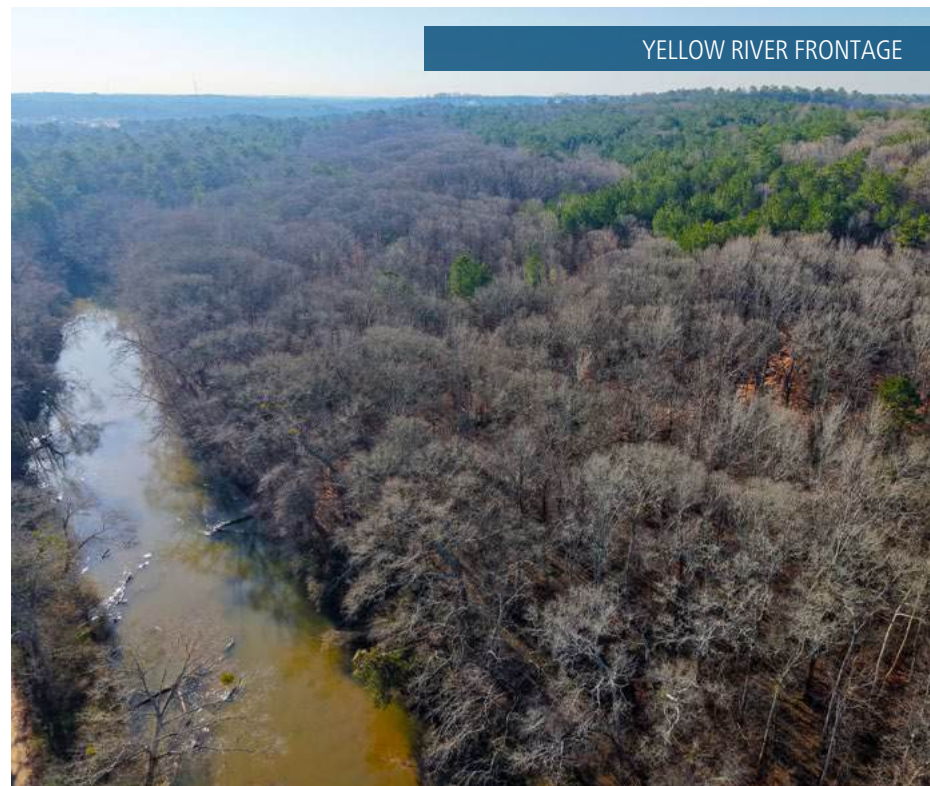
- Convenient access to Interstate 20, less than 3 miles away, offering easy access to Atlanta.

EXISTING HOUSE ON PROPERTY

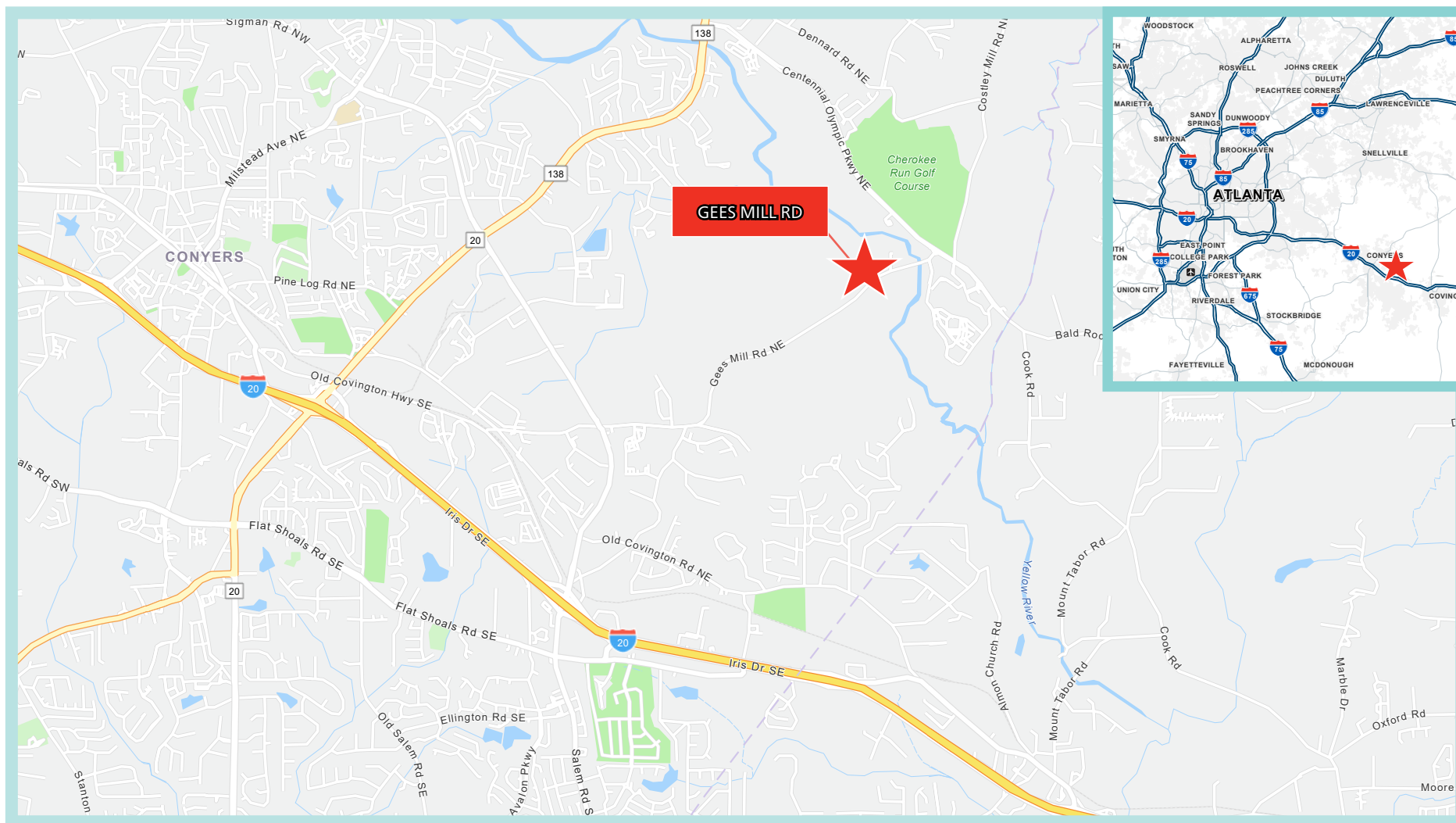


YELLOW RIVER FRONTAGE

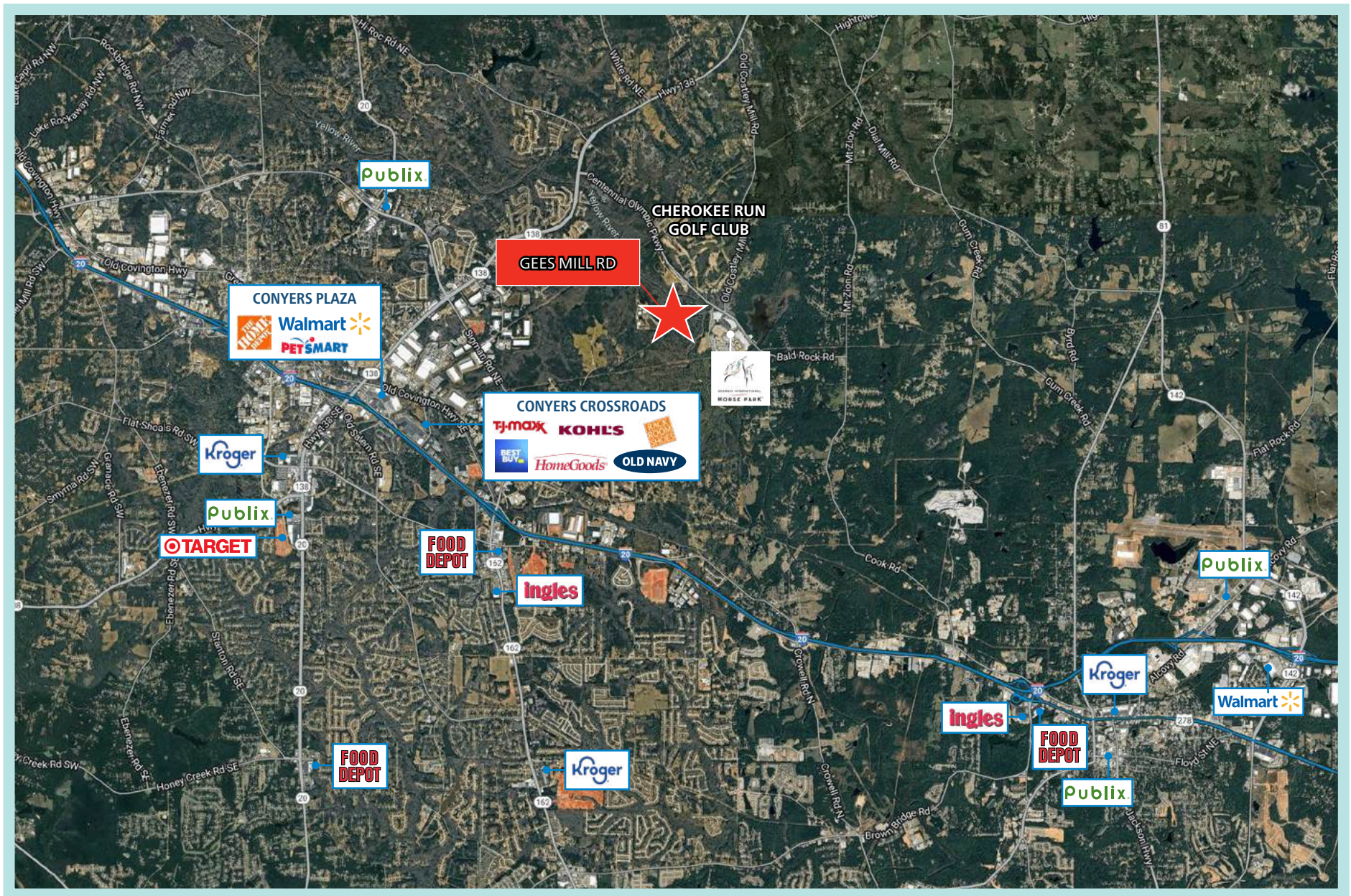

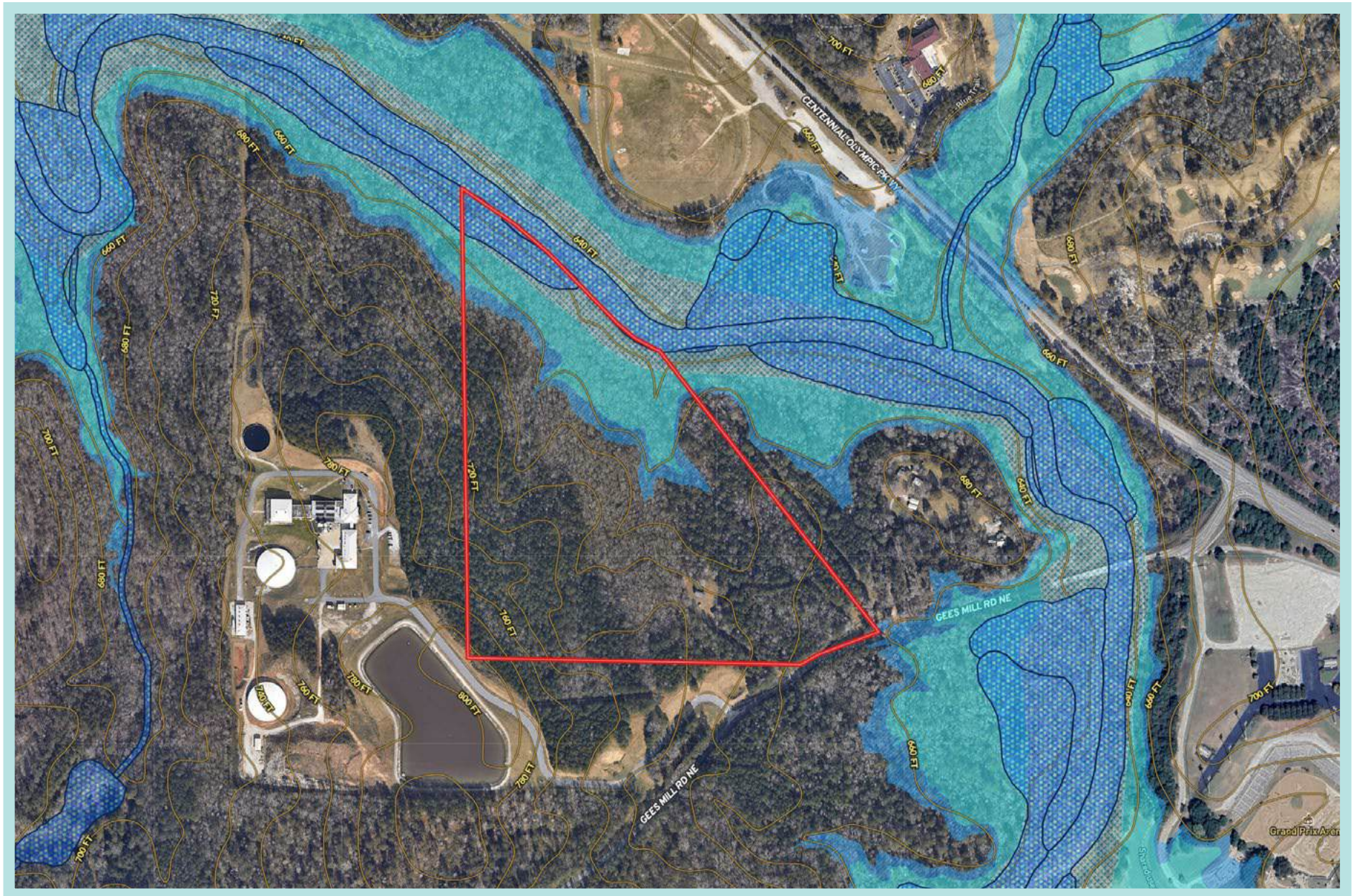

The Property is currently zoned R-1 in Rockdale County with the following development standards:

Minimum Lot Size.....	30,000 SF
Minimum Lot Width	100'
Minimum Front Setback	25'
Minimum Side Setback	10'
Minimum Rear Setback.....	40'
Minimum Heated Floor Area.....	1,600 SF

FUTURE LAND USE

The Estate Residential Character Area of Rockdale County encompasses a transitional land use area on the north side of the city of Conyers. The area is largely comprised of rural residential development but is adjacent to areas where the County encourages compact development at higher densities (though not always higher intensity), such as Milstead Village and Costley Mill. The area has the largest concentration of granite outcrops in the county compared with other character areas. These outcrops will limit the availability of developable land and contribute to the natural and rural character of the county. New development should consider the benefit of preserving the existing character of the area.

UTILITIES

There is a domestic water line in the right-of-way of Gees Mill Road. There is no sanitary sewer located near this property.

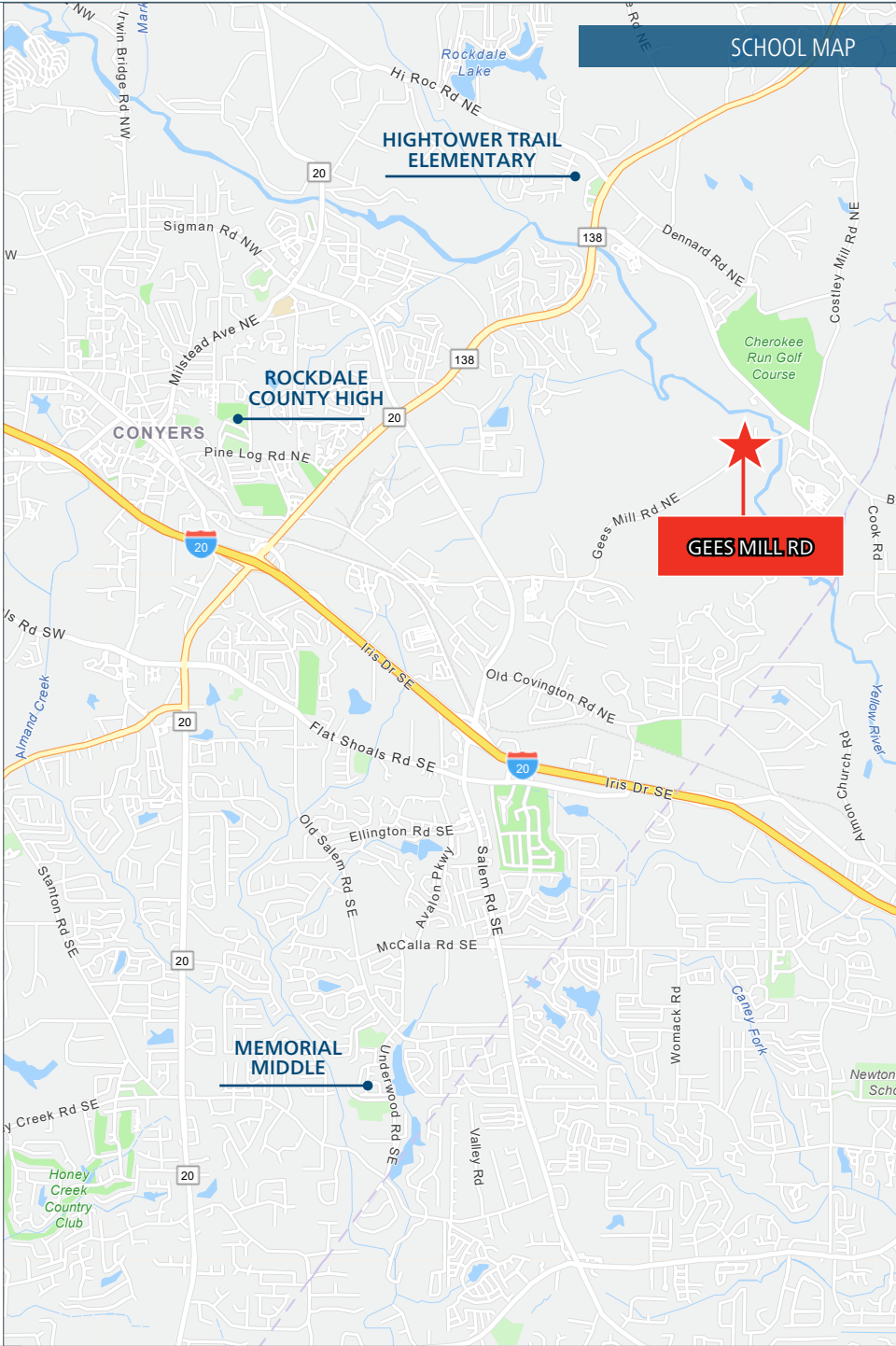

ROCKDALE COUNTY MARKET

The Property is located in Rockdale County, Georgia with a population of approximately 91,000 people. The city of Conyers is the county seat. Over the recent years, Rockdale County has continued to grow and become a desired place for families to live. Below are some highlights from the growing Rockdale County and City of Conyers:

- **The Georgia International Horse Park**, founded in 1995, has hosted some of the largest equestrian events in the world, including the 1996 Olympics. Currently, it serves as a venue for many different services and events, including weddings, festivals, family reunions, equestrian events, sports competitions and more. In 2019, it was voted “Official Best Outdoor Venue in Georgia”.
- In 1944, monks from Kentucky embarked on a journey to Georgia and founded **The Monastery of the Holy Spirit**. Today, the Monastery has become a great destination for the entire family. There are shops, places to sample gourmet food and walks with nature throughout the 2,300-acre site.
- Rockdale County also has a handful of parks that offer hiking, fishing, boating, playgrounds and walking trails. Black Shoals Park, Johnson Park and Costley Mill Park are a few of those.

ROCKDALE COUNTY DETACHED HOUSING AND LOT ANALYSIS

The Rockdale County housing market continues to experience strong growth for both new and resale SFD houses. The new construction SFD housing sales data for Fulton County from 2021-3Q25 is as follows:

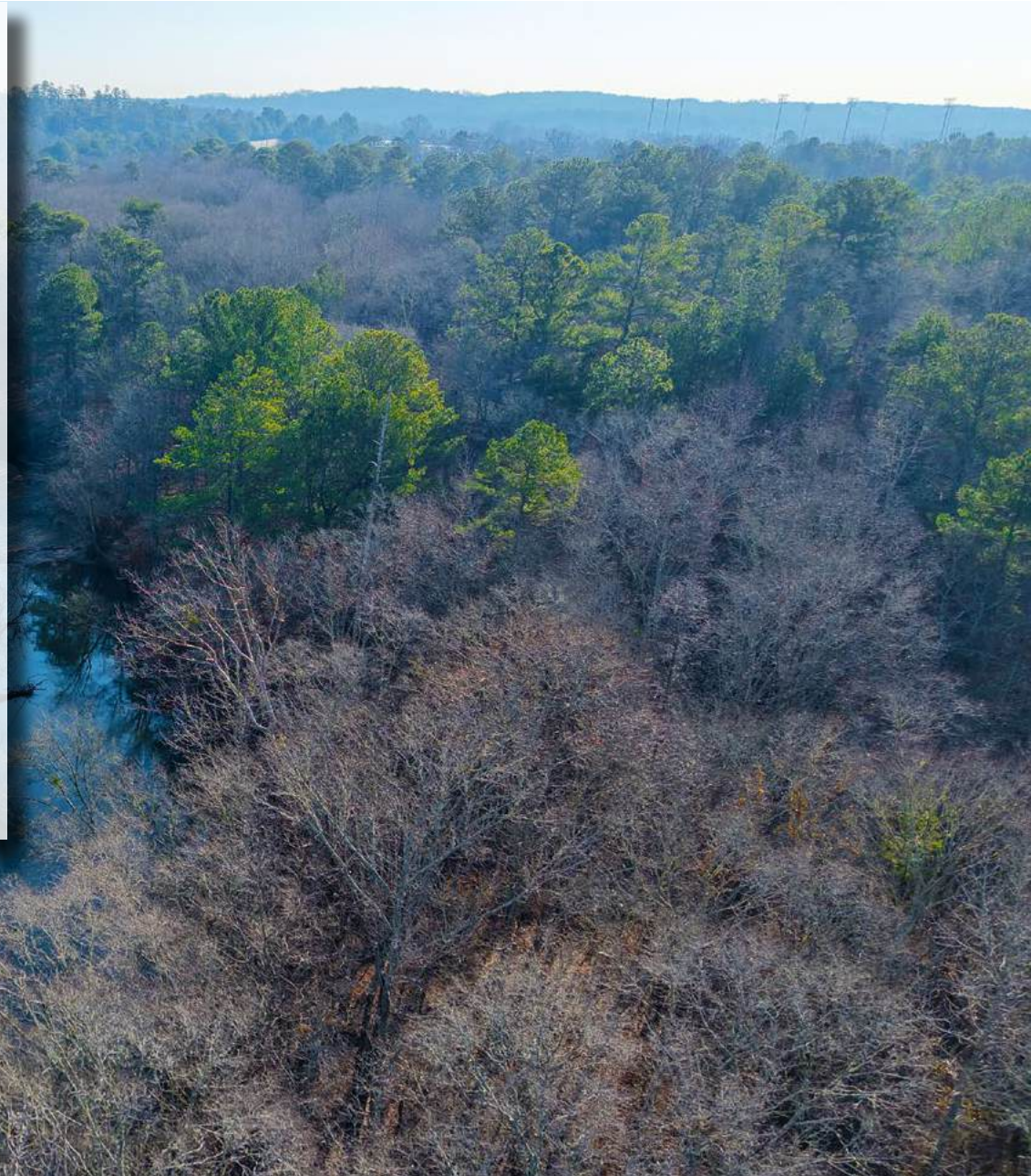

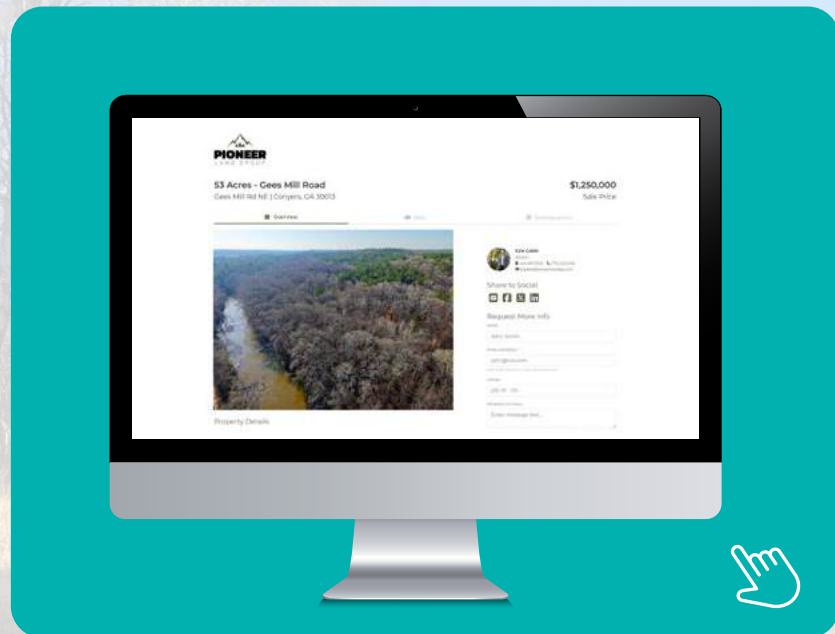
