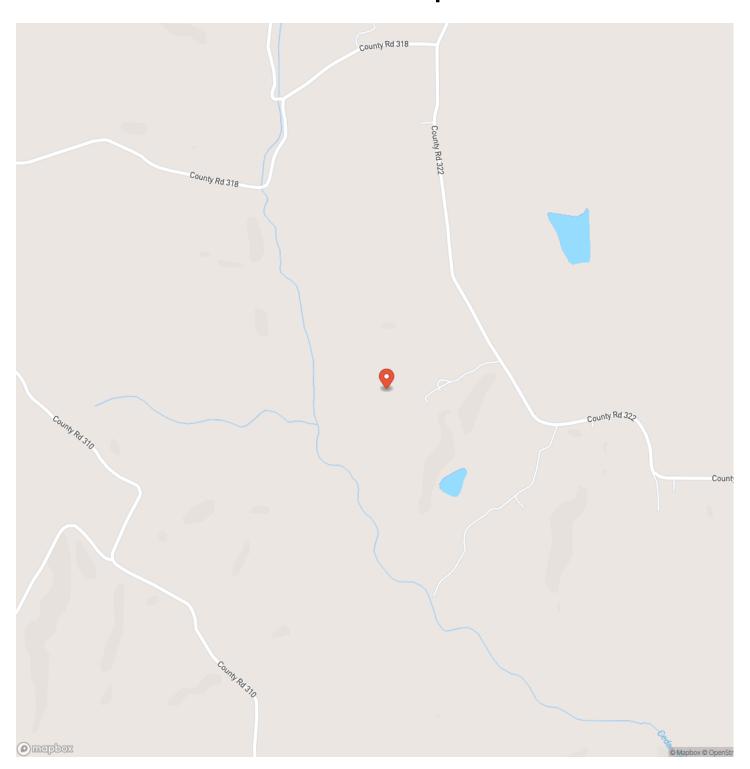






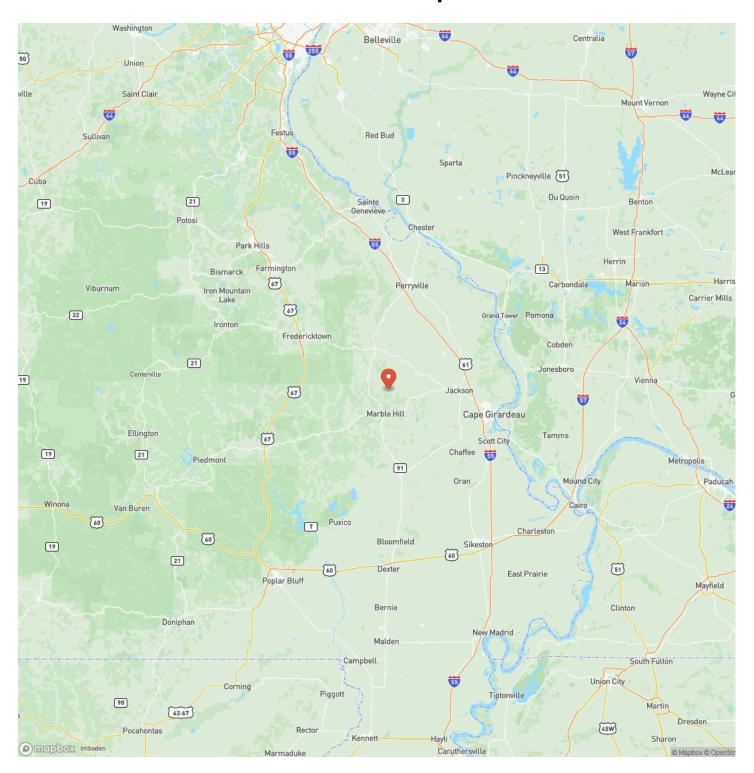


Locator Map
