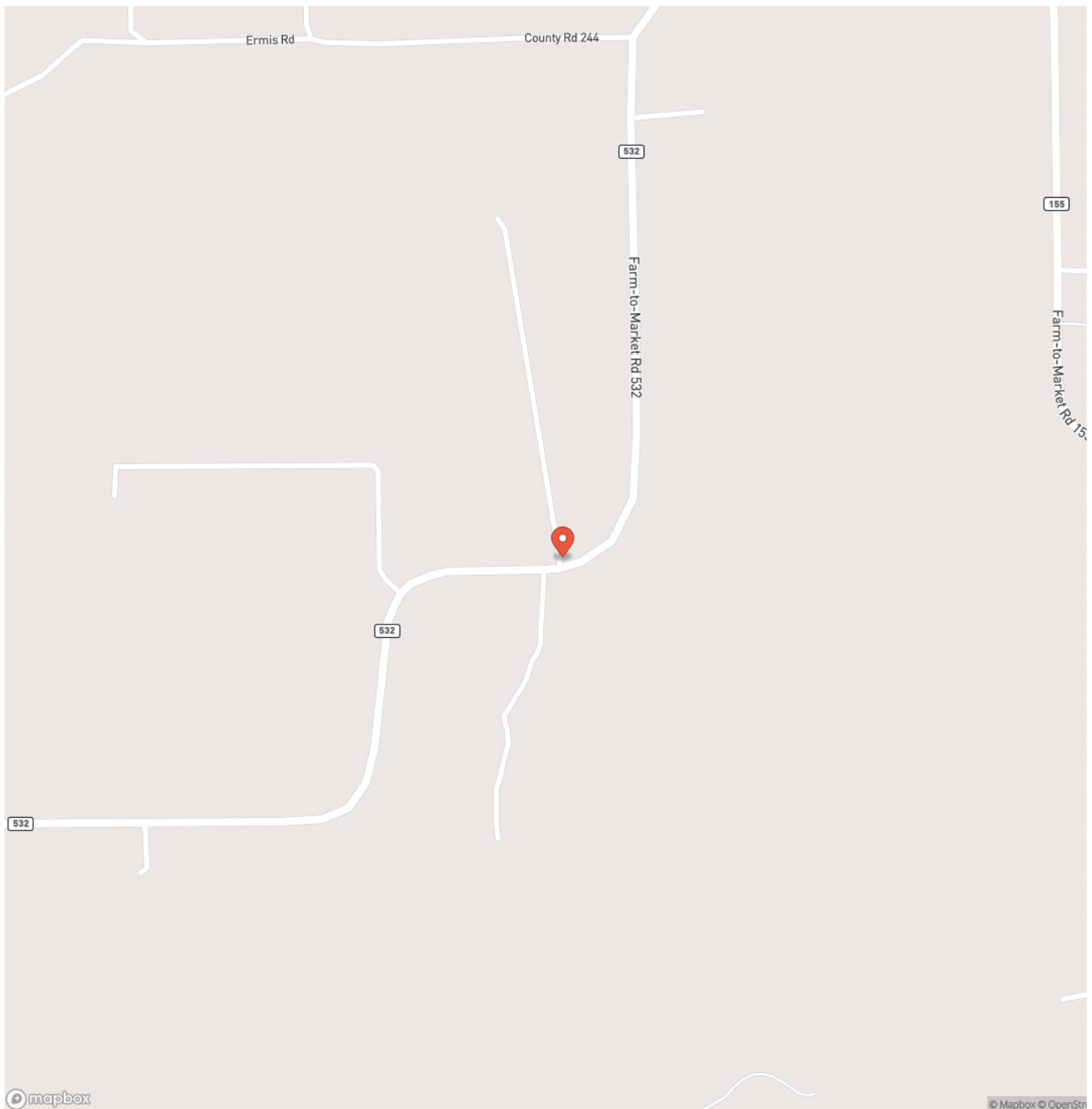

## Locator Map

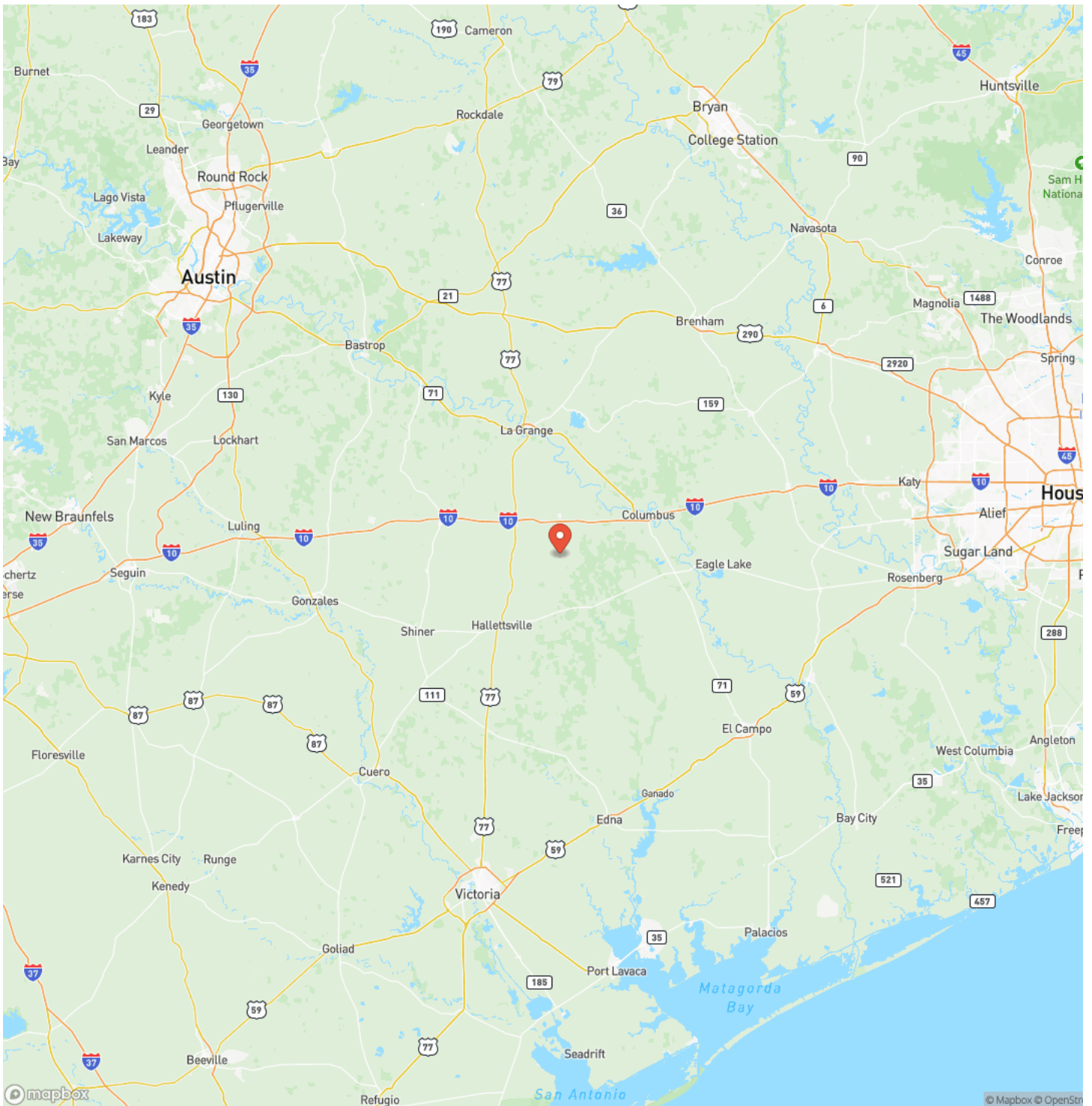
