THENCE S 25° 46' 39" W a distance of 102.34 feet to a ½ inch iron rod found (called for in Volume 23, Page 3309- Official Records Colorado County, Texas);

THENCE N 51° 56' 59" W a distance of 577.66 feet with the Northeast line of a dirt road and the Northeast line of said 135 acre tract to the place of beginning, containing 11.277 acres of land as surveyed by Leonard W. Frank, County Surveyor of Colorado County, Texas, and Registered Professional Land Surveyor, Registration No. 1669.


