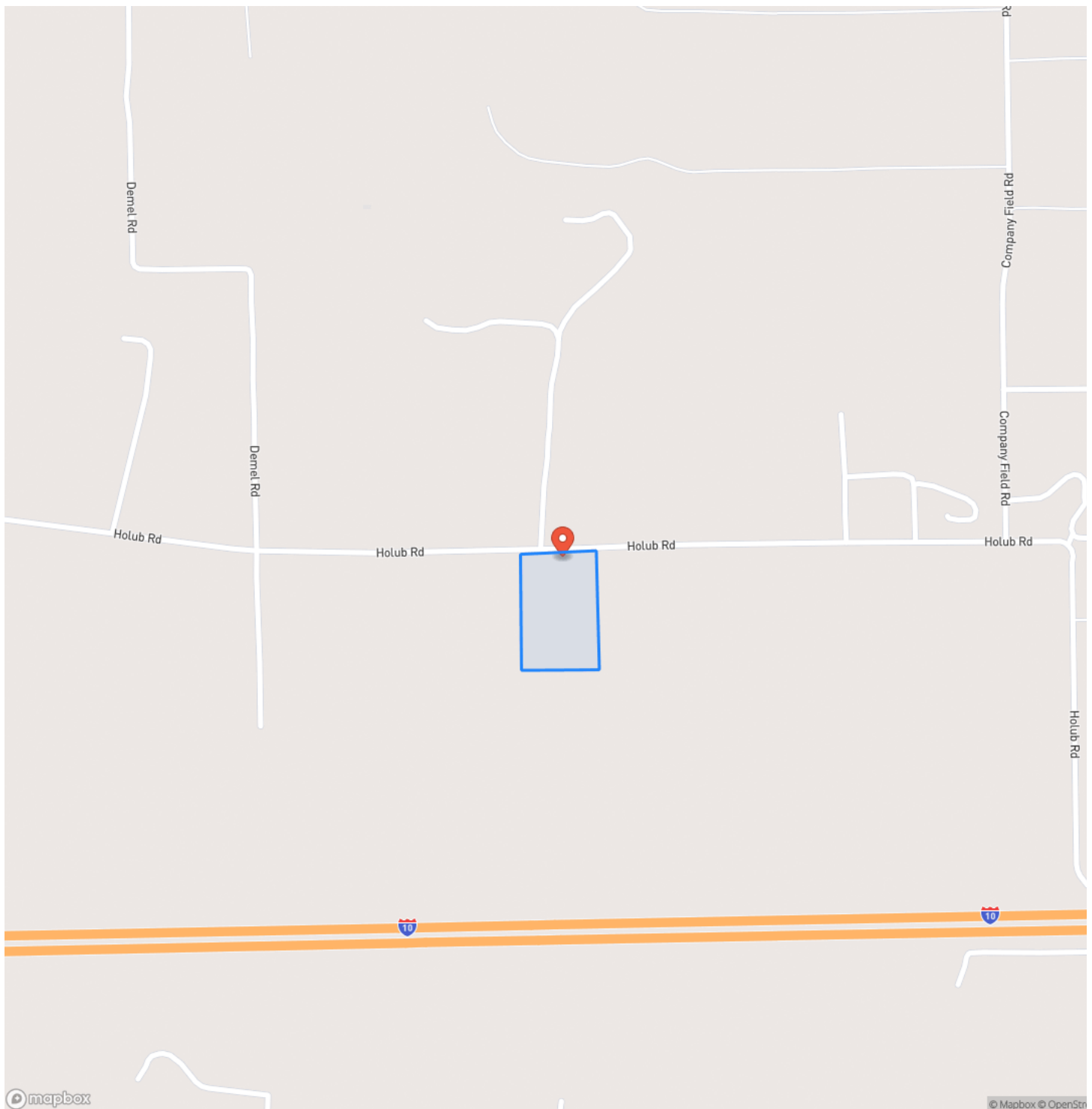

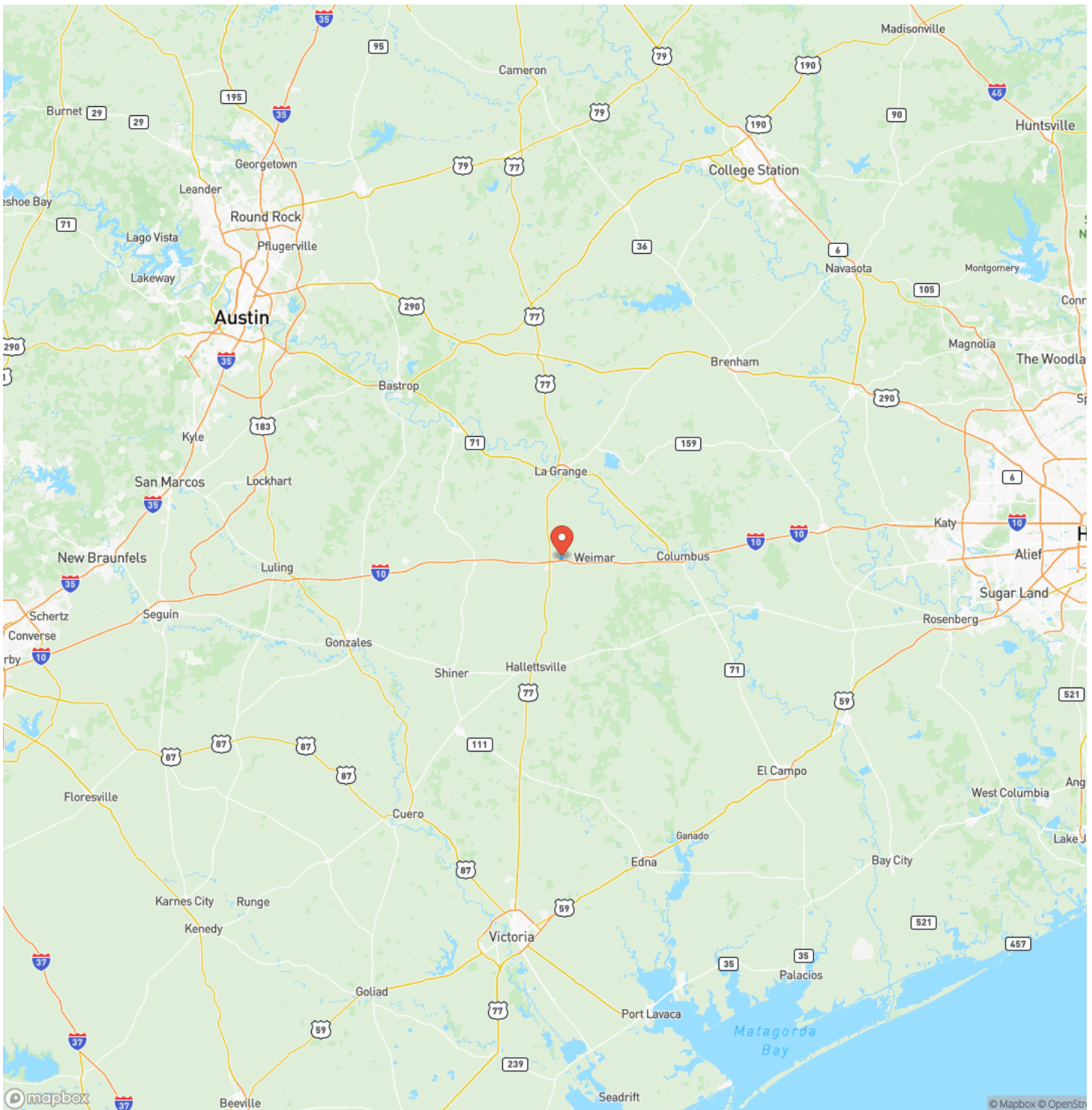


Locator Map

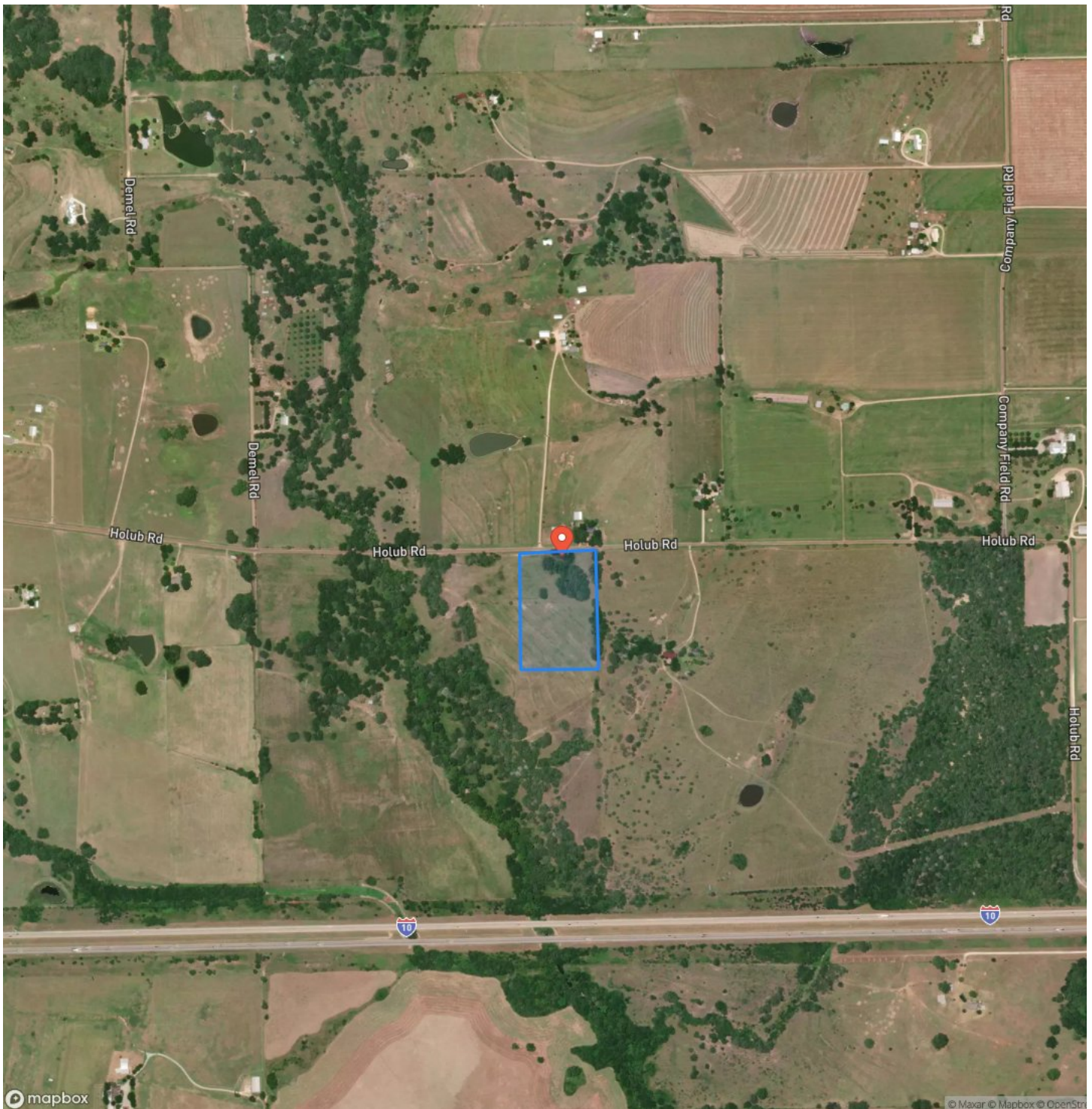
