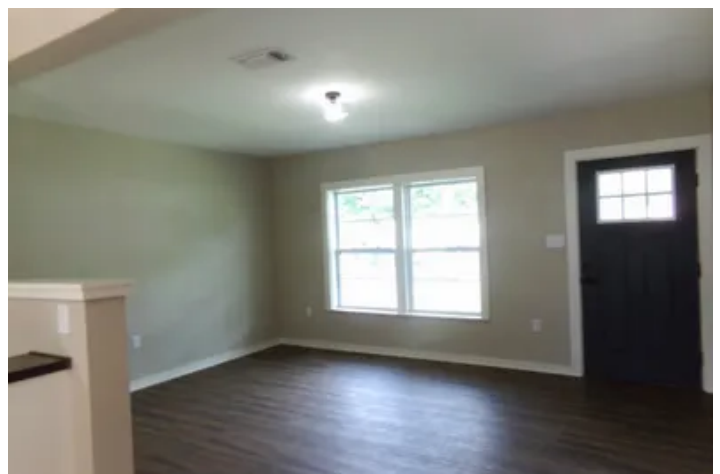

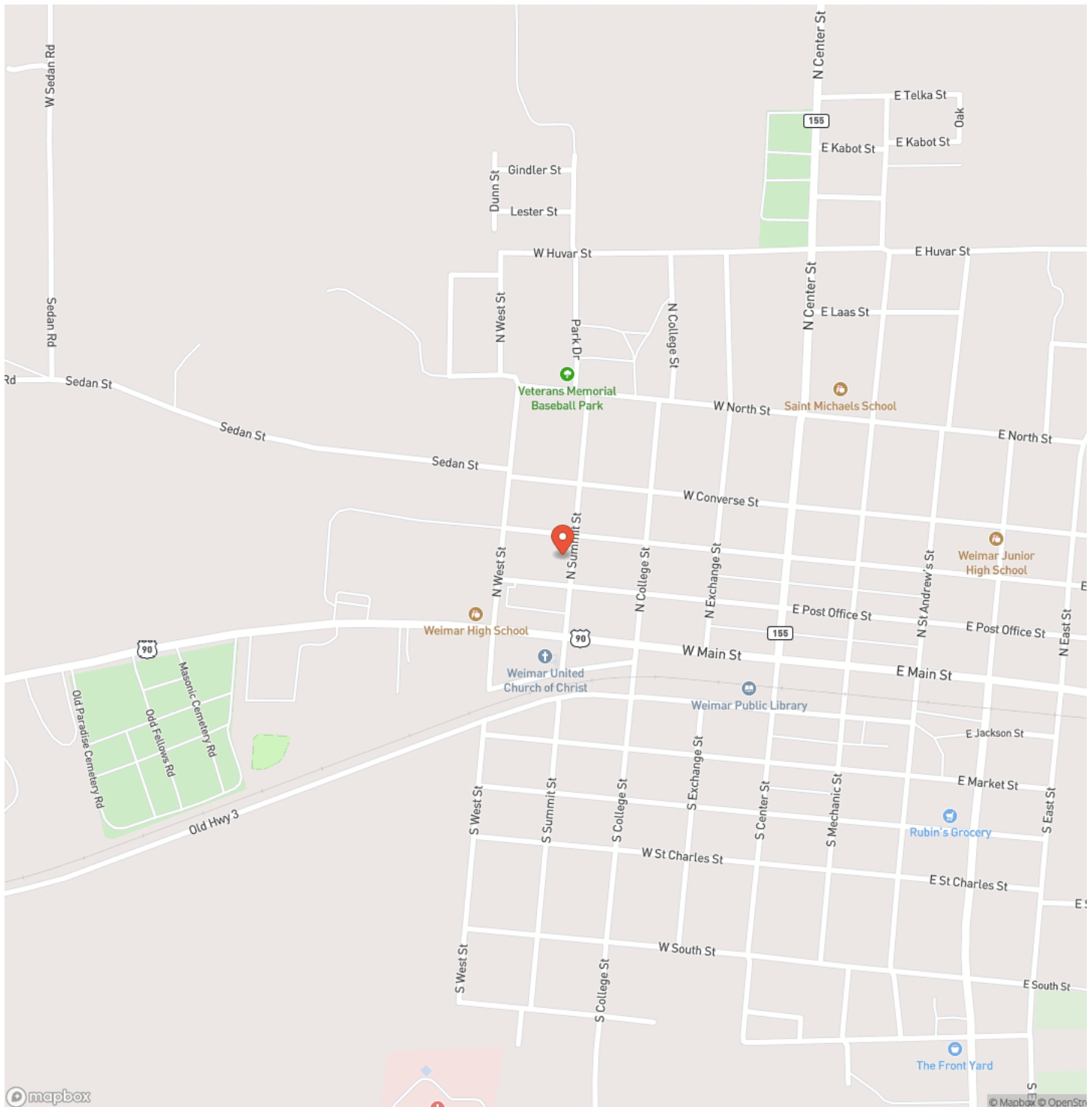

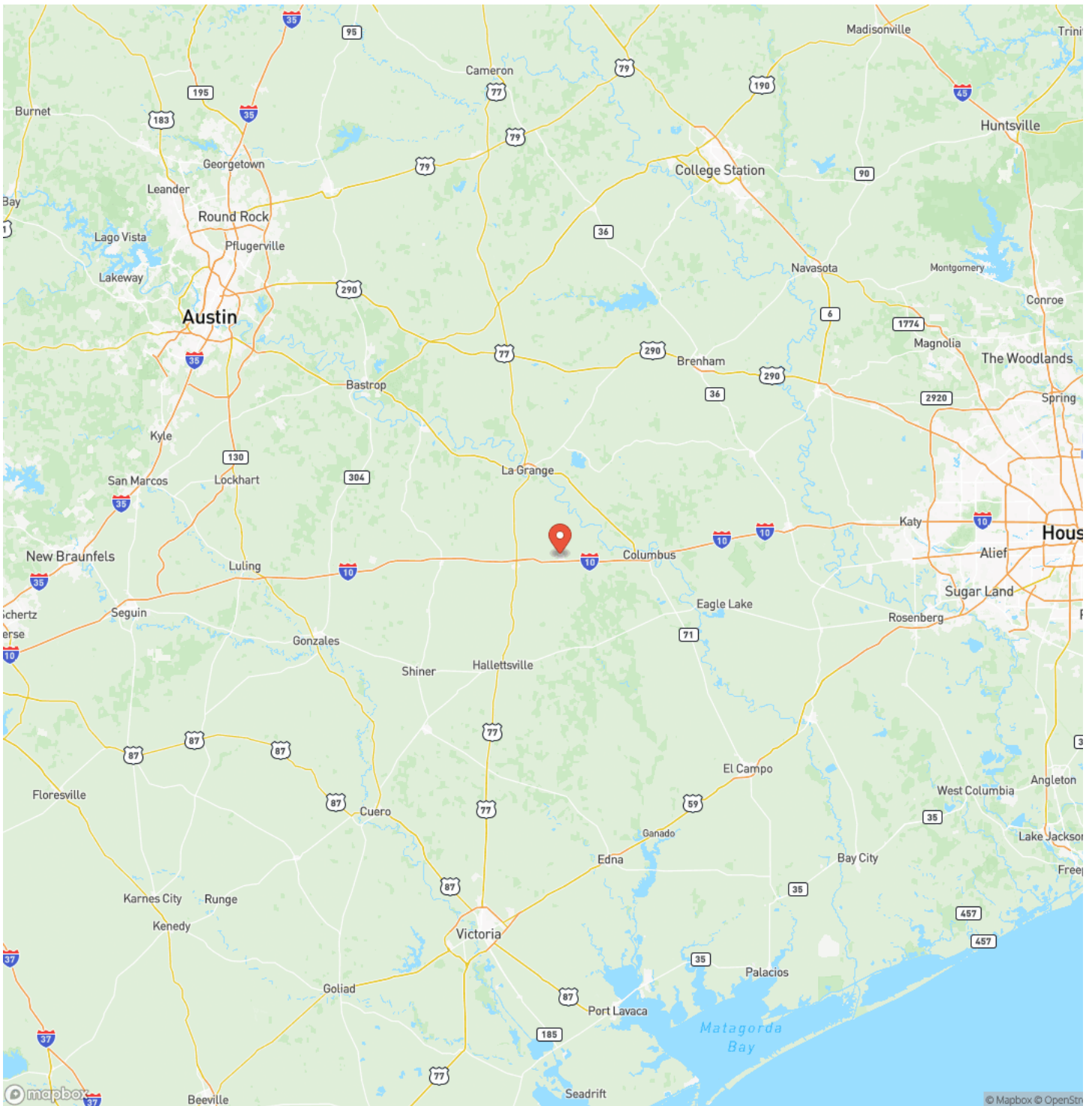


Locator Map

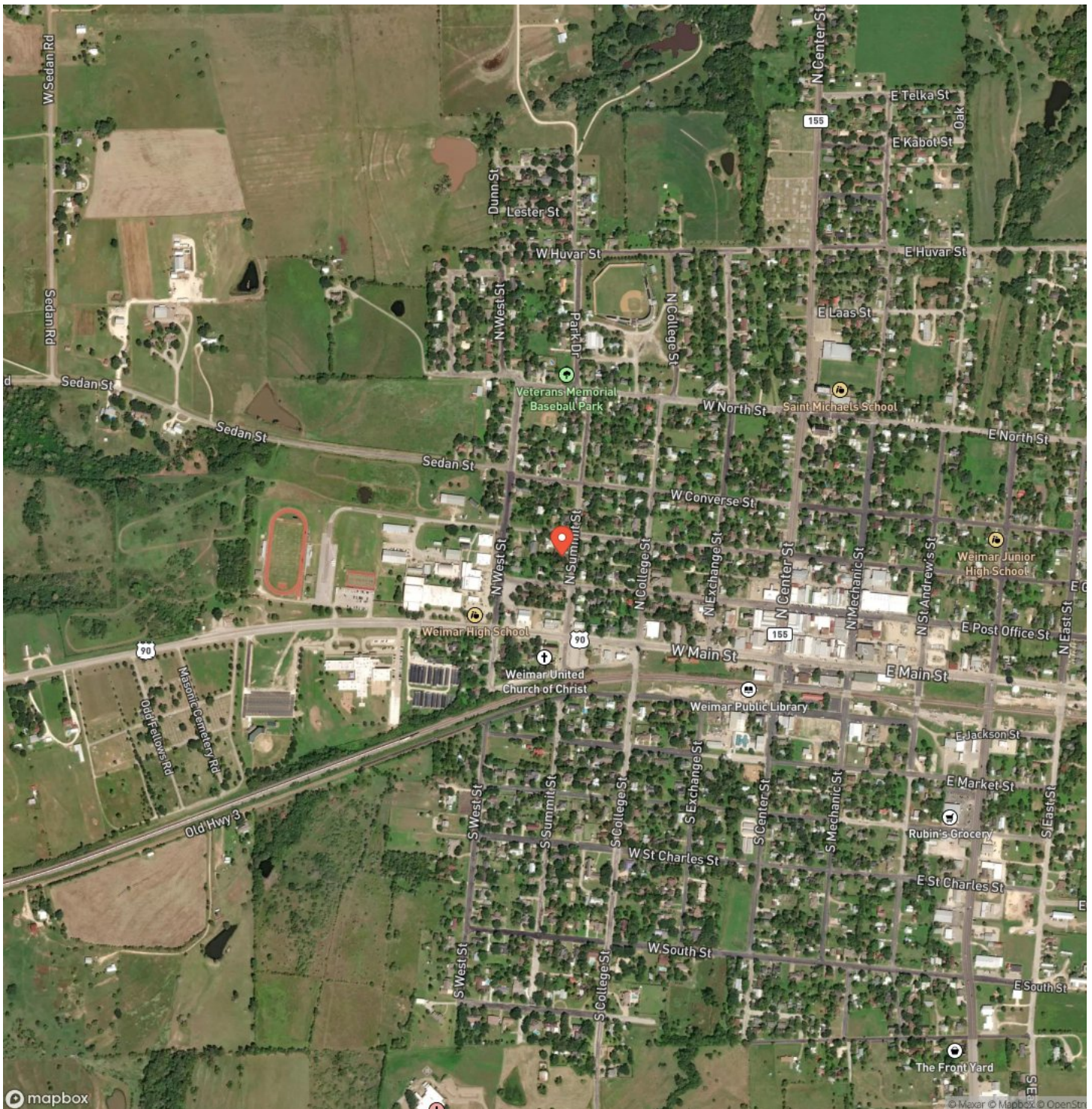
