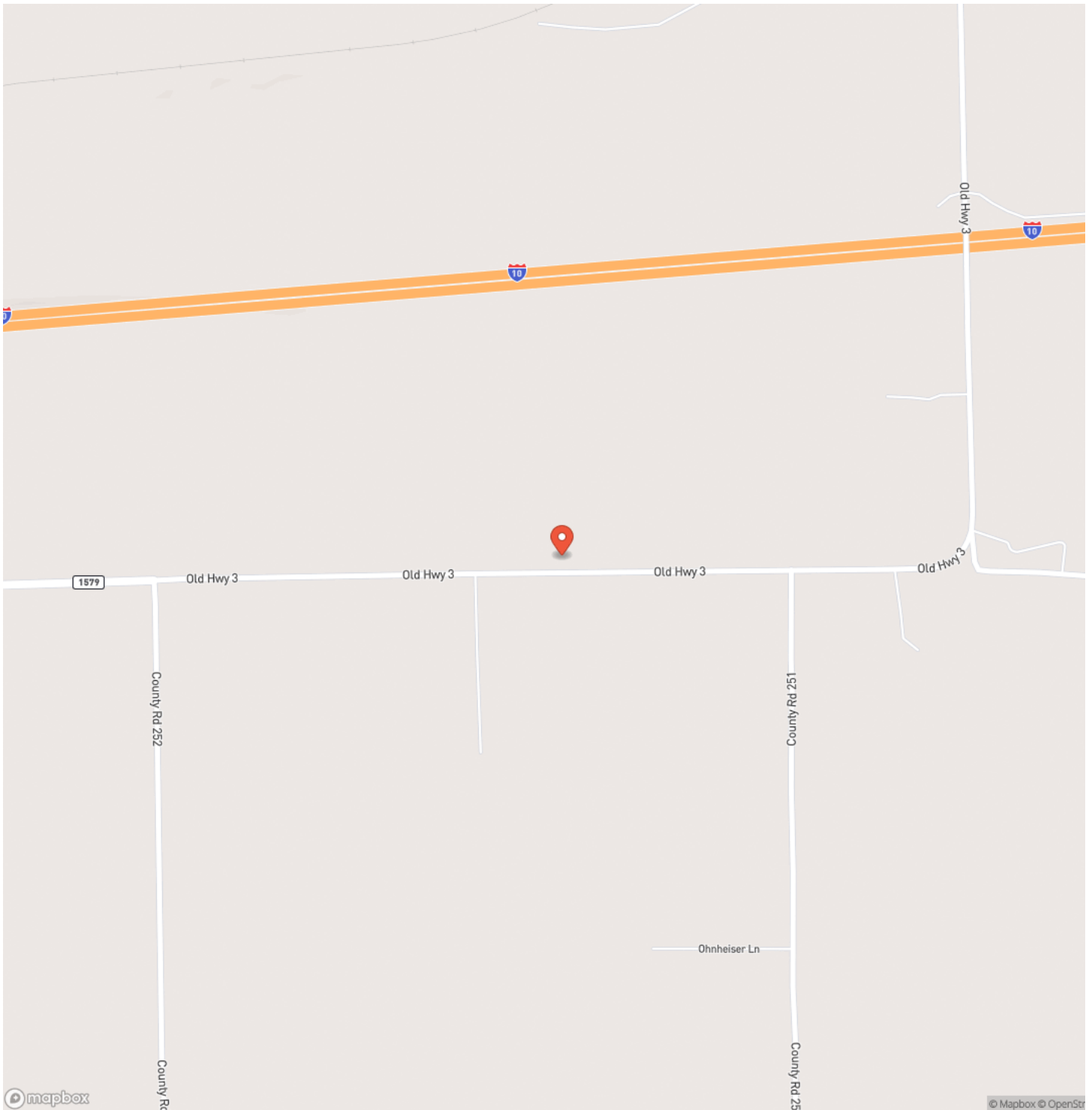

With approximately 1,950 feet of frontage along County Road 253, the property provides easy access and flexibility. No pipelines. New survey in progress.

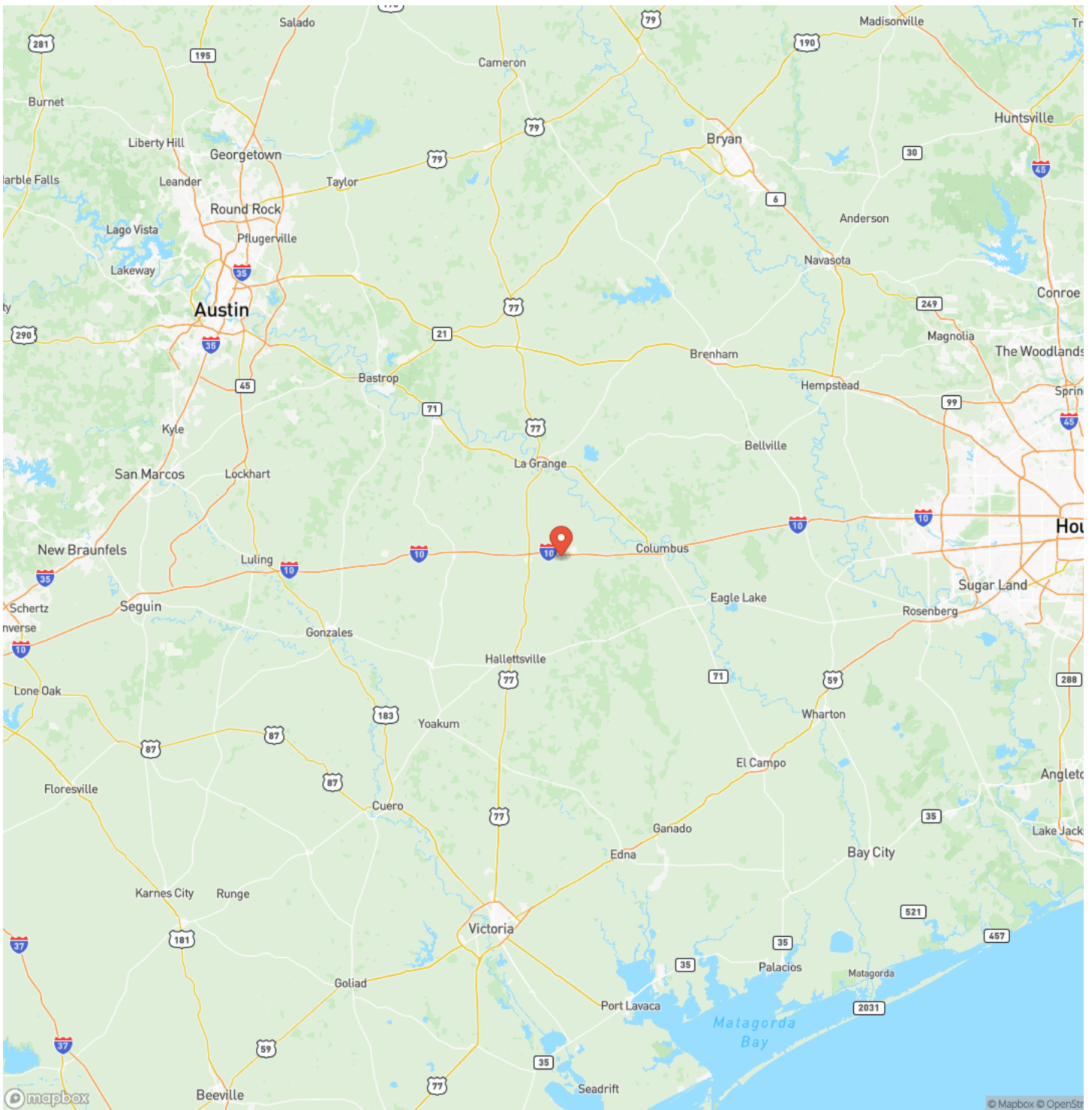

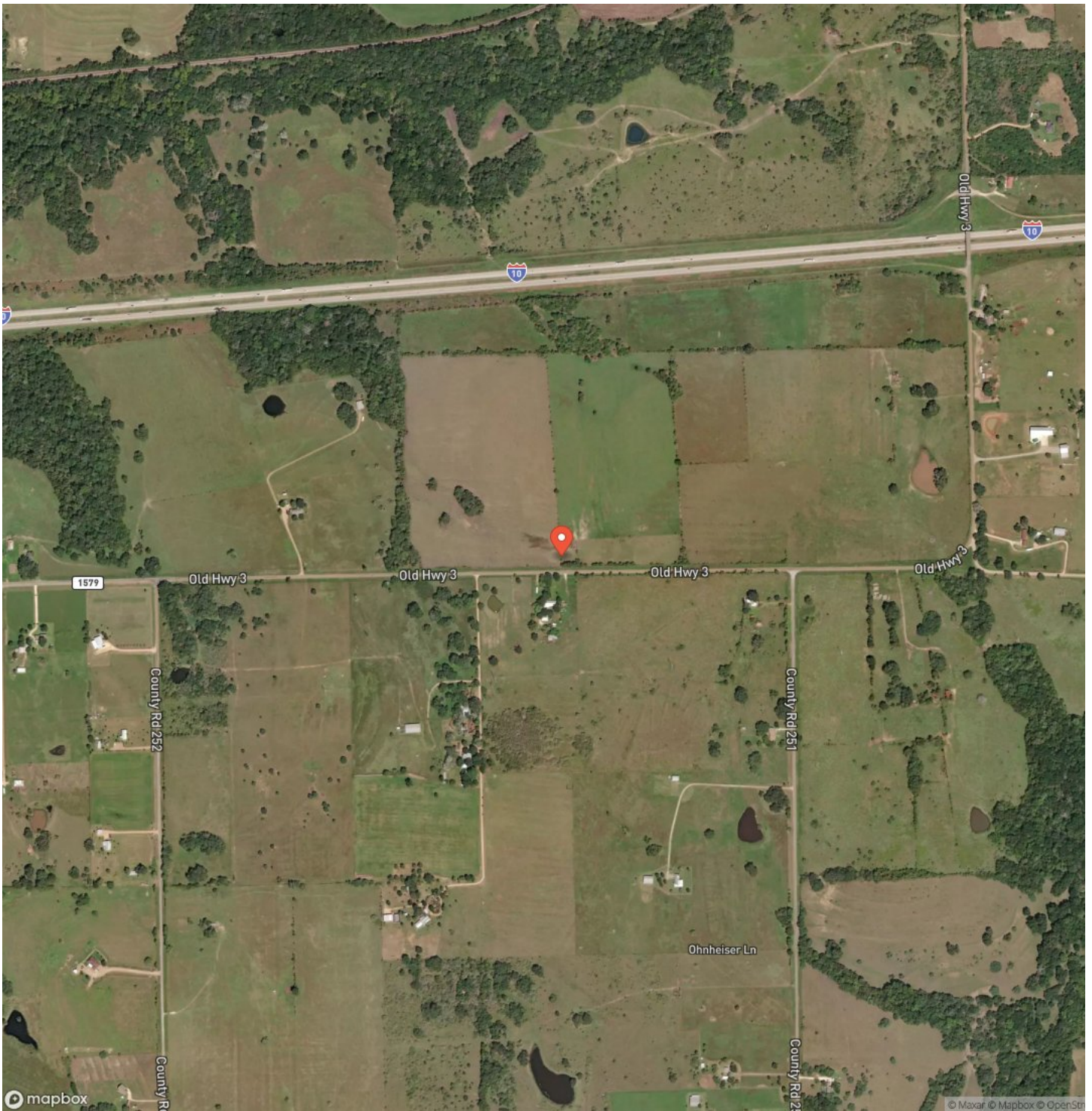
Locator Map
