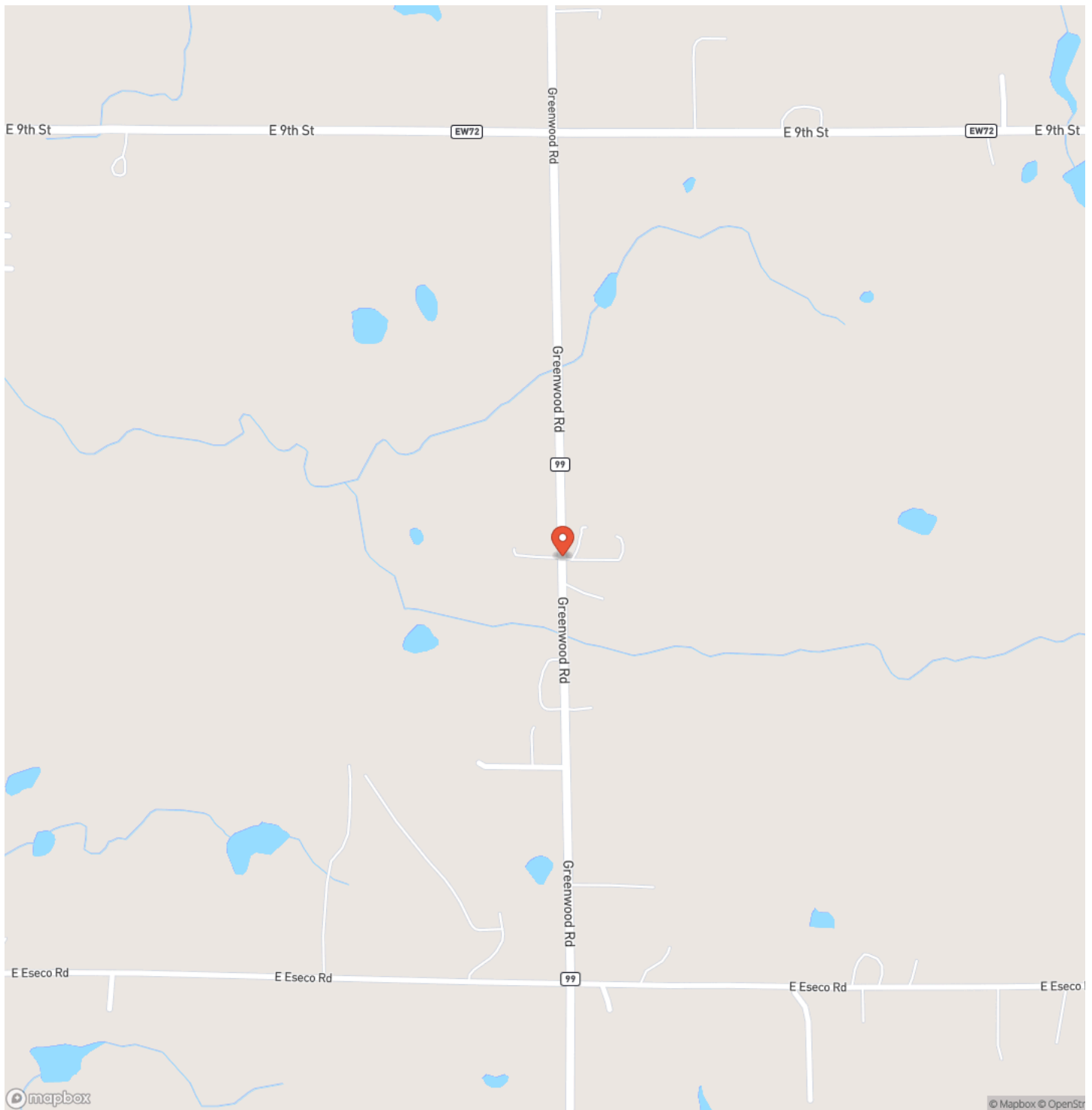

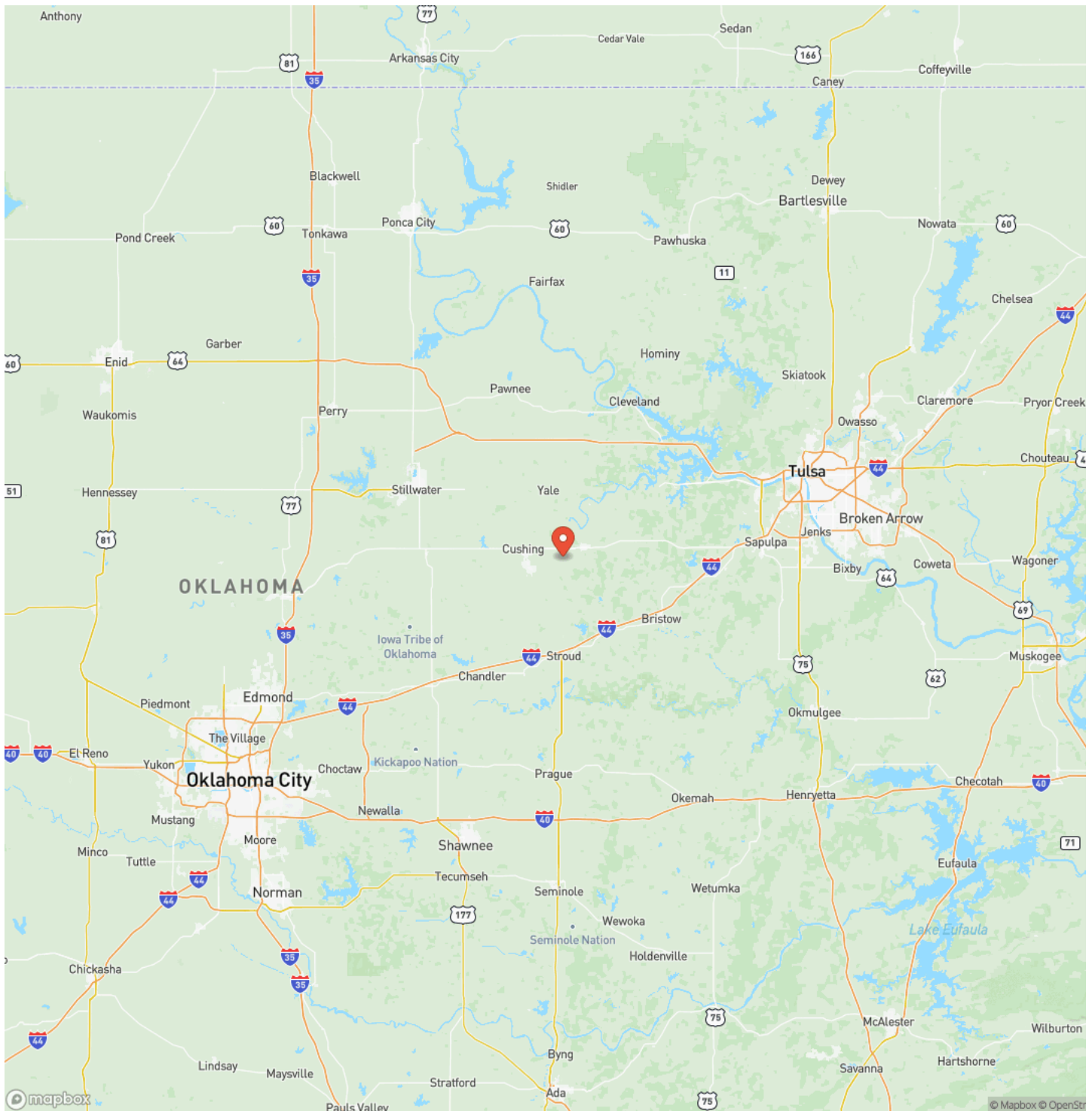
## Locator Map





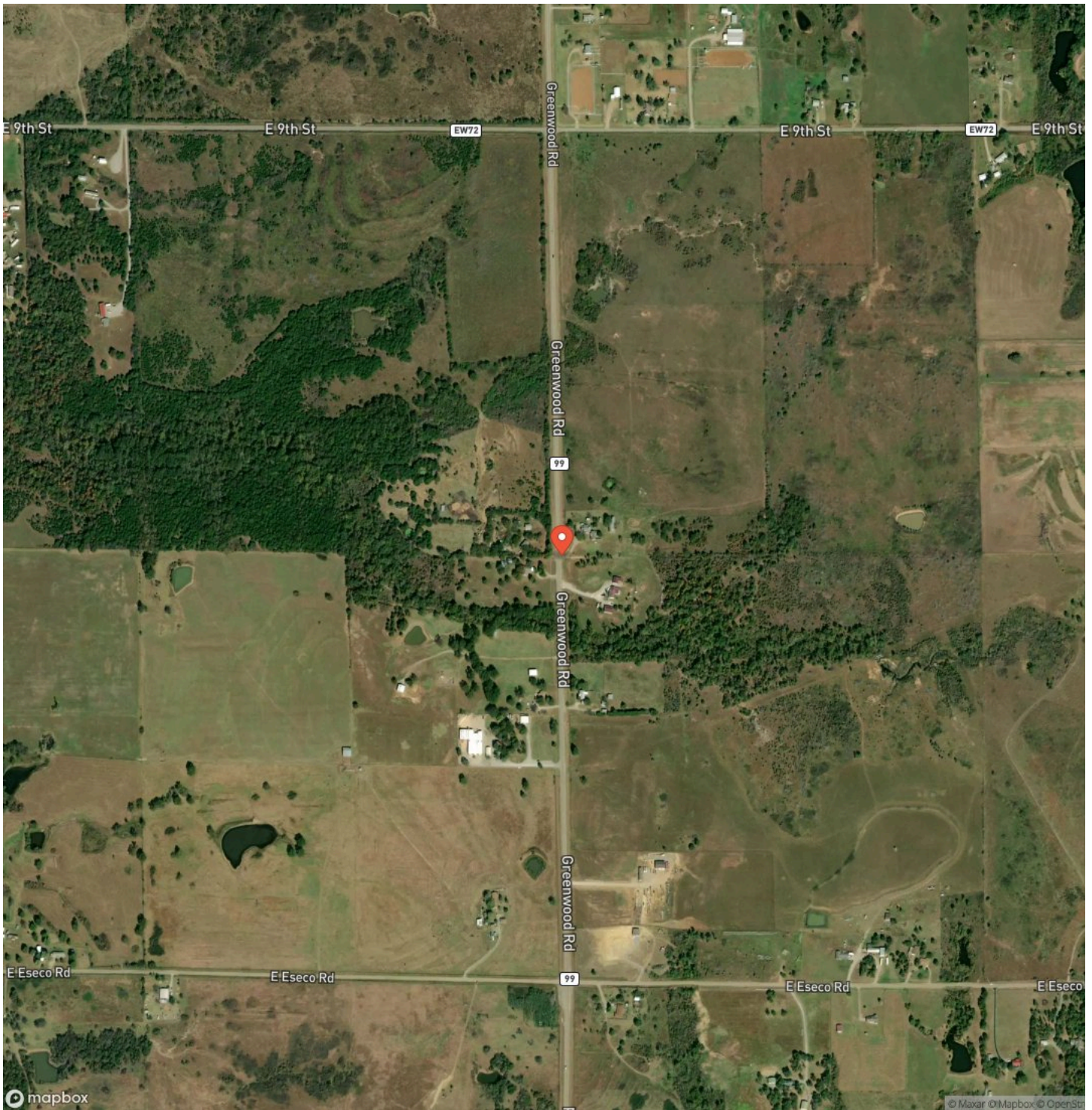
