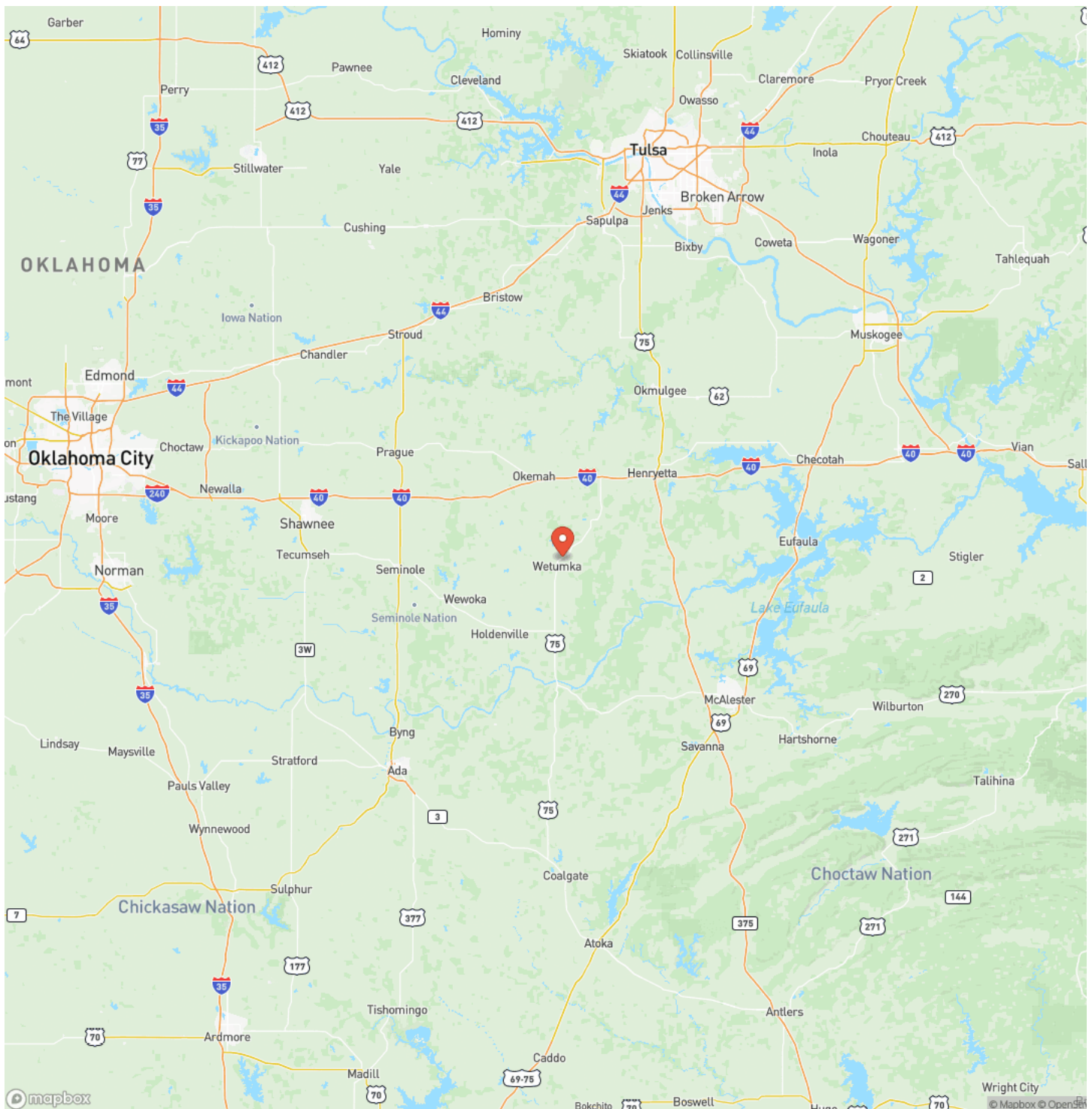

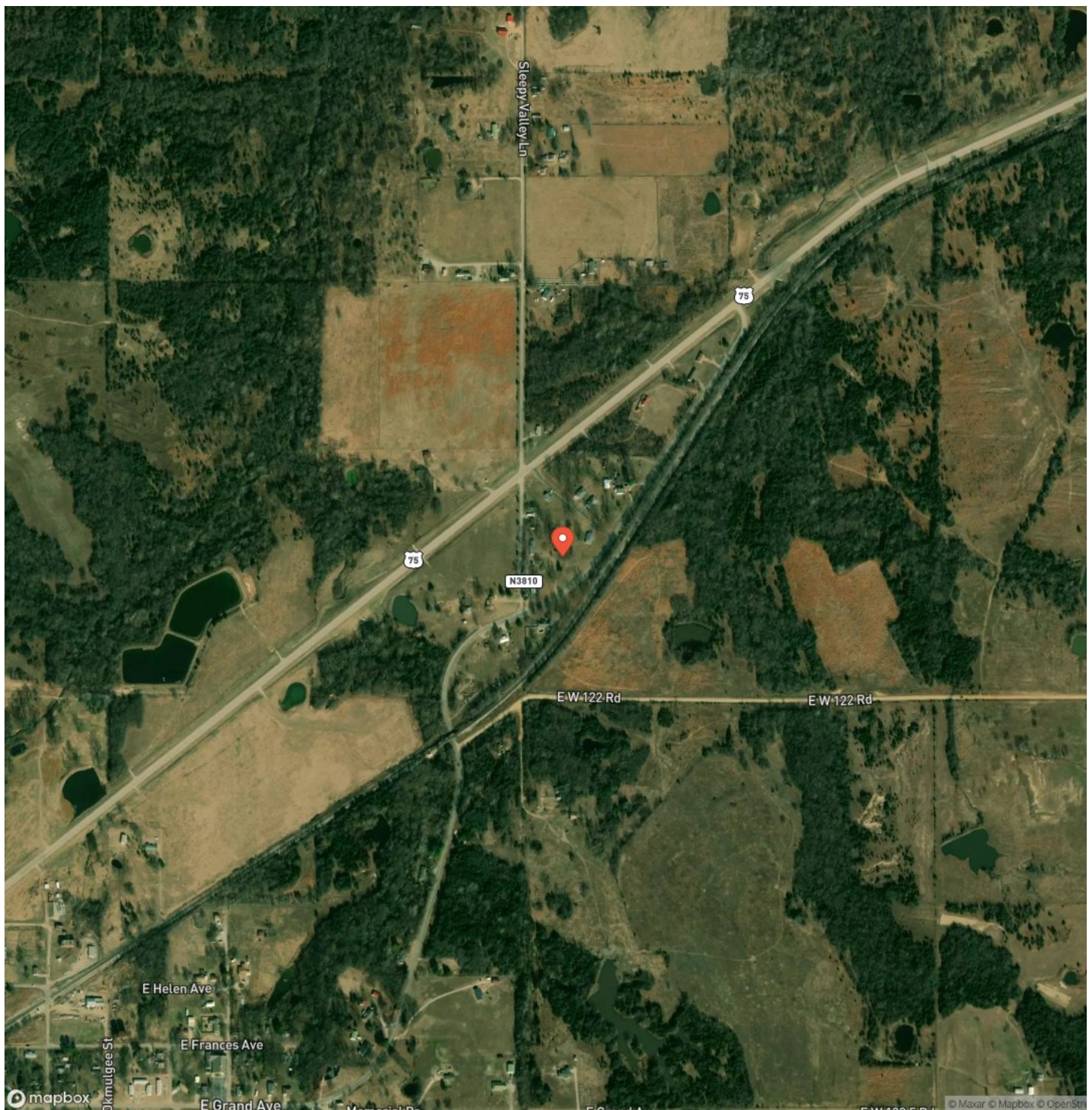
Locator Map

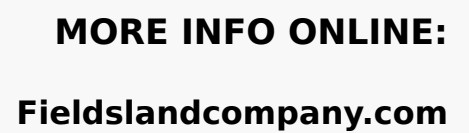
