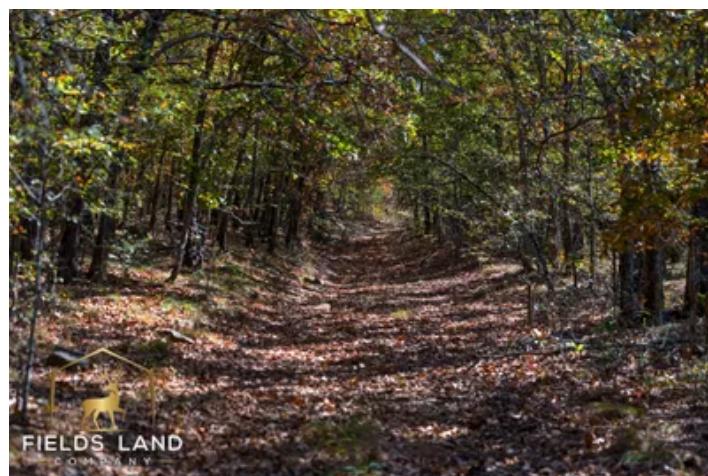

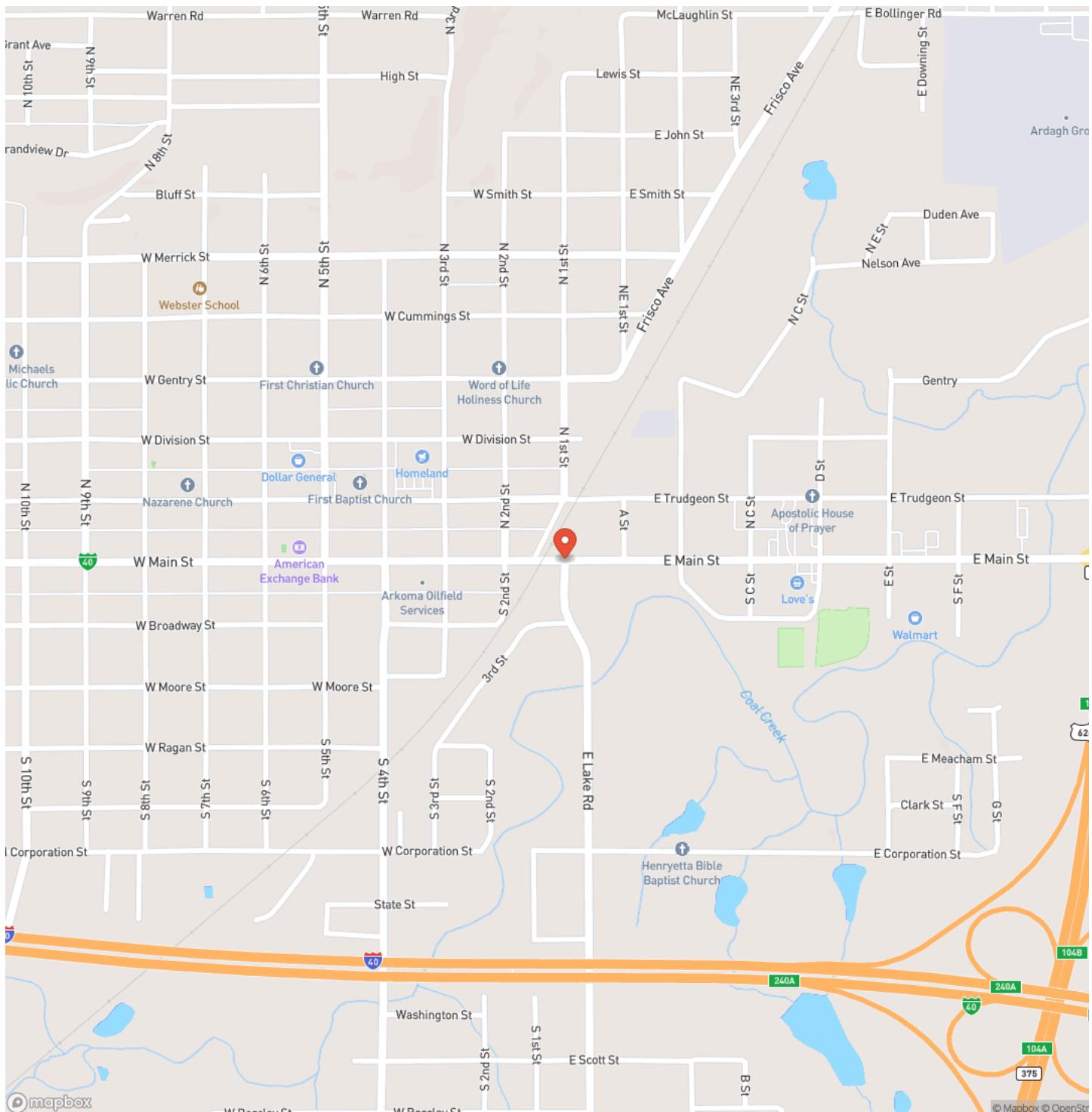

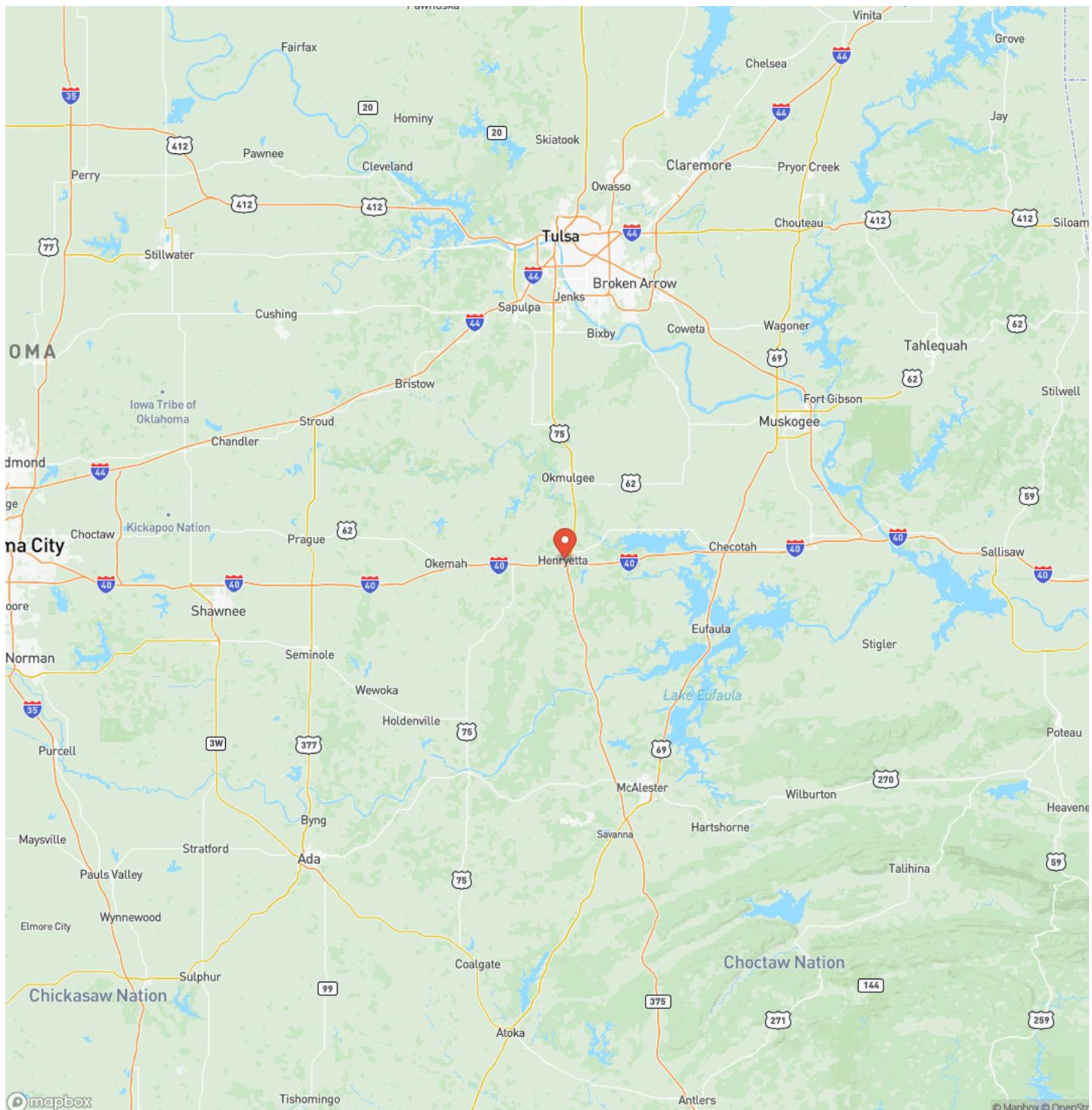
Locator Map

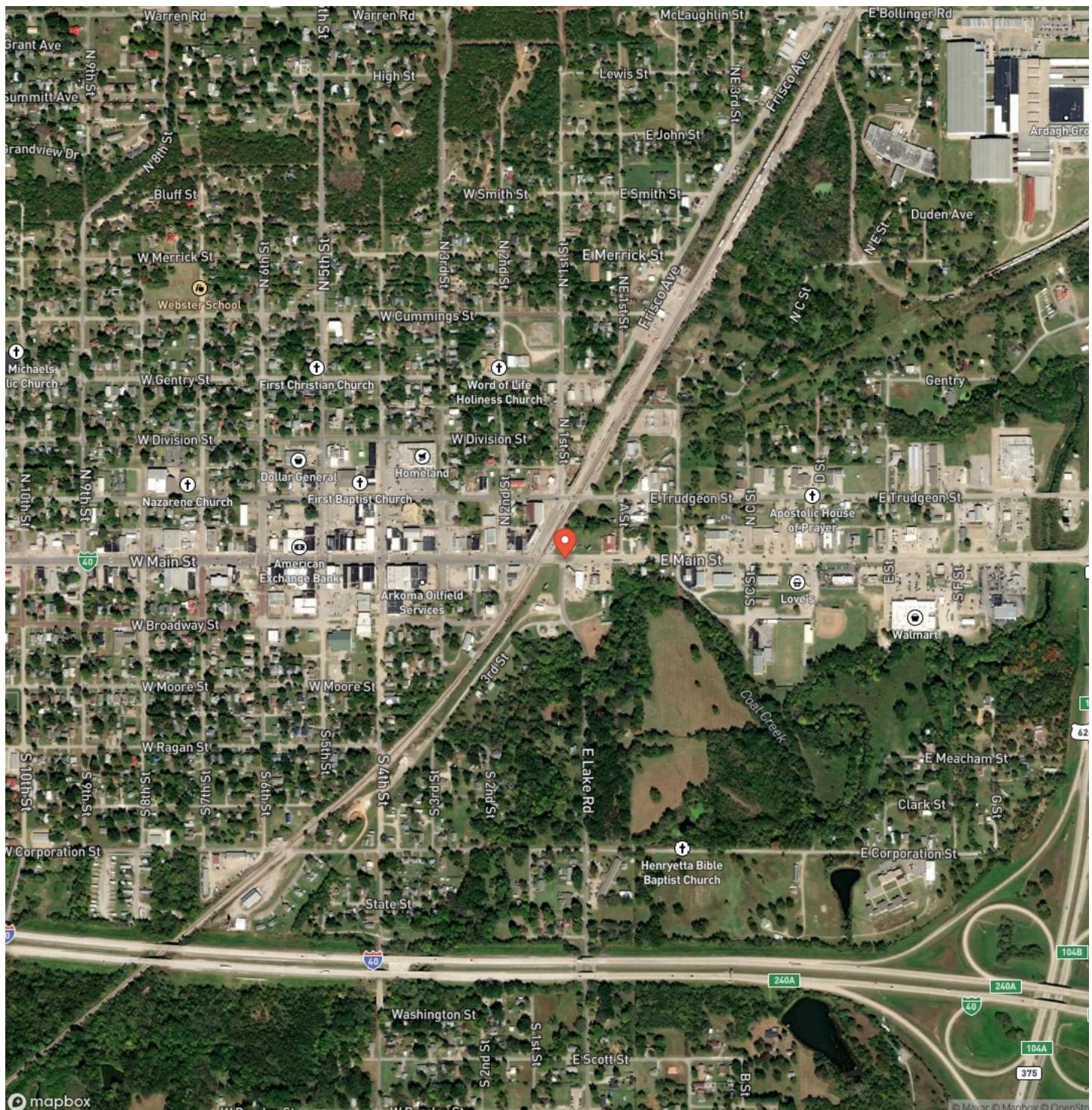
Locator Map
