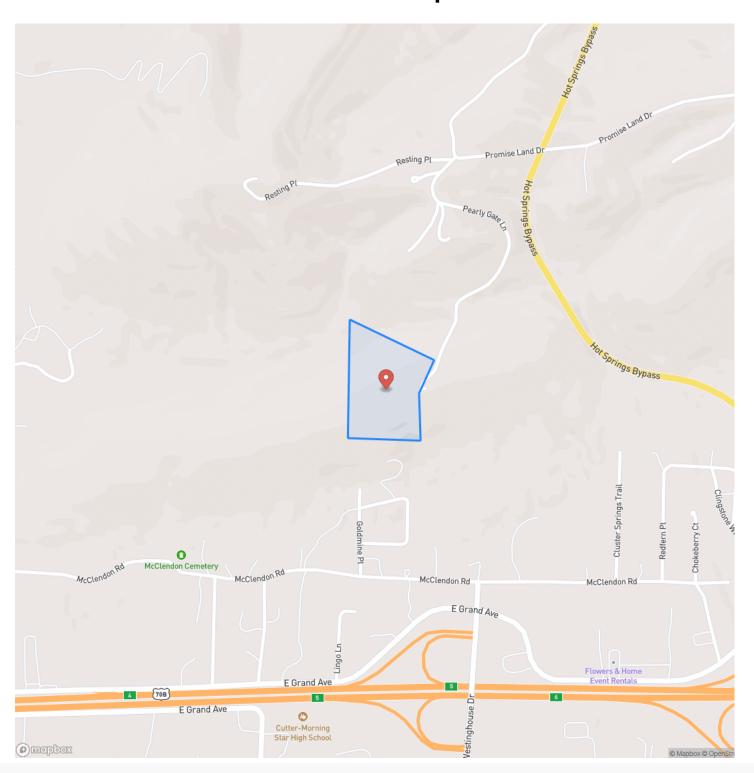

All these activities plus the opportunity to have your own beautiful forested hideaway could make this the perfect place to build your Arkansas Cabin.

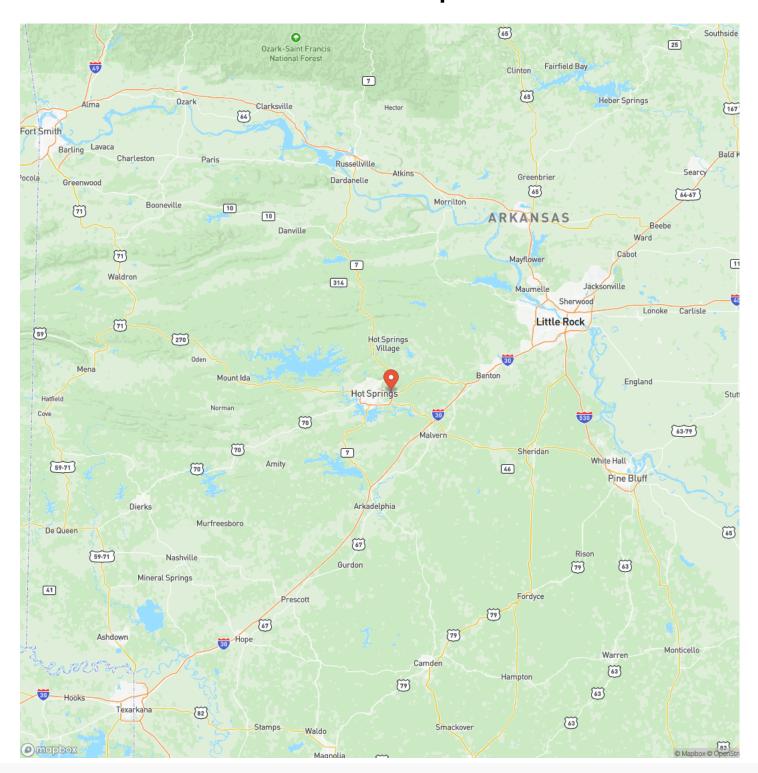


Locator Map
