The creek bottom creates a well-defined travel corridor that funnels wildlife through the property, providing excellent hunting opportunities whether you are wanting to chase whitetails in the fall or turkeys in the spring. The combination of cover along the creek, nearby water influence, and an established food source, create an ideal environment to consistently attract and hold mature bucks, and all other wildlife native to the area. The layout offers multiple stand locations and natural pinch points, allowing hunters to take advantage of prevailing winds and predictable movement. With surrounding habitat and agricultural fields in the area, this property has all the ingredients needed to provide top end hunting year after year. In addition to its recreational appeal, the farm is currently planted in wheat and offers productive tillable ground. The soil and layout are well-suited for continued farming operations, providing a reliable income source to complement the hunting opportunities. Access is another standout feature, with gravel road frontage providing easy access and dependable, year-round use! The farm is located 15+/- minutes from Hennessey, 45+/- minutes from Stillwater, and 1 hour and 10+/- minutes from Oklahoma City. All showings are by appointment only. 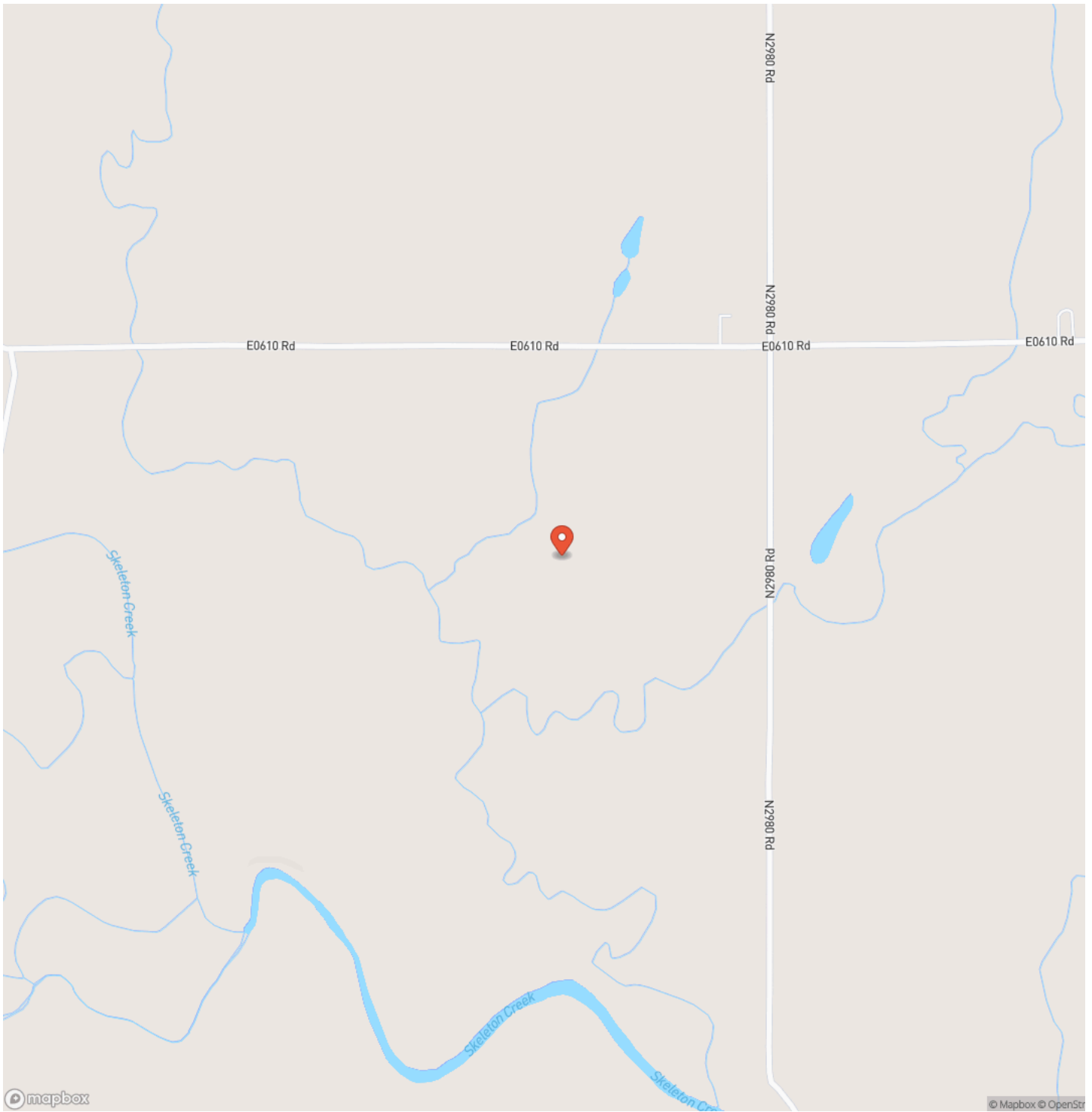

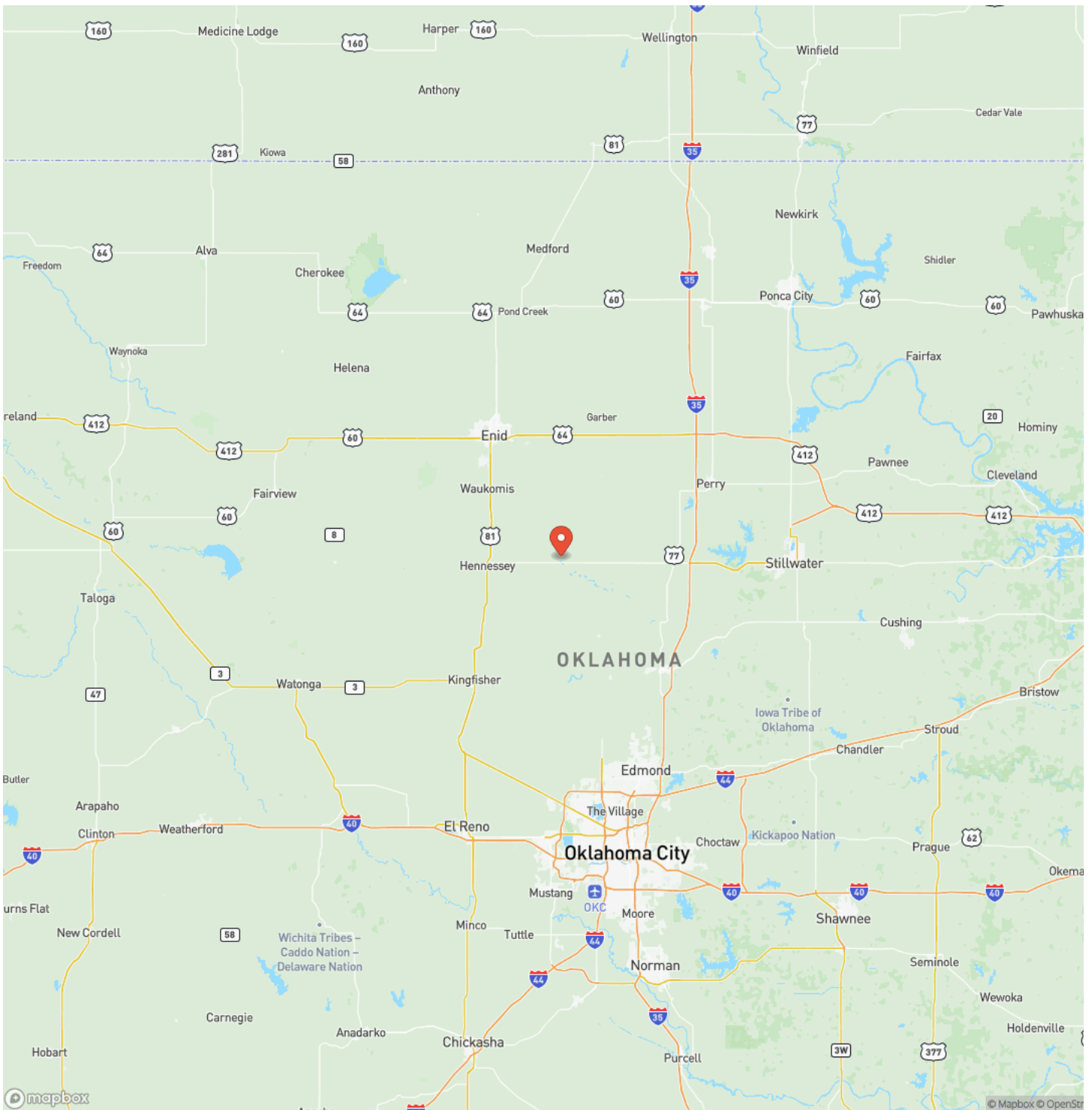
