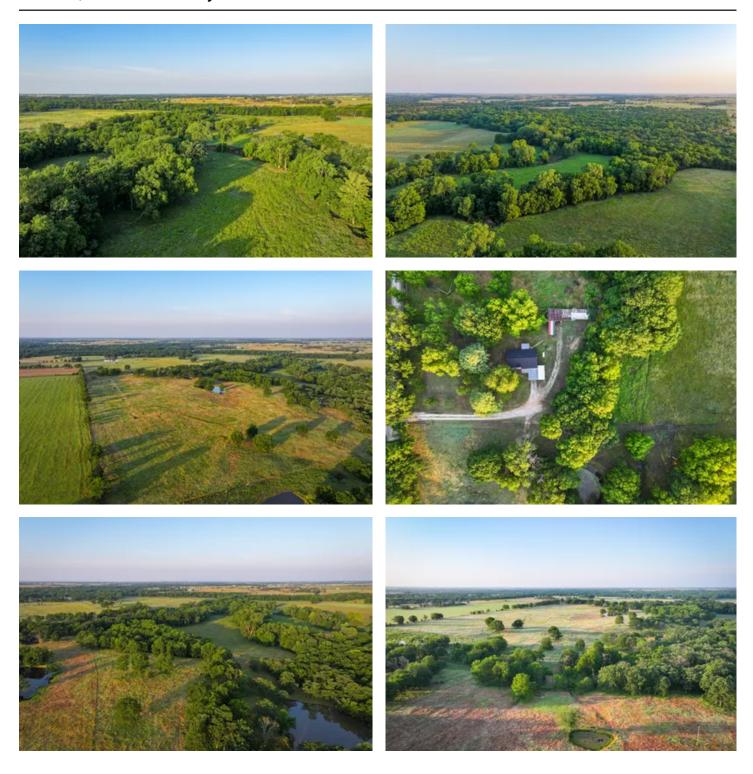

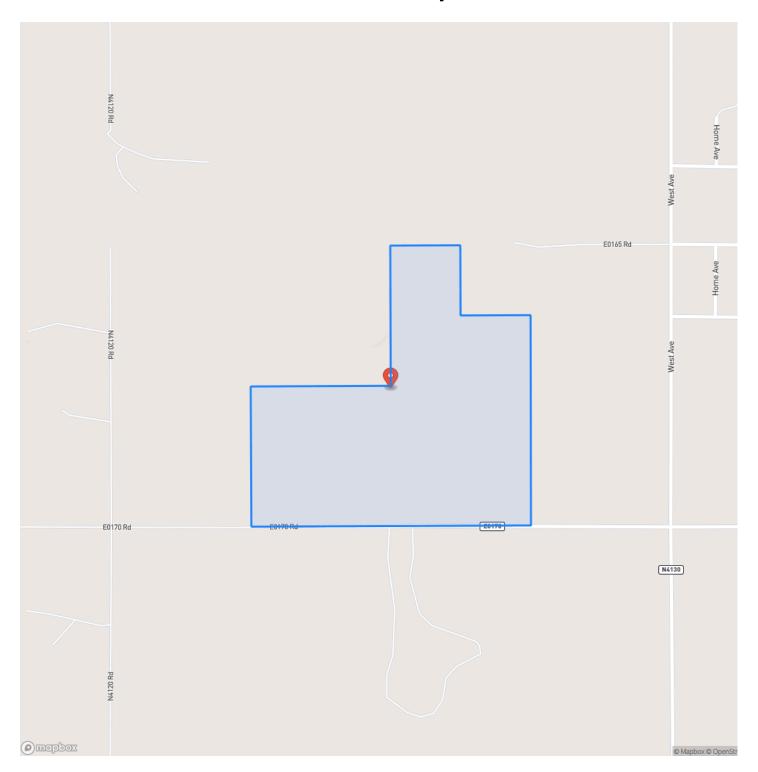

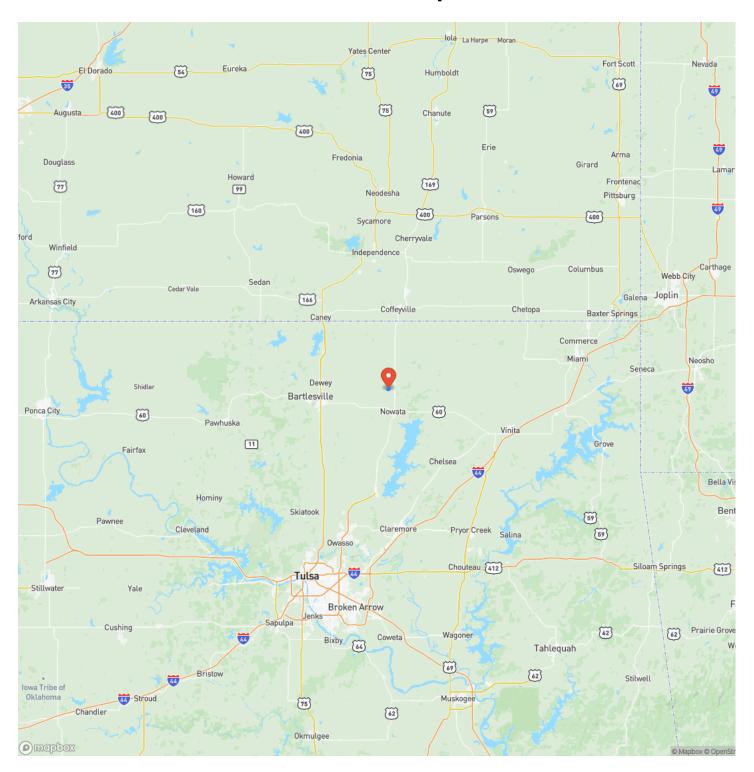


Locator Map



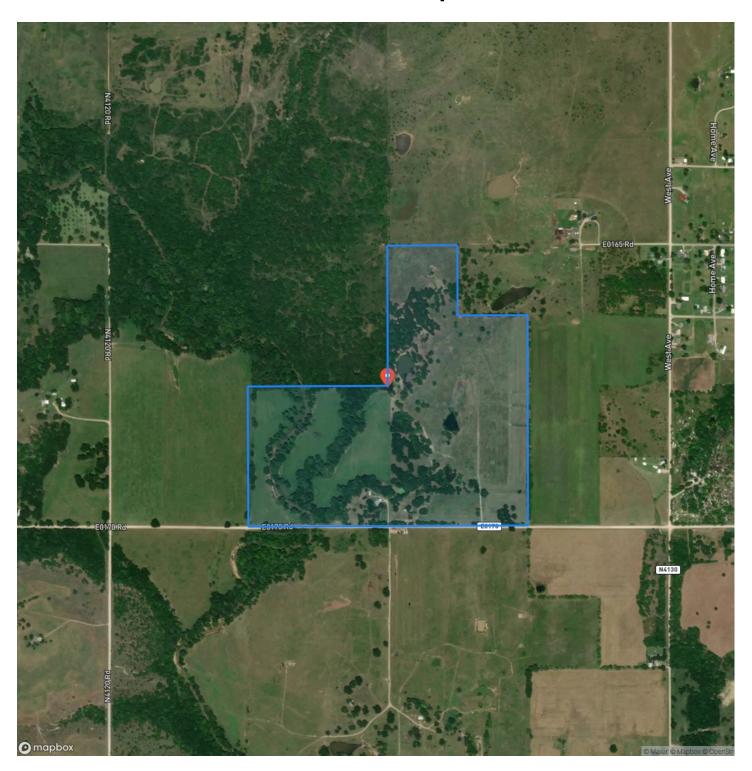


Locator Map
