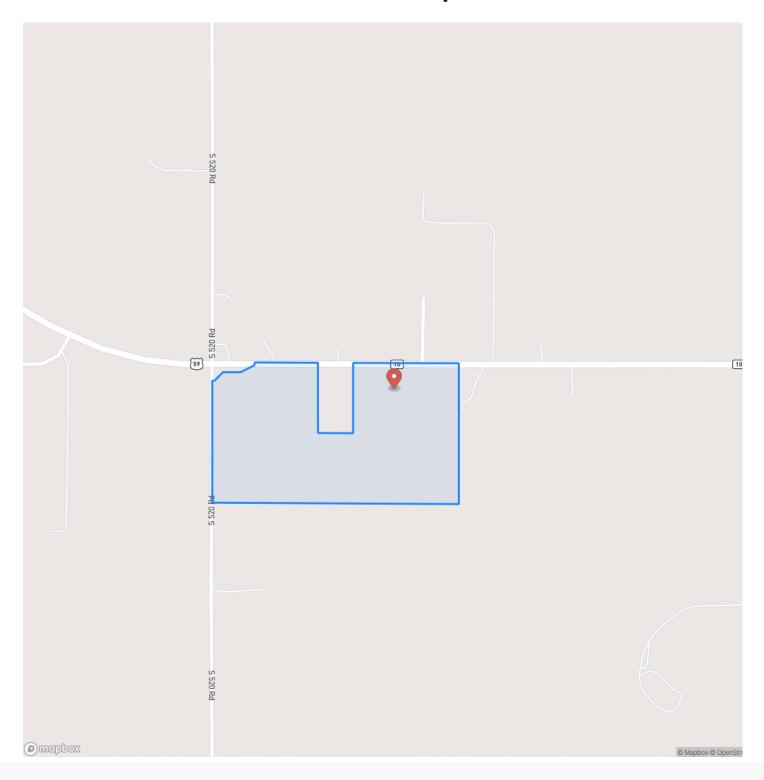






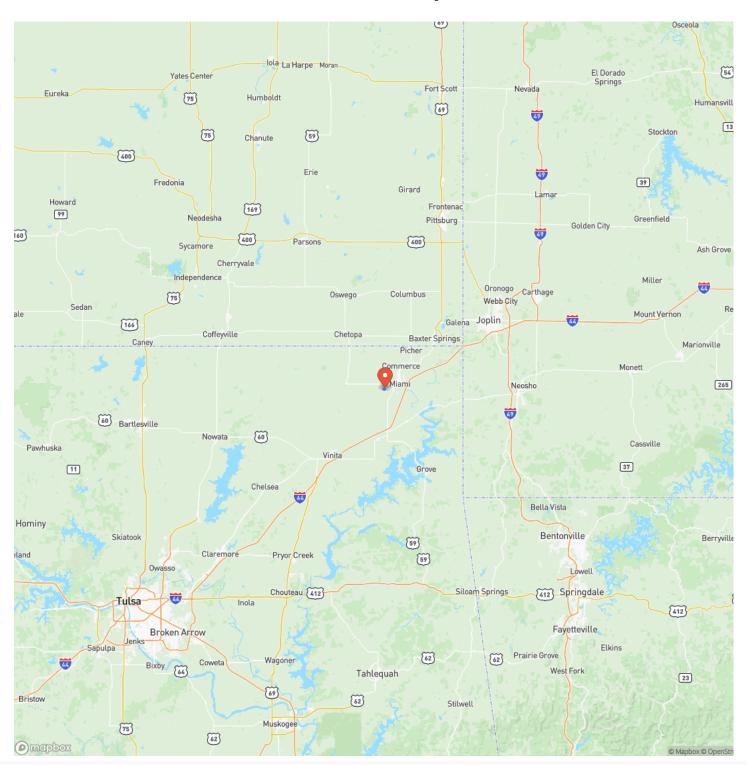


Locator Map
