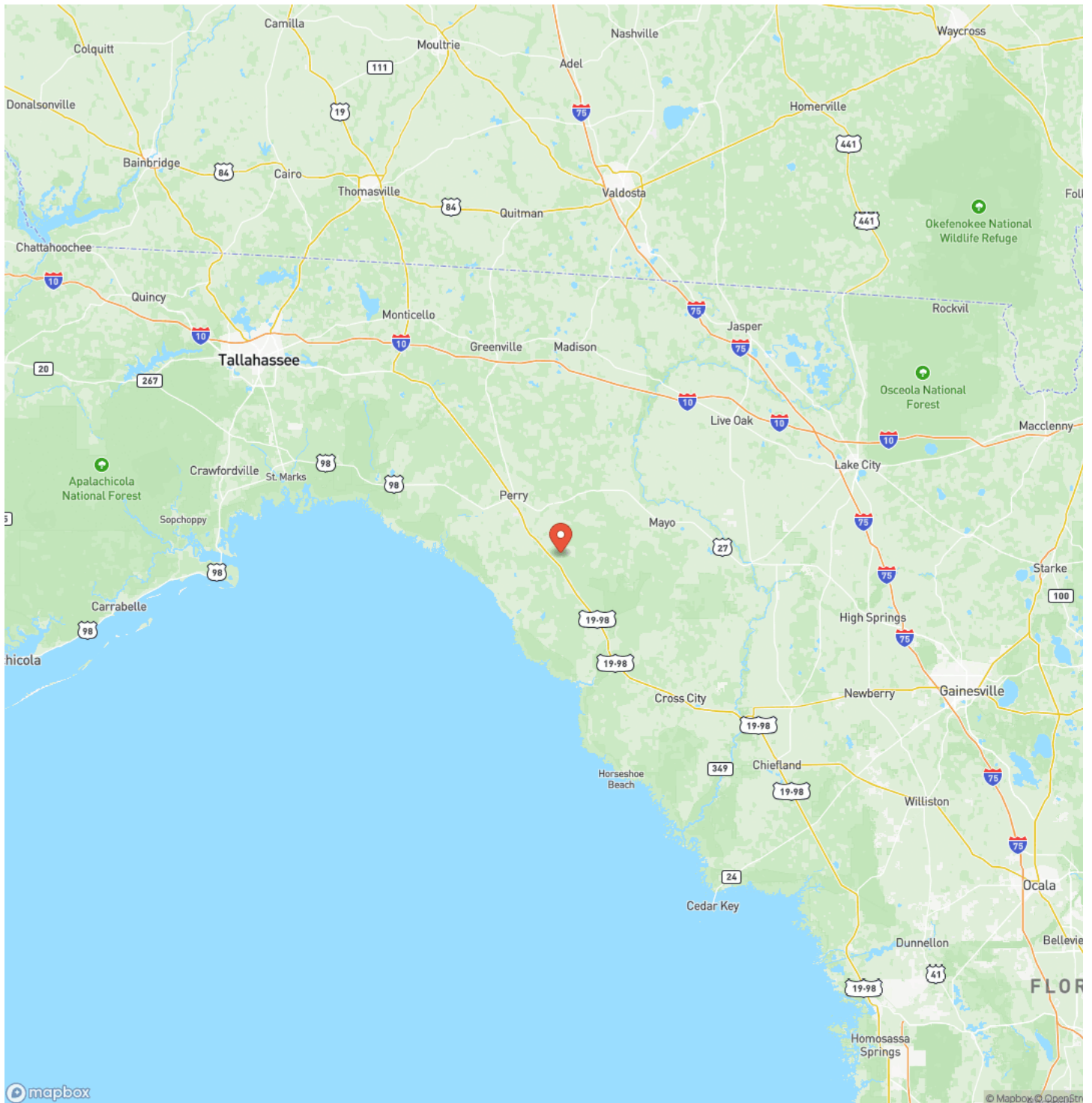

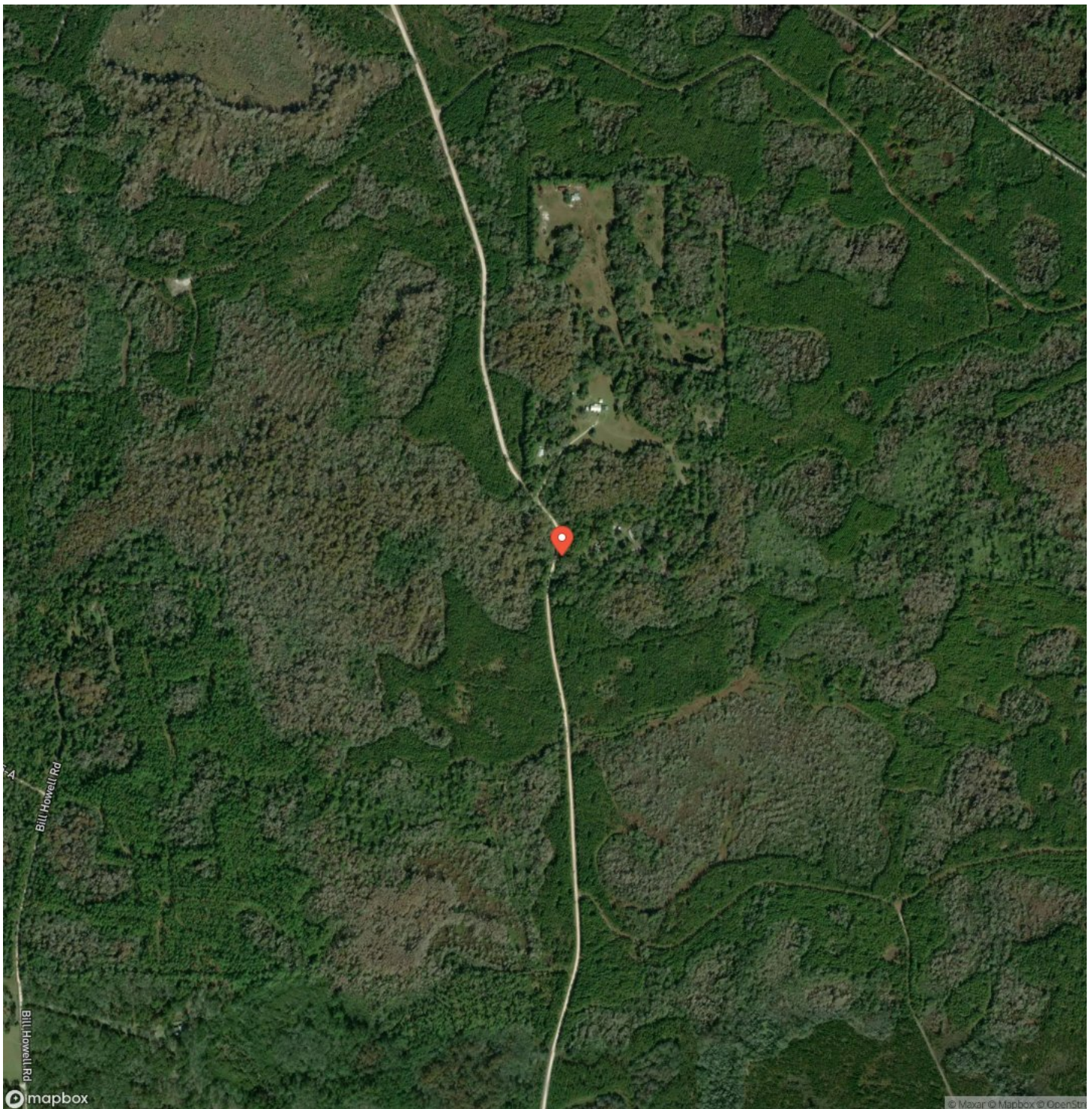
Locator Map
