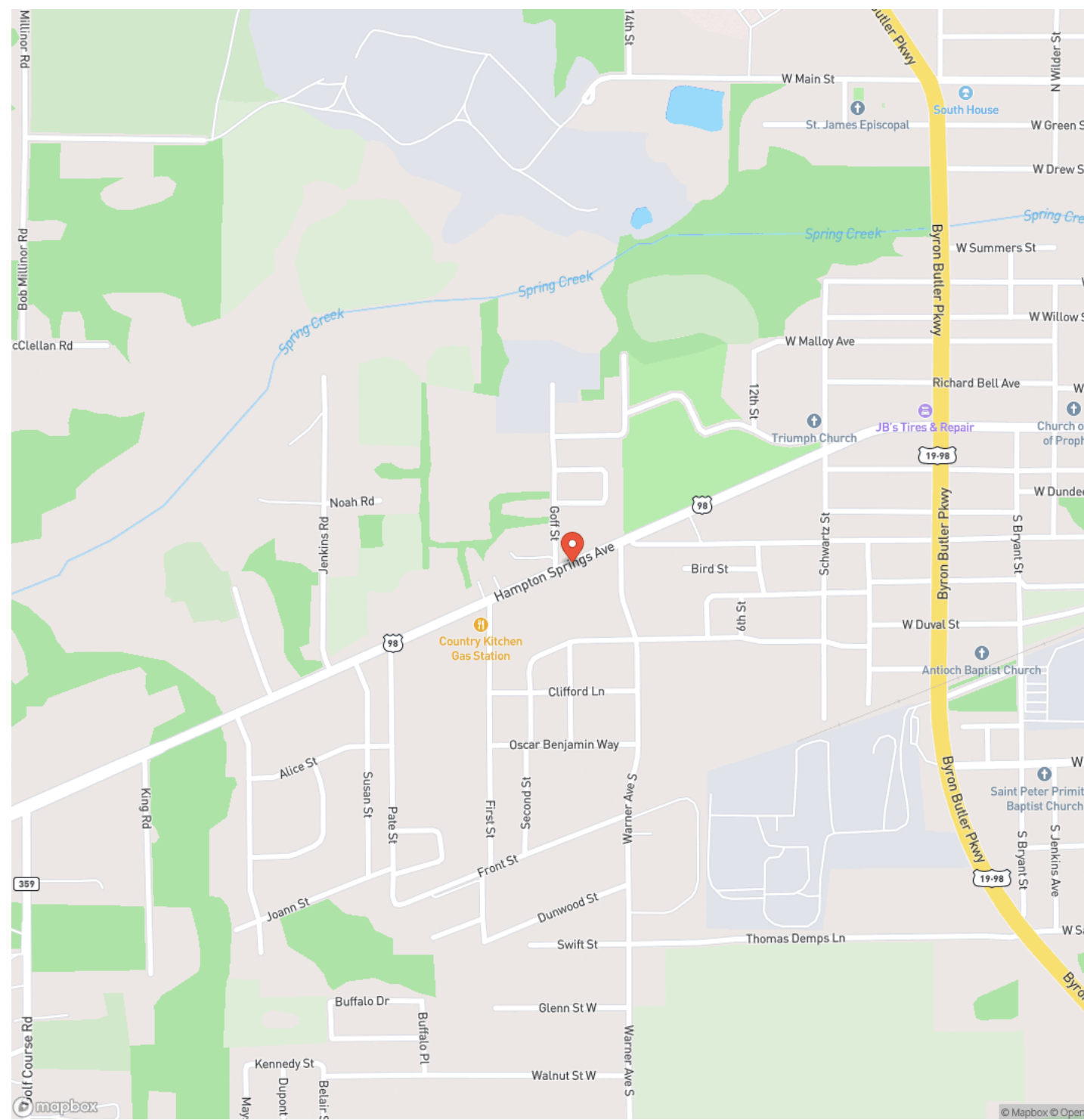

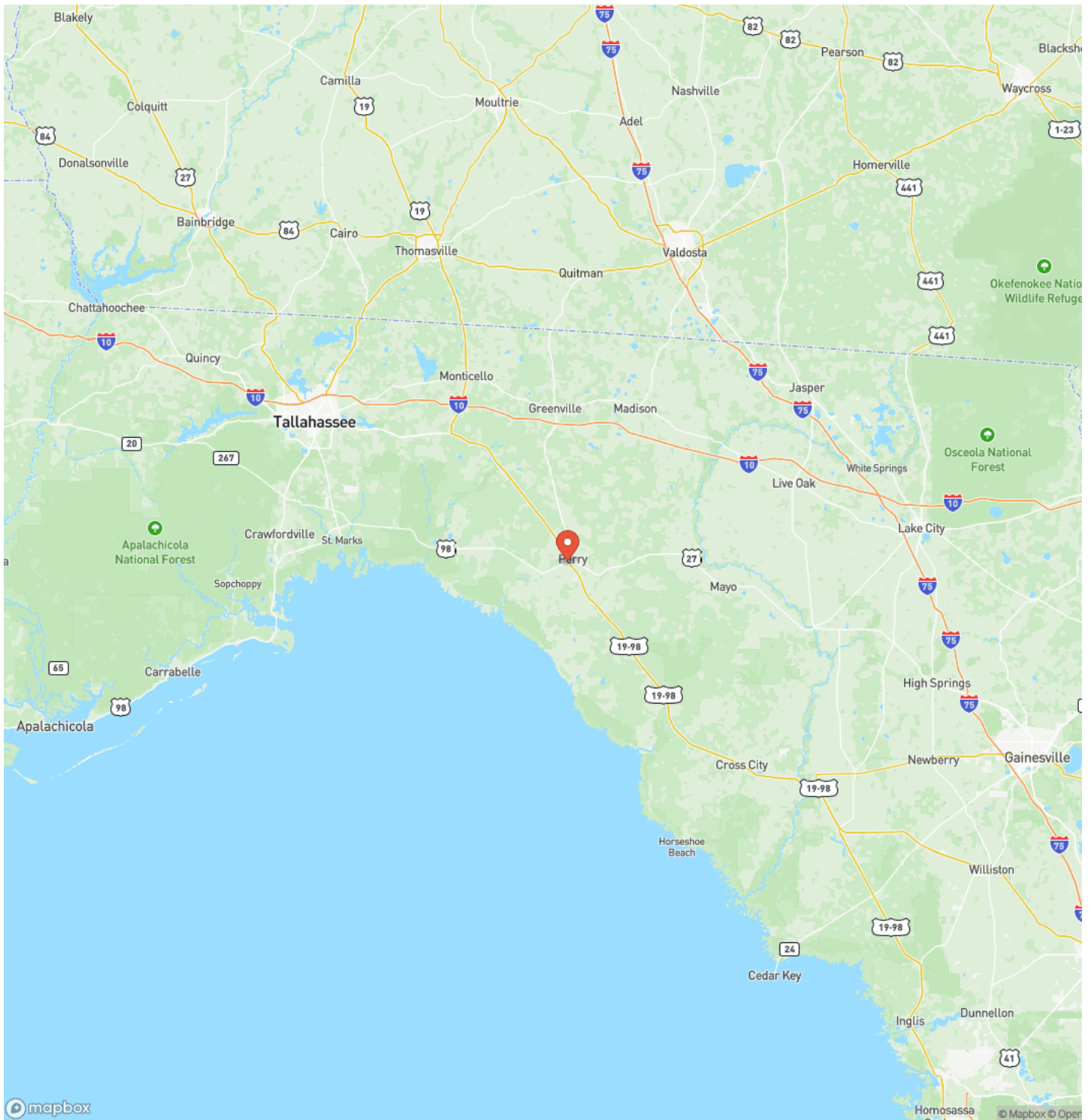




# Locator Map

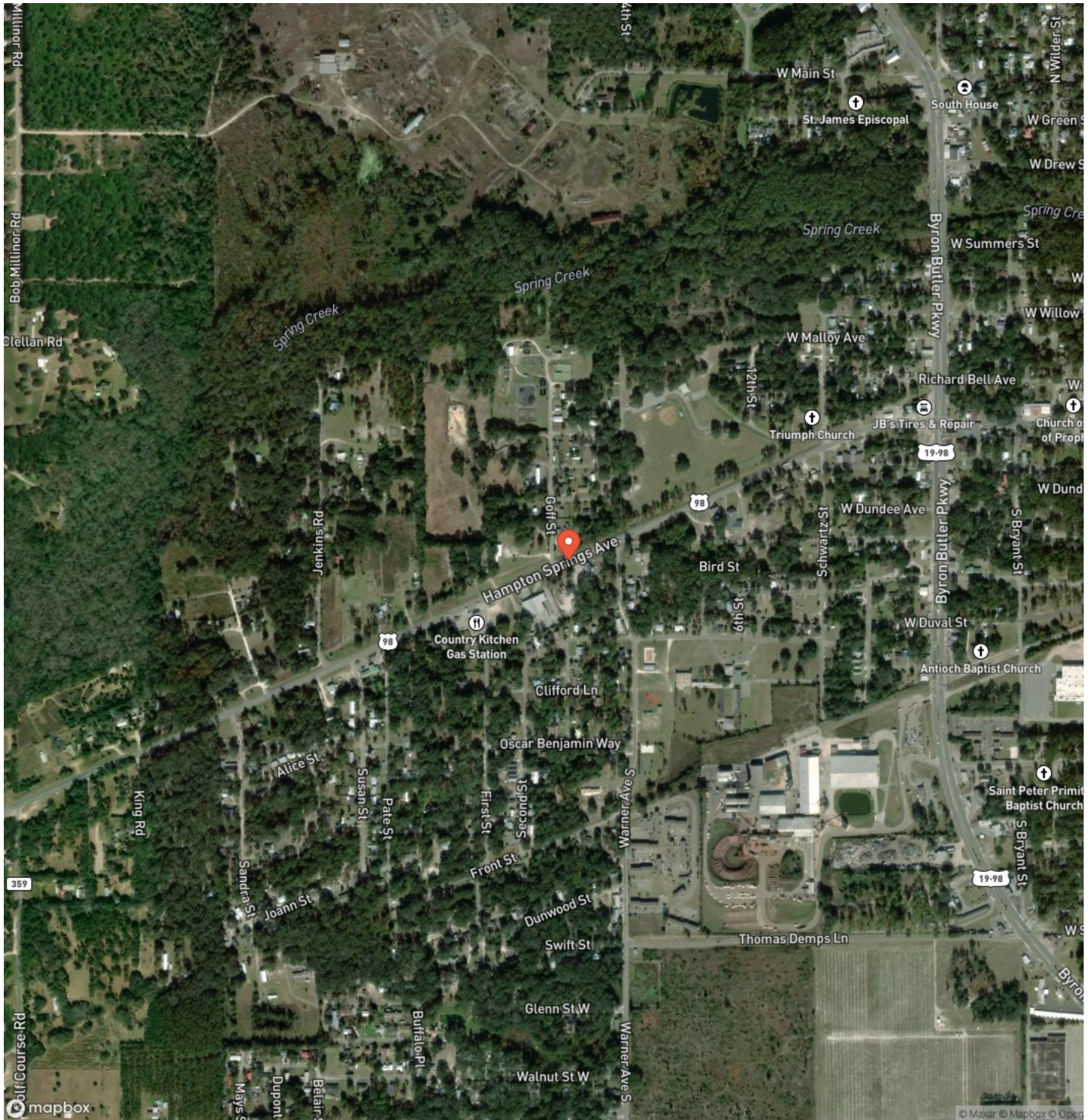


## Locator Map
