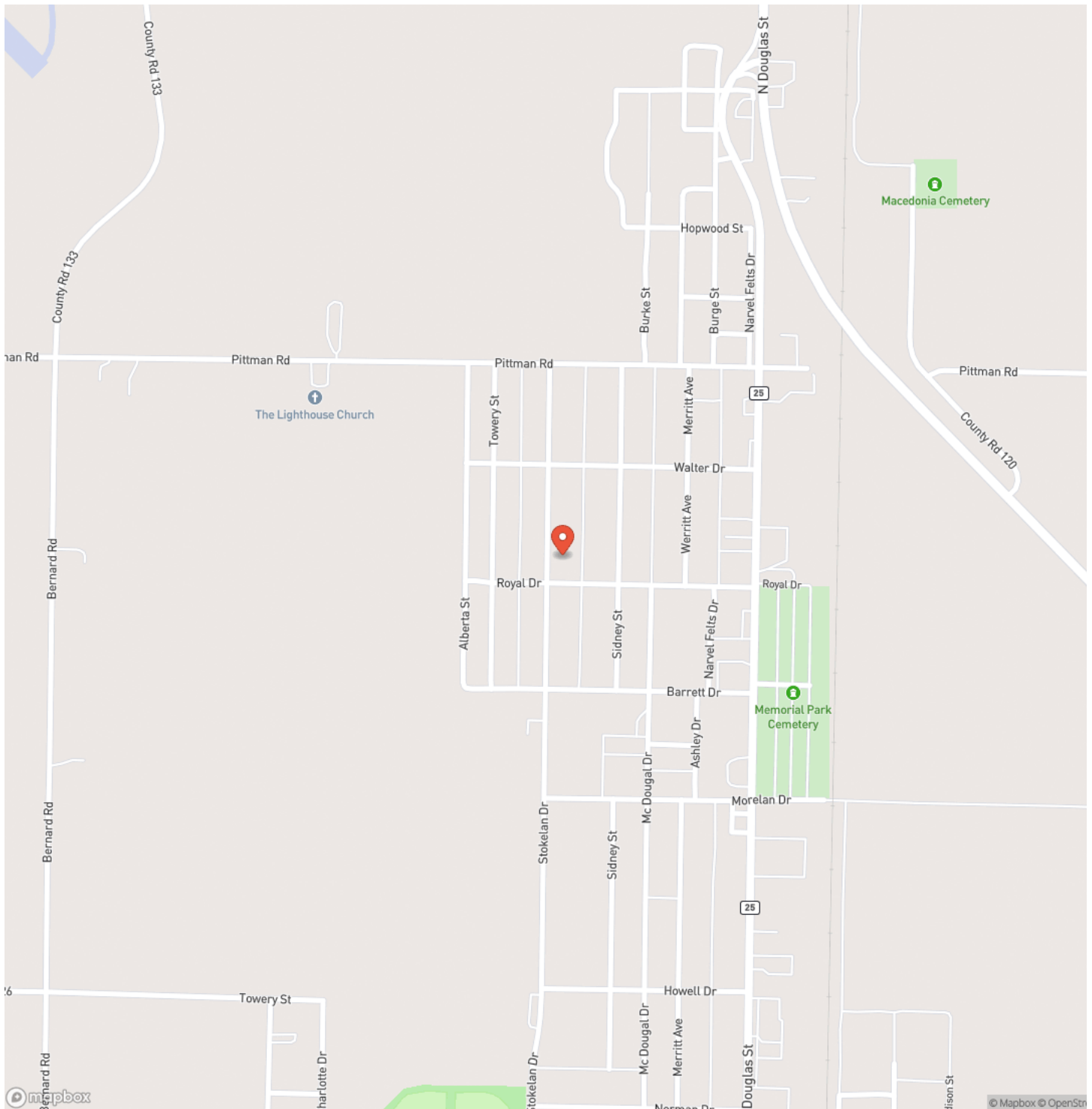

Locator Map

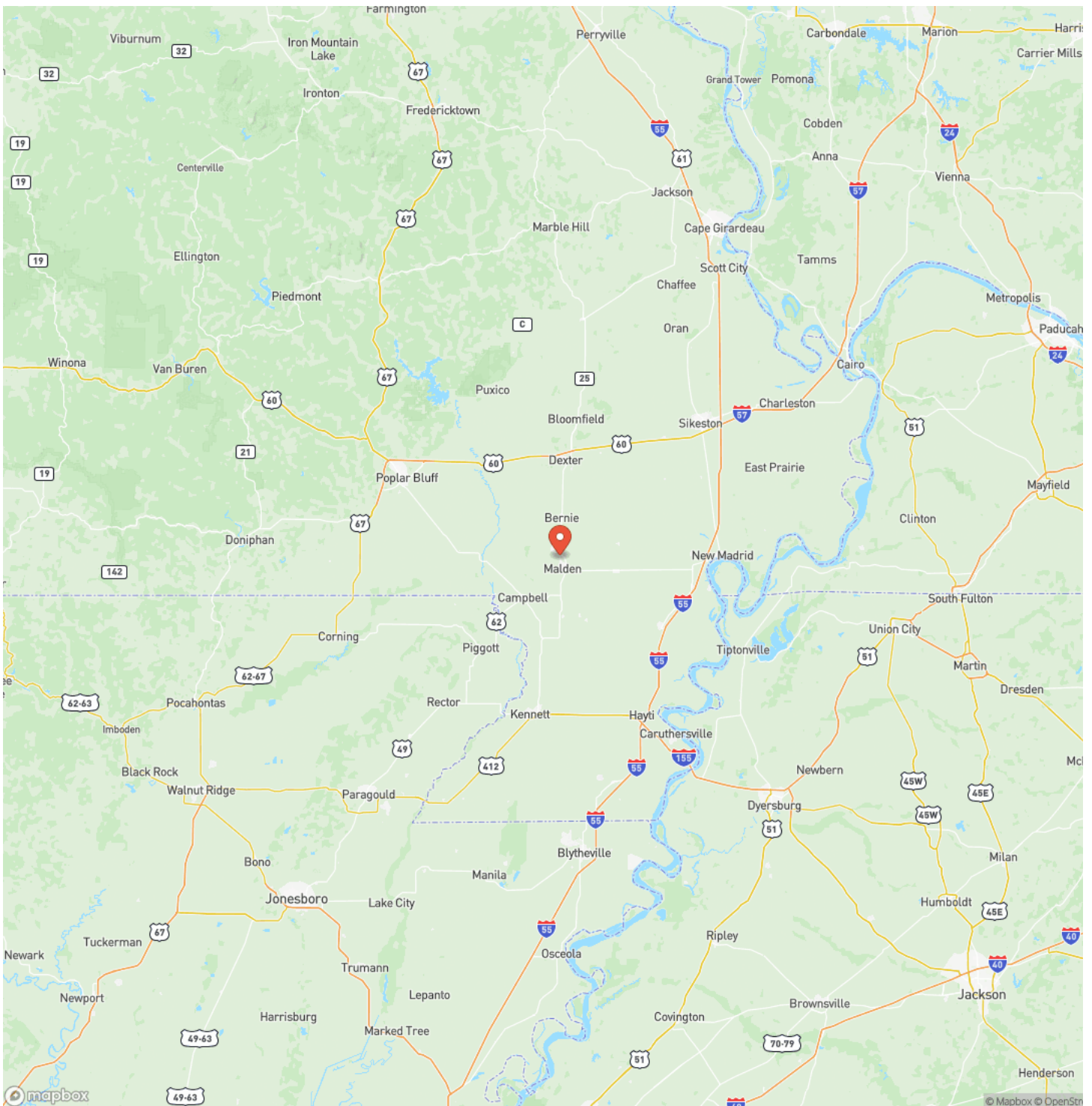
