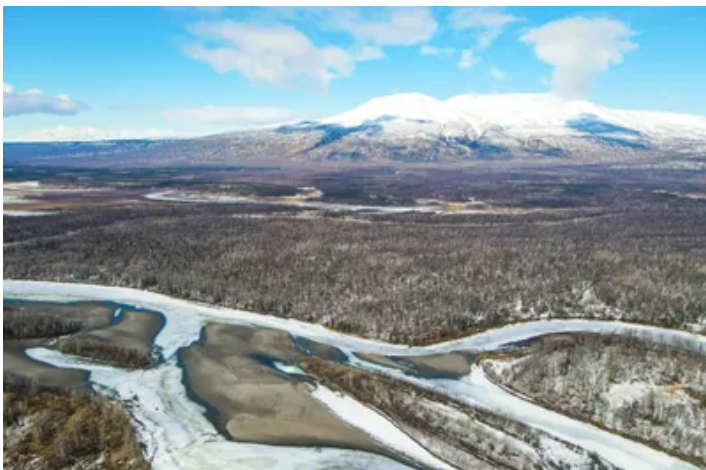


PROPERTY DESCRIPTION

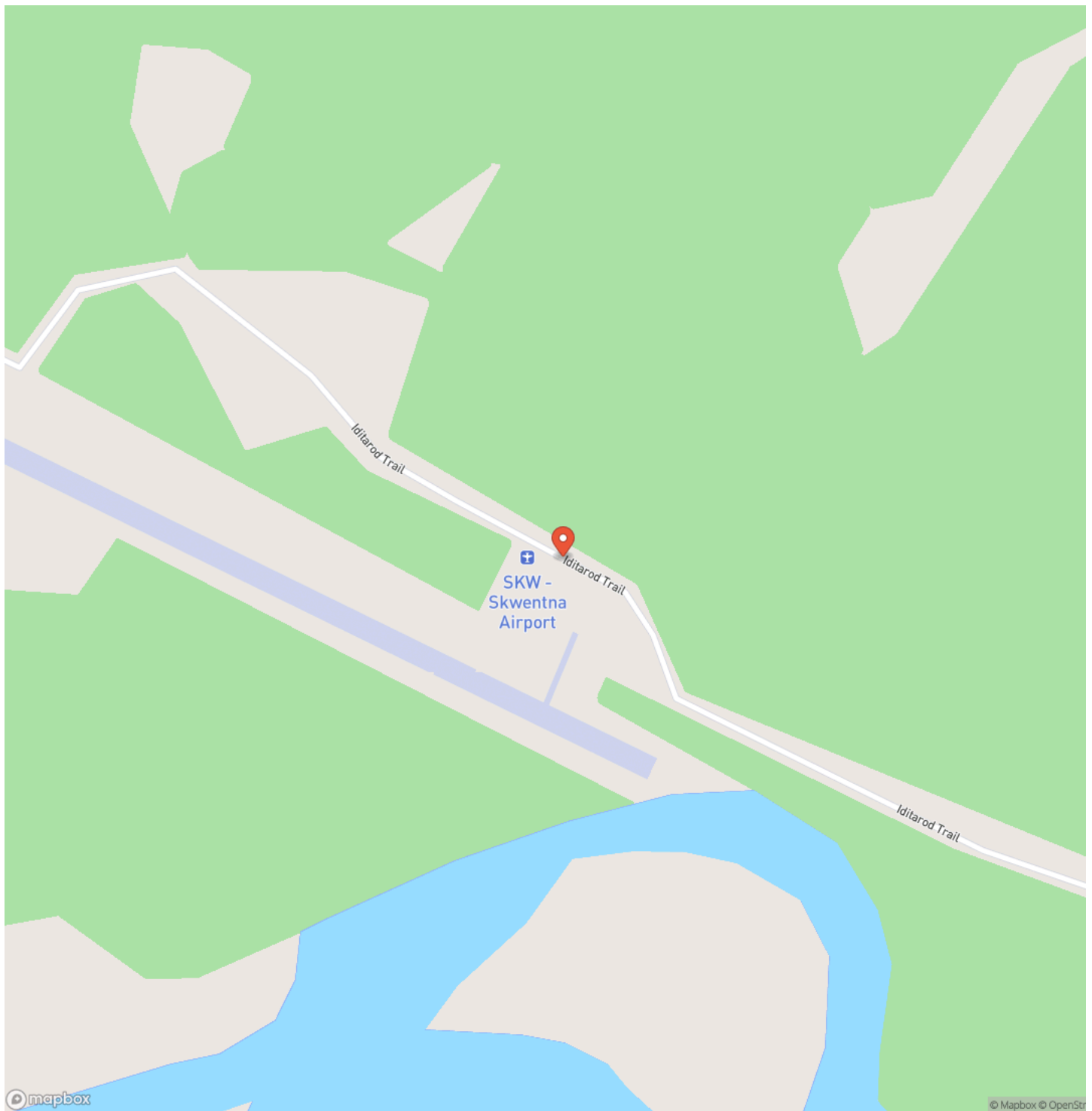
Opportunities like this don't come around often; Introducing the Alexander Creek Lodge! Located at the mouth of Alexander Creek where it meets the Susitna River, this 154.28± acre property offers over 2,000 +/- feet of waterfront in a proven hunting and fishing corridor that Alaskans and visitors have been coming to for years. Access is straightforward for this part of the state - boat from Deshka Landing or float plane in the summer and snowmachine or ski plane in the winter. At roughly 26 +/- air miles from Anchorage, it's close enough to be usable but far enough to feel remote. What really sets this property apart is the amount of infrastructure already in place. Along the Susitna River are 7 smaller cabins with 2 bunk beds in each cabin plus a dedicated bathhouse. Near the creek mouth are 2 additional 2 bunk cabins. From there, the property stretches up Alexander Creek with multiple additional structures. The main lodge sits back along the creek and includes a bedroom and bathroom downstairs with three additional bedrooms upstairs. Just behind it is a generator shed with a diesel generator. Nearby is another smaller bunk cabin with a wood stove, along with multiple storage sheds and a workshop loaded with tools. Further upstream, there's a mid-sized cabin with a full kitchen, bed, and loft, followed by another lodge-style cabin with a full kitchen, two bedrooms, and a bathroom, plus a workshop stocked with tools. The upper end of the property includes one more lodge-style cabin with bunk beds. Altogether, you're looking at 3 lodge-style cabins, 1 mid-sized cabin, and 10 bunk cabins, plus shops and outbuildings. The sale includes everything currently on site - a fleet of at least 10 flat-bottom boats, a large inventory of motors and fuel cans, multiple workshops full of tools, plus a four-wheeler and a snowmachine. It's being sold as-is and will need to be cleaned up and some work done, but the bones are here for someone to step in and build something special. The area is loaded with wildlife - moose sign throughout, strong bear hunting, and seasonal salmon fishing in Alexander Creek. This isn't a polished, turn-key lodge - it's an opportunity. With the right vision and some effort, this could be turned into a serious recreational property or income-producing operation in a location that already draws people in. 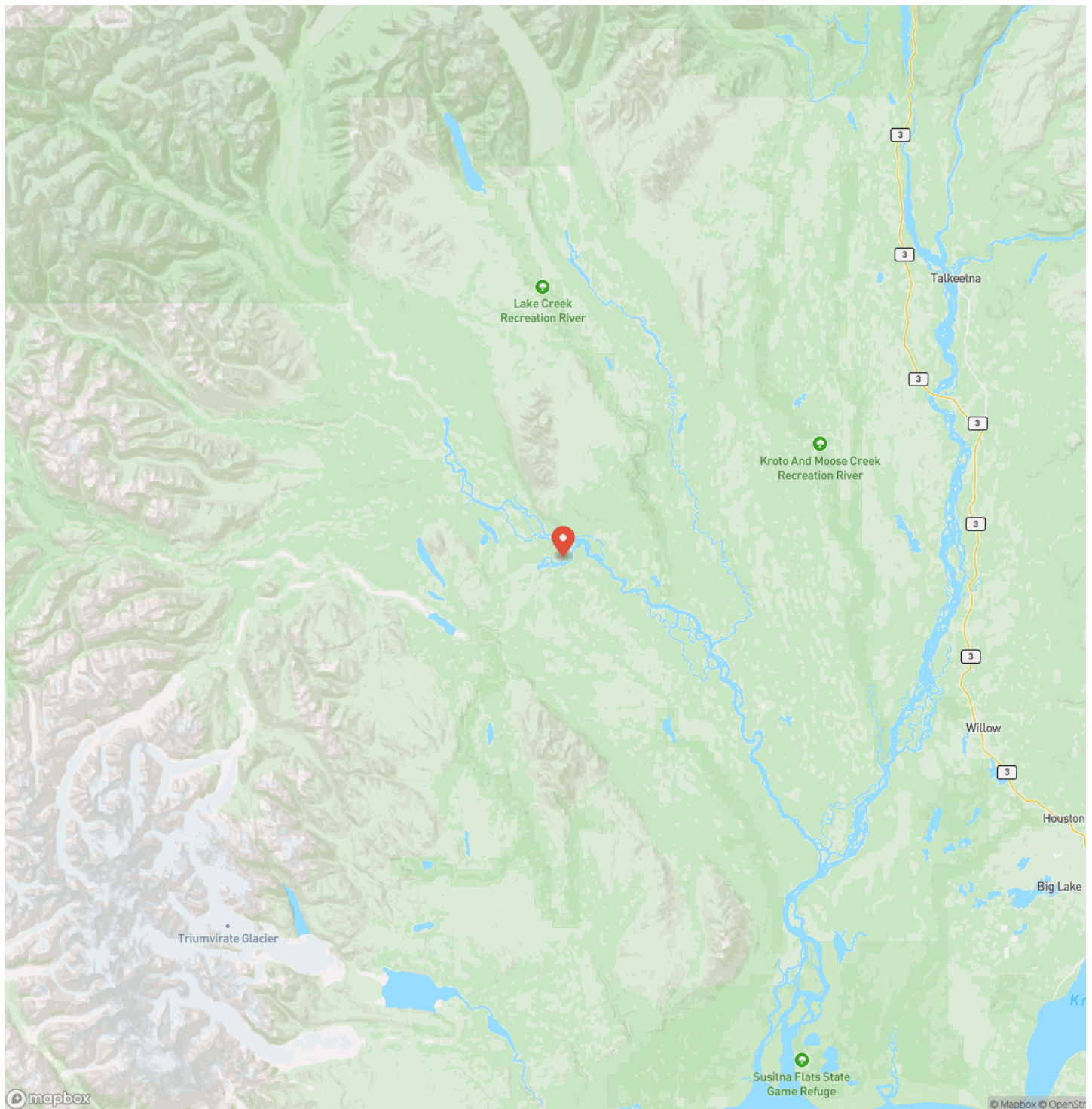
