Pennsylvania lot with camp in quiet setting for sale. The Red Roof Cabin is a unique little retreat for folks needing some R & R in the country. It sits on .6 acre of land along Pine Run Road, which is a two mile stretch of Township Road with a handful of houses and cabins. Large oak trees flank two sides of the cabin creating shady afternoons for outdoor relaxation. The Seller has done various updates to the cabin over the last 12 years. Approximately 12 years ago the cabin was enlarged by converting the porch area into living space, new metal roof, new door, and three new windows were installed. The electric entrance and breaker box has also been updated. Foam installation was sprayed under the floor. A new water line was installed from the spring approximately 3 feet deep to prevent freezing. A heat pump serves as the main heat source, and also provides air conditionings. The heat pump was installed in 2012. It was checked and serviced by a HVAC contractor in August of 2022. There are two wall mounted propane heaters to serve as a backup heat source. The small propane heater in the TV room needs replaced. The Seller has been living in the cabin as a transitional living place until they relocate. The Seller will be taking the refrigerator and freezer. This property is ready to live in, or be the getaway on weekends.

This location will place you nicely for some outdoor recreation amenities: State Game Lands - 4 miles, Prince Gallitzin State Park - 11 miles, Rock Run Recreation Area (ATV Riding) - 8 miles, Chest Creek - Stocked Trout Stream - 2 miles, Cambrian Hills Golf Course - 10 miles. The Seller has priced this property for a quick sale for a cash buyer. Not many properties come on the market in this price range. This property is ready to move with a cash purchase "as is where is". Closing will be 60-90 days from the date of signing of Agreement of Sale. The closing will be contingent upon the Seller closing on a home purchase currently under contract.

Viewing of the property will be by appointment only. The Red Roof Cabin - Come to the country!






# Locator Map
