If you are an avid upland bird hunter and have been looking for a property that is already set up with everything from thick dense brush, young forest habitat and hemlock drainages here it is. A regeneration harvest was conducted on this property in 2018 removing the poor-quality understory releasing the mature overstory to re-seed and regenerate. This type of harvest has created very dense new growth that is ideal upland bird habitat while still leaving mature timber in the overstory to be harvested down the road. The main species remaining are maple and cherry with pockets of aspen and yellow birch which are both favorites of the roughed grouse and woodcock.


If big game is your preference this property is also loaded with bedding areas with dense cover as far as you can see to keep that big bucks on your property. This property has the bedding areas and has the food... why would they leave? The Summerhill State Forest adjoins this property and is well known for its diverse habitat. There are areas of flooded timber, hardwood ridges, softwood plantations and lowland bottoms for all types of game and bird viewing. The snowmobile trail also runs through the property allowing you to jump on your sled and go right from the property.

The former log landing is a perfect place to build your off grid cabin or park your camper for the summer months! Lake Como is just over the hill for a place to take your boat out in the summer and is only 30 minutes from Skaneateles and Owasco lakes both known for their world class fishing. All the necessities, restaurants and other types of entertainment can be found only 10 minutes away in Cortland. This gem of a property is a must see for the serious multi-species hunter!



# **Locator Map**


