A cruise conducted in 2019 by F&W Forestry and adjusted for growth shows 247,000 boardfeet doyle log rule. The main hardwood species are hard and soft maple, with substantial volume in hemlock which is very sought after in the area. There is a managed thinning already marked and ready for the new owner, if desired, that would removing undesirable timber, white ash and over mature timber that could generate revenue immediately. The marked timber has not been sold.

Aside from the timber there are also recreation opportunities aplenty on this property. It is located ON the snowmobile trail allowing you to take your sleds right from your property to the hundreds of miles of groomed trails the area has to offer. It is also bordered on three sides by Beaver Dams State Forest which is well known for quality large and small game hunting. The stream that runs through the property is also a tributary to Dudley Creek which is known as one of the better trout streams in the area. With a little bit of bulldozer work you could also easily put in a pad for an off-grid cabin or pad for your camper or recreational vehicle.




Locator Map
