Approximately 68± acres located just west and north of Pinnacle in West Little Rock, Arkansas, offering a rare combination of recreational, agricultural, and riverfront features. The property includes approximately 7± acres of bottomland hardwood timber on the west side, with a duck blind that is subject to seasonal flooding.

Approximately 525 feet of frontage along the Arkansas River (Palarm Pool), providing river access and exceptional wildlife habitat. The remaining acreage is previously tillable ground that is currently enrolled in a CRP tree planting program (2024), which provides annual payments to the seller.




