
#### **PROPERTY DESCRIPTION**

Almost 400' of Umpqua river frontage this property is located at the start of the Legendary fishing section called the "The Loop", a very limited public access section of the river. Famous among anglers for small mouth bass (4000 fish per mile), salmon, steelhead and beautiful scenery. The recently upgraded Manufactured Home sits on the hillside overlooking the pasture below, the river and the mountains beyond. At an elevation of 200' winters are mild and summers are great for growing just about anything. The Eugene airport is about an hour away and the coast is 45 minutes. Hwy 138 is designated a scenic byway and as it winds its way through the mountains along the river you'll pass by farms, ranches and vineyards. The cute town of Elkton is only 7 minutes away with some restaurants, grocery and a farmers' market. Don't miss this opportunity to own some Umpqua riverfront.

The house has been recently upgraded with new flooring throughout, kitchen and master bath sinks, exterior siding and paint inside and out. Riverwood Road annual maintenance fee of \$200. Two domestic wells and two large water storage tanks. Several outbuildings and a covered parking area for a few cars. The Big K Guest Ranch, a few miles downstream, has a website describing the fishery-http://www.bigkoutfitters.com. Property has a few acres of irrigation water rights. 




## **Locator Map**
