Locator Map

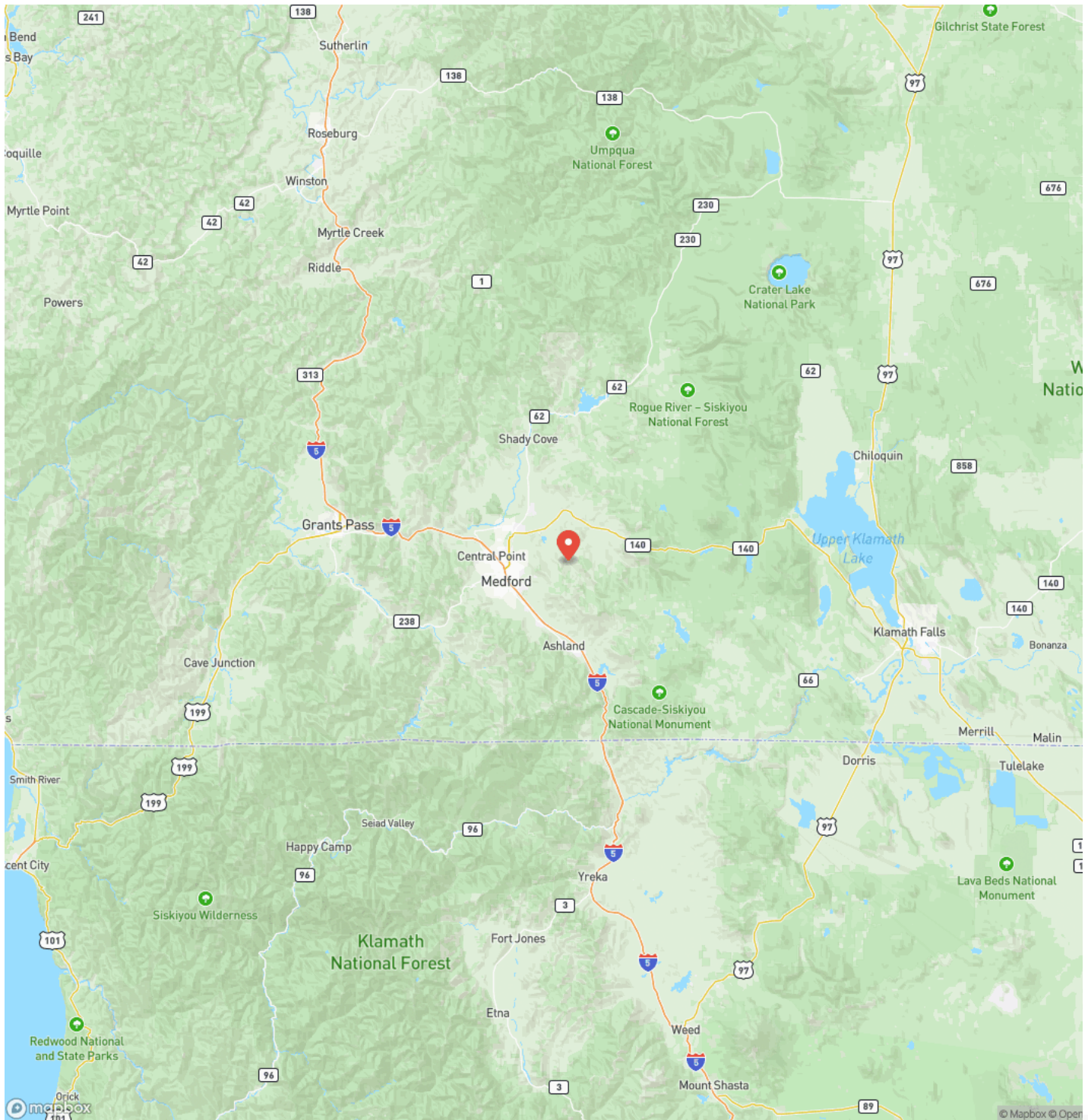
