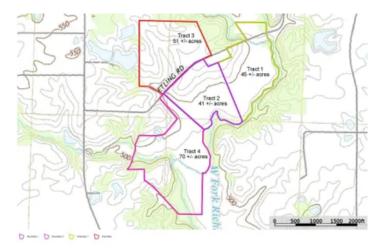

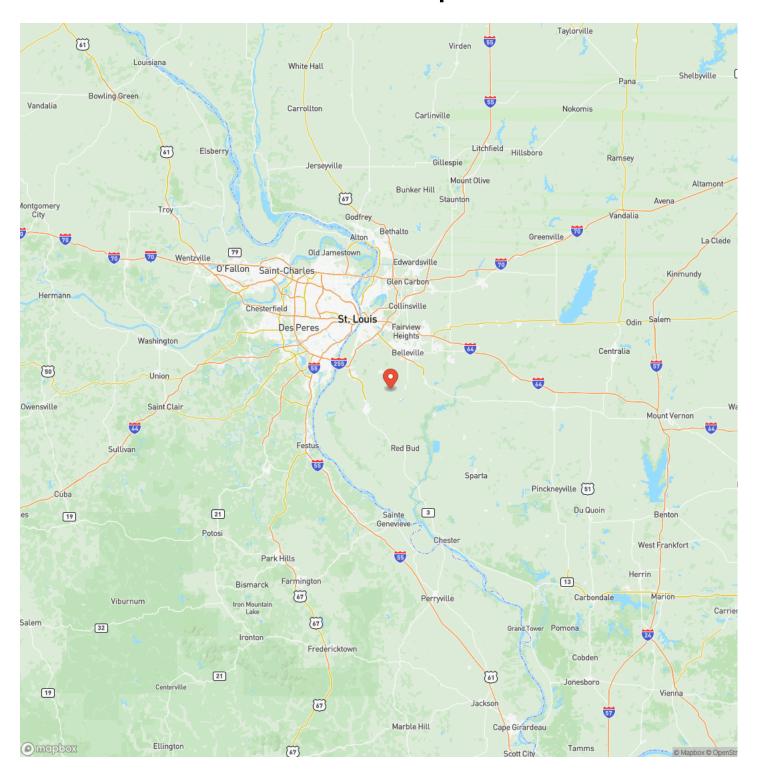


Locator Map
