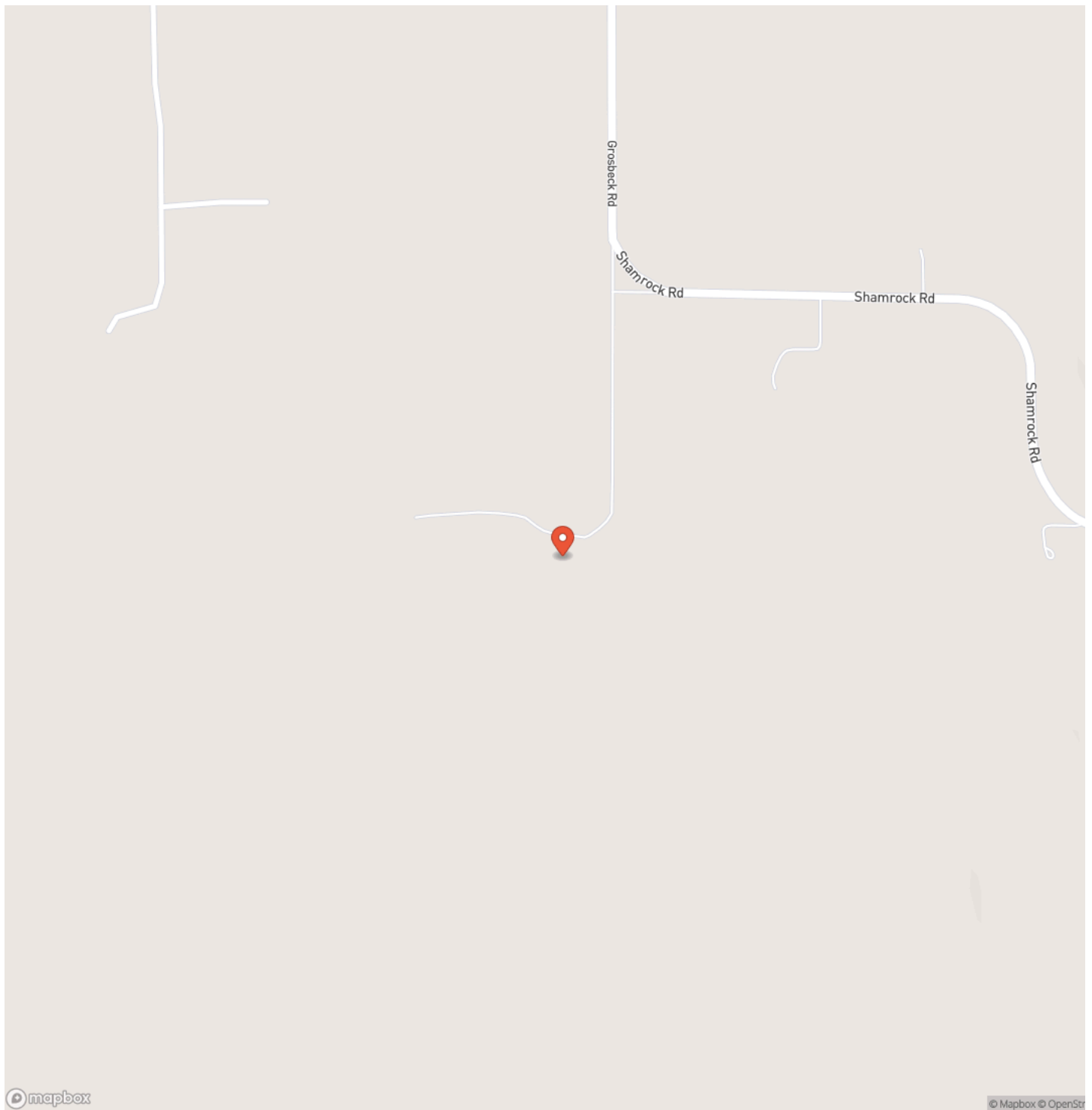

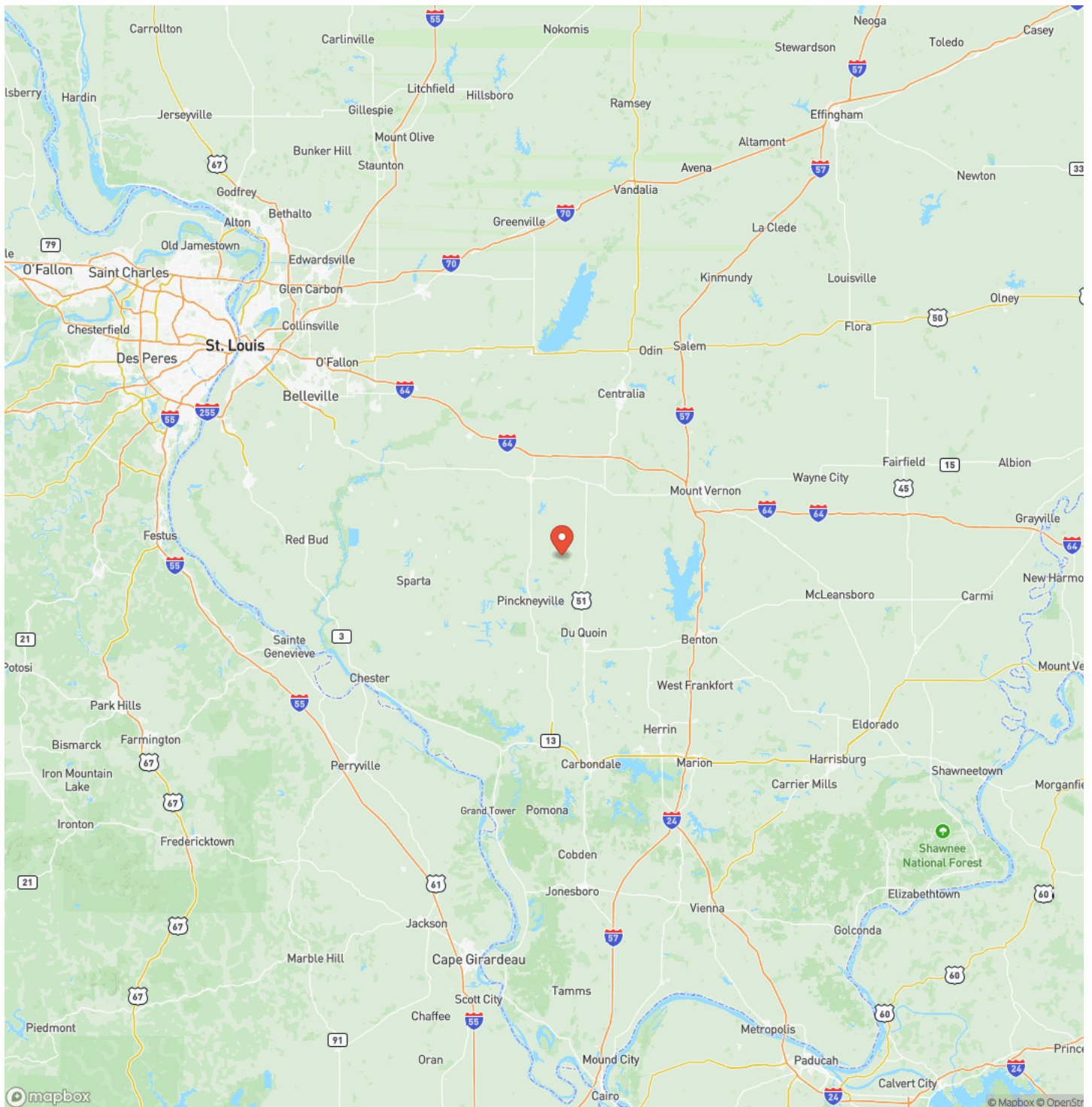

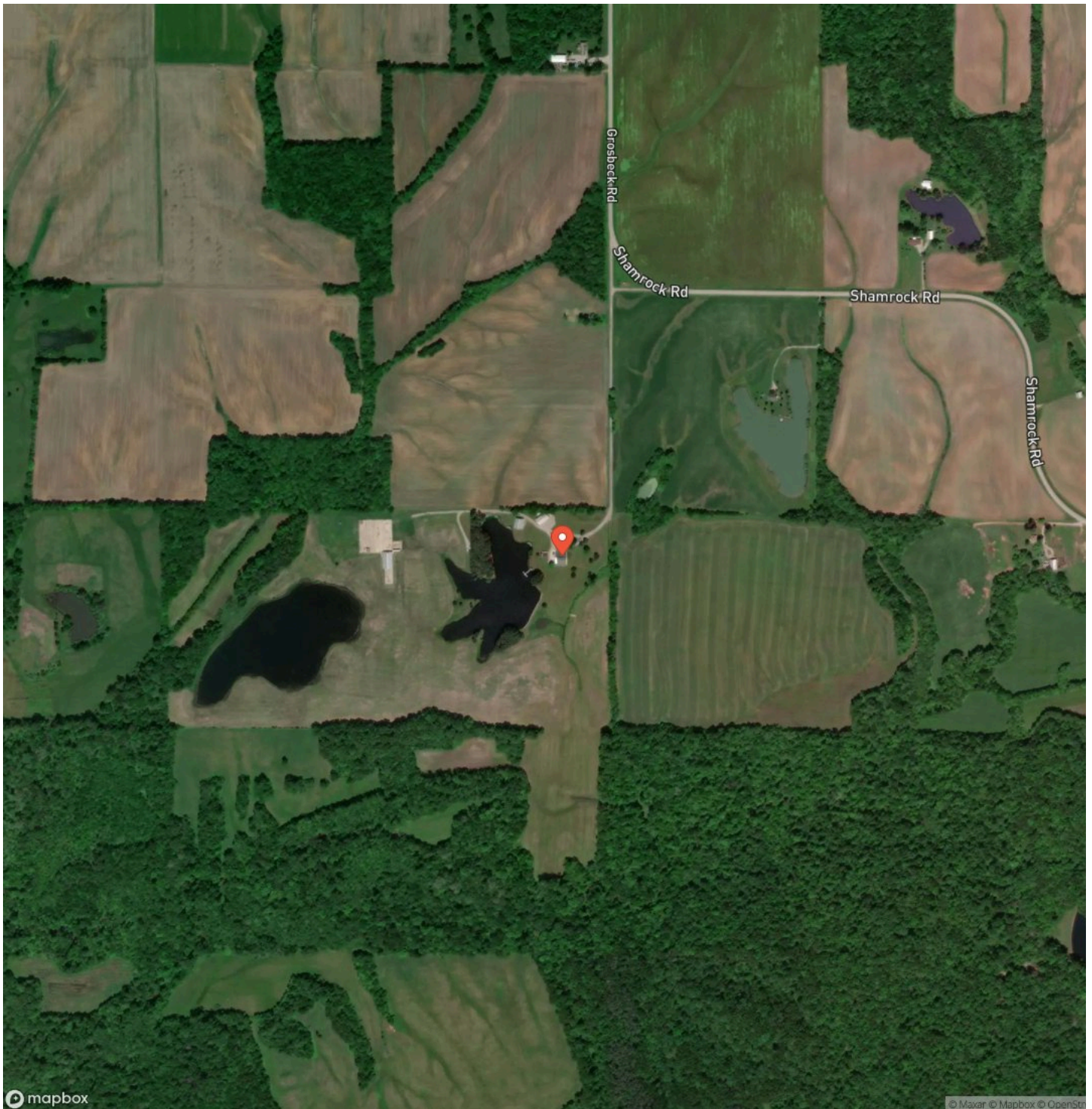
Locator Map
