The pines underwent a select cut years ago, resulting in undergrowth that is now perfect for both cover and navigation for wildlife and hunters.

During a recent walk on the property after a heavy rain, I observed numerous trails, rubs, and tracks, and personally sighted squirrels and rabbits. The property owner has not hunted the land in many years, indicating low hunting pressure. An old trail system and food plot area on the property could be easily reclaimed. Additionally, the property is surrounded by excellent farmland, a significant advantage for early-season deer hunters.

As a bonus, the property is conveniently located approximately 40 minutes from Lake Chicot State Park, 40 minutes from Cut-Off Creek WMA hunting area, and 30 minutes from Monticello, AR.




Locator Map






Locator Map
