
Interested in fishing or water sports? Ana reservoir has Trout and Bass and is less than 5 mins away! Float the Ana river just a short walk from your property and get the best of both worlds, fishing for trout while also hunting waterfowl. Don't want to hunt or fish, take your jet ski to the reservoir and have a blast riding around or pulling a tube. *Big game hunter*? This property sits in the Wagontire unit with the Silver Lake unit across the highway. Deer and Antelope are prevalent in the area. Just a short drive or walk and there is access to multiple public hunting areas!

If **UTV's** are what you are into there are tons of open BLM roads and open forest service areas just a short distance from the property for your riding enjoyment. The popular Christmas Valley sand dunes are 45 mins away. High Desert MX track is only 35 mins away, is open year round on the weekends and is regularly groomed and water. Take the back roads towards Paisley or head towards Christmas Valley. Plenty of opportunities for whatever riding or scenery you feel like that day.

Other Attractions include: Summer Lake, Summer Lake hot springs which are less than 30 mins away, Cowboy dinner tree is 20 mins away and you can be to Fort Rock in just under 45 mins.Come see the amazing views and endless fun this property can bring!






Locator Map


