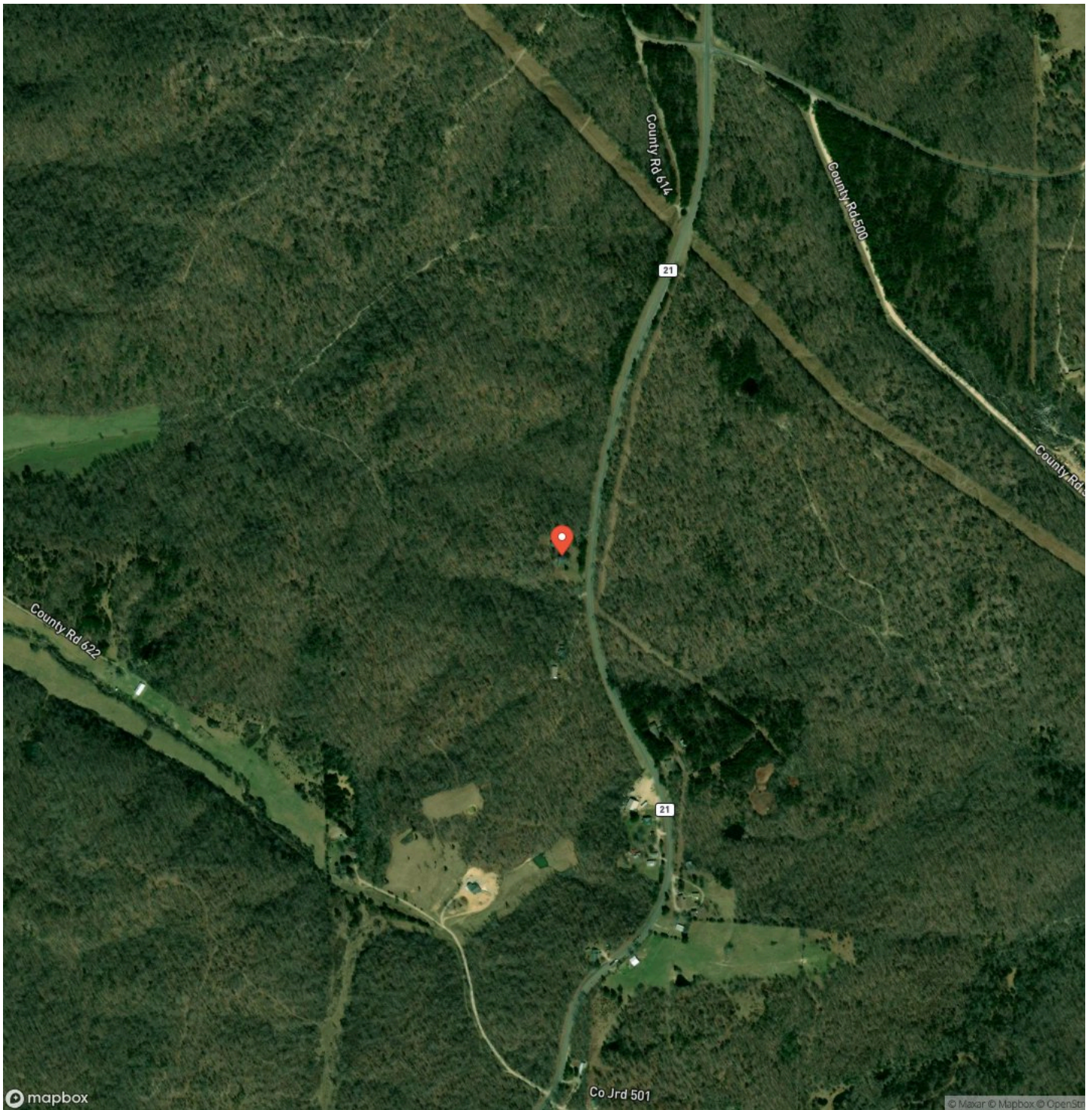
Locator Map
